October 10, 1992

Dear Ray:

In response to the letter received from James M. Fenelon concerning the 164th Infantry Memorial, your site selection as the N.D. Veterans Cemetery is excellent. Tourists like myself always visit the Capital when we return to North Dakota. In fact we feel Fort Lincoln State Park is one of the best in the United States.

During my years at the Boeing Company, I served in various elected as well as volunteer positions (General Chairman of the B-17 50th Anniversary 1956). Service in these areas gave us an opportunity to use publicity to our advantage. I have been a subscriber to the Towner County Record Herald for the past 30 years, not once has this paper carried a story about the N.D. Veterans Cemetery. Had it not been for the 164th Infantry News I would not have known it existed. I'm sure many of us who live out of state and receive papers from back home would appreciate more news of the past, present and future of the NDNG.

One thing I will never understand is why the 164th Infantry was deactivated following its Korean War activation. The 164th should still exist as a Regimental Combat Team, but that's a whole different subject.

Back to publicity, each week the Record Herald lists contributions to various groups in memory of some deceased friend. In my case I have sent contributions to the local Cemetery Fund, the Church Restoration, the Audi Theater Restoration, etc. I would like to see a forum similar to the one on page 4 of the July 164th News that could be used to cover contributions to the Veterans Cemetery or the 164th Memorial or both with some means of notifying the family concerned. Other methods of fund raising such as a community contribution in memory of one of their own KIA, in Cando's case Corporal Rollie Andrick. It would seem the local Legion Post (Hal Parker) would step up to this fund raiser. The number of over 300 sticks in my mind as the number KIA in the 164th/WWII. Many of these must come from N.D. communities like Cando. The Cando community seems quite proud of its Guard Units participation in the Gulf. With that feeling and a look at those who served in the Cando unit HQ, Co. 2nd Bn. 164th, the community would get behind a fund drive. Once in awhile we need a history lesson on just how much was contributed to the Army in the call-up of these N.D. units for WWII service as well as the Korean War.

In closing I would be more than happy to contribute to the Memorial Fund, but more important let's get some publicity going. I know of at least a dozen former 164th members from the 1947 and on guard unit that don't know a thing about 164th Infantry Association. Let's make everyone aware that the 164th Infantry is still alive and well.

Thanks for the opportunity to participate.

Dear Buser:

I must apologize to you for being late in answering. Following has been sent for Veterans:

My trip for U.S.A. will be postponed till this summer or autumn because of operation of cataract. I, however, have decided to visit Michigan including the museum of Kalamazoo and Washington D.C. Will be able to visit with other places if possible.

Also, I am sorry that did not reply you for your information about the map of Henderson field which was sent from you July 9, last year.

In the fact, your above maps of Henderson field is quite important to research our history. We thought that Kawaguchi had no maps without navy chart in Guadalcanal. One of the maps that you sent me is captured by Marine and the owner is Japanese First Lieutenant, named KAWABATA. This means that they had exact maps when the attack of September 13. There is a book which contents is of maps in Guadalcanal. In the book, the author wrote that KAWAGUCHI had no maps except navy chart. Most of Japanese authors had written unreliable articles after the war. Civilian write with imagination. Veterans write own exploit. I can find "The truth" by the actual evidence only, for example, your maps are actual evidence. Thank you so much.

I think it will be very difficult to see those evidence at the U.S. Marine Corps Museum and/or other historical materials library in Washington because it needs many days to search.

I, anyway, wish to write you when I decide exact scheduled in your country.

Dear Buser:

I regret that have had too much delayed to answer you. Received your recent letter on August 25 of 1992 and for which I thank you very much.

My condition of sick is recovering very slowly by and by. I could not eat original hard boiled rice even now. My main food is rice gruel. Needs two hours for each meal. Doctor said it will need more half years to be able to eat common food.

Thanks also for your kind letter of June 15 1992 but I did not read it even now. I shall read this your letter and reply you my opinion as early as I can.

By the way, there were two of big events while those several months. One was the visited of Horsman. He came here on May 28th and the press men of National Geographic took pictures and recorded conversations of Horsman and me. This was very pleasant and unforgettable thing for me.

The second is that I donated a scale model to Kalamazoo Museum. This is the model of Japanese battleship KONGO which bombarded Henderson field in Oct 13 of 1942.

I began again to type this word-machine since this June. I stopped to send translation work to Barsch in Geneva who is proceeding to write true history of Guadalcanal for one year. As I feel one of the reason that I took ill of stomach was caused by overwork of word-processing machine, I am not type so much. Usually, I type two hours per day. I typed over eighteen hours per day before the ill.

Thanks again for your kind letter sent me while my sick. I shall reply you as early as possible.

It was too bad we lost that day in Guadalcanal. I would have liked to gone all the way up to Cape Esperance.

However, it was a great experience, but I wouldn't want to live there. I'm hoping someday that we get to see some of that TV video that was taken.

Some of my photos turned out pretty good. I'm enclosing a few.

Now I have sad news to report. One of my Co. "B" buddies, Robert (Bob) McComb, died in Olympia, WA. He joined us at Fort Ord just before we went overseas. He came from Southern California.

Relative to 164th Infantry News Vol. 31 No. 2 dated July 1992, and James M. Fenehon's letter on next to last page wherein he requests that the names of all members of the 164th Infantry Regiment that served on Guadalcanal until the Regiment left Guadalcanal be put on the plaque.

I take exception to the wording "that served on Guadalcanal until the Regiment left Guadalcanal."

(1) I was dumb and green and never knew what a Purple Heart meant and when one lung louie lets loose on the Anti Tank Company I got some hot shrapnel that cut my leg a bit but to me not bad enough to go see a medic.

(2) In February of 1943 I was evacuated because of malaria, jungle rot, and yellow jaundice so bad I grunted to urinate and all that came was yellow pus. I was in hospital from Feb. until June and advised to not go back to unit by the doctor.

My point is I fought in all the major battles of Guadalcanal in the mud and what all; so I feel I deserve to have my name on the plaque too even though I was not with the Regiment when it left Guadalcanal.

I joined the 164th in April 1941 and left due to illness in February 1943.
