MINUTES OF THE UNIVERSITY SENATE

January 12, 1967

(NOT TO BE MADE AVAILABLE TO NON-FACULTY MEMBERS)

1.

A meeting of the University Senate was held at 4:00 p.m. on Thursday, January 12, 1967, in Room 415 of Twamley Hall. Mr. Tomasek presided.

The following corrections were made in the minutes of the December 1, 1966, meeting:

- 1) Under Item 7, page 379, the Curriculum Committee would like to correct the minutes to the effect that the Interdepartmental SLA 101, 102, 201, 202 courses will not be given under that title, but that the content of the courses in Geology 101, Biology 164, and Chemistry 100 will be given under the current course numbers in this program, and that the Physics Department at a later date will submit a new course to the Senate for its consideration.
- 2) Under Item 6, page 379, this paragraph was added: Mr. Herndon and Miss Oslund were nominated for membership on the Senate Executive Committee. It was moved that nominations cease. The motion was seconded, voted upon and carried. A ballot was taken and Miss Oslund was declared elected.
- 3) Under Item 9, page 380, this sentence was added, "A suggestion was made that this matter be considered by the Curriculum Committee."

With these corrections, the minutes were approved.

Mr. Starcher presented the report on the Attorney General's ruling concerning open meetings of the University Senate. Mr. Koenker moved that this organization go on record as favoring public meetings. Mr. Thorson seconded the motion. Discussion followed. Mr. Koenker moved to amend his motion to read: This body, effective this meeting, declare the Senate open to the public. Mr. Herndon seconded the motion. Mr. Hankerson moved to amend by a substitute motion to follow the correct procedure for amending the bylaws, but to invite the public to attend now. The motion was seconded. Mr. Hankerson was permitted by unanimous consent to withdraw his motion. Mr. Koenker was permitted by unanimous consent to withdraw his motion and proposed amendment. Mr. Bullard moved to amend Bylaw #3, but that this meeting and successive meetings of the Senate be open until this action is taken. (This item will appear on the agenda for the next two meetings.) Mr. Hankerson seconded the motion. Upon request the motion was divided. The first half calling for the amendment of Bylaw #3 was voted upon and carried. The second half inviting the public to attend this meeting and the two successive meetings was voted upon and carried.

5.

Mr. Wheeler presented the recommendation from the Honorary Degrees Committee that the following addition be made to the Senate Bylaws under Standing Committees, IV., Honorary Degrees Committee: "2. The deadline for submitting nominations for honorary degrees shall be three months before the date on which the degree is to be awarded." This recommendation will be placed on the agenda for the February meeting.

6.

Mr. Wheeler presented the report of the Codification Committee. (Copies of the University Constitution, the Bylaws, and the Council and Senate Legislation have been sent to all faculty members.)

7.

The Chair appointed Mr. Herndon and Mr. Robertson as a committee to study and report on possible changes in the physical arrangements of the Senate chamber and rules of conduct for Senate visitors.

8.

Mr. Koenker moved to call for nominations from the floor for the election of five faculty members to serve on a committee to select three outstanding undergraduate teachers for awards for teaching excellence. Miss Heyse seconded the motion. It was voted upon and carried. The following were nominated: Arthur P. Jacoby; John L. Hancock; Glenn H. Smith; James F. Herndon; Russell Peterson; Albert Cooley, John Penn, who withdrew his name; Robert Caldwell, F. D. Holland, Jr.; Beulah Hedahl; and Virgil Stenberg. Mr. Thorson moved that nominations cease. It was seconded, voted upon and carried. The Senate proceeded to vote and Mr. Smith, Mr. Peterson, Mr. Holland, Miss Hedahl, and Mr. Stenberg were declared elected.

9.

Mr. Naismith presented a recommendation from the Committee on Committees that the study of faculty turnover be assigned to the Academic Policies Committee.

Mr. Naismith moved that the recommendation be approved by the Senate. The motion was seconded, voted upon and carried.

The Chair called for the election of members to the Convocation Committee. Valborg Osland, Clifford Thomforde and Henry Lee were nominated. It was moved and seconded that nominations cease and that Miss Osland, Mr. Thomforde and Mr. Lee be declared elected. The motion was seconded, voted upon and carried.

11.

Miss McKenzie presented the list of candidates for degrees in January, 1967, and moved that they be approved for recommendation to the State Board of Higher Education for the awarding of the degrees indicated, upon satisfactory completion of the work of the present semester. The motion was seconded, voted upon and carried.

12.

The meeting adjourned at 4:45.
