This is a 26-page report ( Ereignismeldung ) classified "Top Secret".

Page 1 : The garrisons and personnel as reported in No. 191 ( 10 April ) remain unchanged.

Pages 1- 19: Report from Einsatzgruppe A in KRAZNOGVARDEISK. Morale and general situation; schools; churches; economy; agriculture; food; activity against communism and Marxism.

Page 15: " In DUEENBURG 7 communists who took part in the shooting of German flyers making emergency landings in the summer of 1941 and 2 sick Jews who were not able to work were executed.  
( An. note: KdS Latvia was at that time SS- Ostbf. LANGE )

Page 19: " During the report period a total of 1, 272 persons were executed - among them 983 Jews who had contagious diseases or were old and infirm so that they could not be considered in the labor allocation, 71 gypsies, 204 communists , and 14 more

Jews who were guilty of various misdeeds and crimes."

Page 19: General report from Einsatzgruppe B in SMOLENSK.

Pages 20-26 Report from Einsatzgruppe C in KIEW.  
Arrests of communist officials, NKWD members and antipartisan activity.

Page 26: Report from Einsatzgruppe D in SIMFEROPOL.
