SUMMARY (Indicate page nos. of original or translation):

This letter from Himmler's office signed by Himmler with a postscript signed by SS-Sturmbannfuehrer Dr. Brandt sent a copy of the basic communication dated 10 March 1942.

Herein Himmler told Pohl the facts as disclosed by Dr. Pokorny about Dr. Madaus' research as outlined in NO-035. Himmler orders Pohl to notify Madaus to cease publication about medicinal sterilization openly and to have Madaus get in touch with the Reichsarzt SS Dr. Grawitz and cooperate with him in the experiments on criminal type of human beings which should be sterilized anyway. Himmler, however, wants to be notified of the intended location of these experimental laboratories.

1.) Dear P o h l ,

I read Dr. Pokorny's very interesting memorandum and Dr. Madaus's publications on medicinal sterilization. I would ask you to get in touch with Dr. Madaus and to inform him, on my behalf, that he should not publish anything else on these questions of medicinal sterilization, and offer him possibilities of doing research, - in co-operation with the Reich Physician SS, on criminals, who would have to be sterilized in any case.

The intended plan of research is, however, to be submitted to me by the office engaged on the subject.
