SUMMARY (Indicate page nos.)

- This is a 14-page report (Ereignismeldung), classified "Top Secret".
- Page 1 Report made by the Hoherer SS- and Polizeifuehrer Ost in KRAKAU to the effect that 50 persons were executed on Oct. 3, 1941, as a reprisal for the assassination of Police Sergeant Michael SENDEGA in LEMBERG.
- Page 3 It is furthermore reported that near BELGRADE 101 persons were arrested mainly for Communist propaganda. Of the arrested persons 12 were already executed.  
+ Sonderkommando, after interrogating 22000 inmates of the prisoner camp in SCHABATZ, executed 8000 of them while the Wehrmacht liquidated 910.

- In BELGRADE: 1) 200 communists, mostly Jews, were executed as a reprisal for a recent attack made on two German soldiers.  
 2) 2,100 Jews were executed as a reprisal for the death of 21 German soldiers.  
 3) Upon order, 18 Jews were placed at the disposal of the Army headquarters. The execution shall be carried out by the Wehrmacht.  
 4) Preliminary work for the construction of a Jewish ghetto in BELGRADE are completed as well as the registration of all male Jews after the intended liquidation of the rest of male Jews in BELGRADE, as per order of the Supreme Commander in BELGRADE, it is estimated that approximately 10,000 Jewesses and children will remain in the ghetto.  
 5) The arrest of 12 wealthy Jews who tried to flee to Hungary via SEMLIN resulted in the seizure of considerable amounts of money and valuables.
- Pages 4-11 Report from Einsatzgruppe C in KIEW.  
 Page 5 Members of the Wehrmacht looted Jewish homes at UMAN on September 21, 1941 together with members of the local militia.  
 Page 6 Two members of the Soviet Secret Police were liquidated in UMAN.  
 A total of 1,412 Jews were executed in UMAN on Sept. 22 and 23, 1941 by the Einsatzkommando 5.  
 14 Ukrainians were executed in SOKOLIKA for Communist Activity.  
 13 Ukrainian communists and 35 Jews were executed on Sept. 19, 1941 in Justungrad by the Einsatzkommando 5 for spreading rumors about the retreat of the German army.  
 Page 7 8 Ukrainians, 13 Jews and 3 Jewesses were executed in various villages for propaganda activity by EK 5.  
 78 Jews were shot on Sept. 25, 1941 in CYBULOW for their arrogant attitude towards the Ukrainians.  
 Page 8 A Vorkommando of the Sonderkommando 4a executed 537 Jews on October 4, 1941 in FERLJESLAW. This execution met with the approval of the Wehrmacht and the population.  
 Sonderkommando 4a executed 125 Jews on Oct. 8, 1941 at JAGOTIN, and 166 persons, 29 Jews and one Soviet official on Sept. 21, 1941 at IWANNO.  
 The same Sonderkommando executed 177 Jews at KOROSTEN for disturbing public order.  
 Page 9 The same Sonderkommando en route to DEDMROW executed 32 gypsies for possessing German equipment.  
 Einsatzkommando 5 executed 322 Jews and 13 communists on September 15, 1941 at DOGUSLAW and all Jews at MOSCHEWATOJE.  
 Einsatzkommando 5 executed one Jewess and one communist on October 2, 1941 in KIEW.  
 Page 11-14 Report on military events.  
 Page 14 "Greece: In the SALONIKI area weapons found. 3 greeks shot, 12 houses burned to the ground."
