Subject: Persons of German race who do not apply for the entering of their name into the list of persons of German descent.

- I. I request to instruct the subordinate offices, to report to the competent local State Police Office all persons of German descent who do not apply for the entering of their name into the list of persons of German descent. I request you to report of all actions taken.
- II. The competent local State Police Central Offices and Offices should order the reported persons to prove, within a period of 8 days, that application for the entering into the list of persons of German descent was filed.

If the person concerned is not able to prove that, he should be taken into protective custody and his transfer to a concentration camp should be arranged.
