SUMMARY (Indicate page nos. of original or translation) :

This 2-page document, signed by SS-Gruf. Greifelt is a report on the results of a census of inmates of the Baltic-German refugee camps, carried out by the Stabshauptamt with the help of the local offices of the Sipo and SD.

The results are as follows:

- 215 (70.0 %) of Latvian and Estonian refugees are fit to be put to work immediately.
- 37 (23.5 %) Estonians, Latvians and other foreigners who have to be returned to their native countries in agreement with the state-police, as soon as possible.
- 5 ( 1.5 %) who are politically implicated or suspect or a-social will be handed over to the chief of the Sipo for transfer to a concentration camp.

After completing their examination of the inmates of Baltic-German refugee camps, as ordered by the Reichsfuehrer, and inasmuch as they are in the territory of the Gau Mitte, it was carried out in close co-operation with the local Offices of the Chief of the Security Police and the SD during the time from 21 to 30 August 1941; the Staff Main Office therefore submits respectfully the following report for your kind information.

The Estonian and Lithuanian refugees in the territory of the Gau fall into the following groups:
