- P. 4 5 July 1941: "Einsatzkommando 6 (Standfu. Dr. Kroeger) in Lemberg reports: More than 400 Jews shot in reprisal for murdered Ukrainians. Another 200 will follow. In Lemberg 150,000 Jews."
- P. 6 11 July 1941: One Politruk brought in by Ortskommandantur, turned over to Special Purpose Command, Cberfuehrer (SD) Schoengarth.
- P. 8 24.7. "...shot German soldier found near Zmierinka. Chief of Staff plans shooting of 20 men in the event that deed was committed by civilians." 25.7 "Contact with SD established. 1 SD Commando will be stationed to Zmicrinka (cable sabotage by Jews - Retaliation)"
- P. 10 13.8.41 "...in Uman. Un 12,8.41 14 year old Wassily Stepanowitsch was treated as guerrilla. Cable sabotage, anti-social elements "
- P. 11 23.8.41 GFP turns over 18 year old Russian girl suspected of being Communist to SD C6.
- P. 12 22,9.41 "SD Kommando IV b is asked to carry out reprisals against Krementschug Jews since 3 cases of cable sabotage have occurred there."

- 1.) SD Sonderkommando IV b (Sturmbannfuehrer Herrmann) leaves for Ioltawa and is on the alert for Charkow. ... small detachment remains in lrementschug until further notice.
- 2.) SD Lommando IV b is requested to take reprisal measures against the Jews in Irementschug since three cases of cable sabotage had occurred there.

3.) Secret Field Folice Group 13 was committed on the Onjepr with assault boats and arrested 100 persons 6 km South of Mr. (ementschug). After interrogation, 52 were kept in custody, 49 were turned over to the F⁻ Camp Mrementschug,
