Miller and Zazula were assistants under James Aiken at University of Nevada in 1946. The trio moved to Oregon in 1947, when Aiken was named coach of the Webfoots. Nevada won seven and lost two games in the season of 1946. Oregon won seven and lost three in 1947 and last fall was defeated only by Michigan's national champions, 14-0, during the regular season. The Webfoots were beaten, 21-13, by Southern Methodist in the Sugar Bowl, but went through their Pacific Coast conference schedule without a loss to challenge the selection of California as Rose bowl representative.

Miller was born in Canton, Ohio, is 31 years old, married and has one child. He played both basketball and football in high school and specialized in the pole vault in track. The new coach attended Akron university three years, transferred to Nevada in 1939, from where he graduated with a minor in physical education in 1941.

In college the coach lettered in both basketball and football at Akron and Nevada, then took a coaching position in Canton high school in the fall of 1941 through 1942. After serving in the naval physical education program Miller was discharged in 1945 and returned to Canton high.

The fall of 1946 found him as assistant to Aiken at Nevada.

Miller spent several days here. coming for an interview and to look over the University after a telephone conversation with Jarrett.

## 'U' Law Graduates Prominent in State

During its 50-year span the University of North Dakota law school has supplied the state with four governors, two U.S. senators, two U.S. congressmen; one federal judge; six North Dakota district judges, two judges of the supreme court of the state and six attorney generals, according to a survey of graduates of the school.

Elected to the U.S. senate have been John Moses, who was a three-term governor previously, and William Langer, incumbent. U.S. congressmen have been William Lemke, incumbent, and O. B. Burtness, Grand Forks.

### Detroit Club Honors '13 Graduate

Some thirty-five members of the North Dakota club of Detroit, Mich., gathered recently to honor Gretchen Oeschger Luros of the class of 1913, now a teacher of chemistry at Wayne university.

Mrs. Luros told of her trip to Europe where she spent the summer with her daughter, Mrs. Richard Knorr. Together they visited France, Germany, Italy and Switzerland. Mrs. Knorr is on the staff of the Army newspaper, "Stars and Stripes." Mrs. Luros also has a son, Dr. John T. Luros of Ann Arbor, Mich.

Members of the state supreme court from the list include William L. Nuessle and Sveinbjorn Johnson.




### 100 Attend **Bismarck** Banquet
