Campbell Wheat Farm

"world's greatest wheat king," has sold his 65,000-acre Montana wheat farm to the United States Wheat corporation of Nebraska.

Gordon Diesing, Omaha at-torney and president of the corporation, announced a purchase price of 2 million dollars for the Campbell Farming corporation of Hardin, Mont. The 20-mile long farm lies at the foot of the Bighorn mountains.

Campbell, head of the farming corporation, will stay on as manager, Diesing said.

Diesing said Campbell will retain 400,000 acres of land in New Mexico together with other mining and farm interests there.

The Omahan said the seeding of 30,000 acres of the Montana land to winter wheat has just been completed.

Campbell was born Feb. 19, 1892, in a sod hut near the Uni-

Veteran U Educator Sells Great Given Service Award

Miss M. Beatrice Johnstone, director of the University division Thomas D. Campbell, North of correspondence, was present-Dakota native known as the ed a service award in recognition of 58 years of service by the alumni association at the alumni banquet October 21.

> Miss Johnstone was introduced as "Queen of the Alumni" by Mrs. John Cooley of Minot, a member of the University board of directors.

> As an expression of the gratitude and high esteem in which Miss Johnstone is held, the award was signed by the officers of the alumni board and President John C. West.

> Miss Johnstone entered the University in December, 1886, and was a member of the graduating class of 1891.

Named as one of the 10 leading women in North Dakota, her list of achievements in the state are great. Recently she was appointed on a state industrial commission, representing the University, along with President West

She has directed the correspondence study division at the University since 1933. Previous to that she was secretary in the department of instruction, extension division from 1924-33 and was Grand Forks county superintendent of schools for 12 vears.

In 1914 Miss Johnstone was a rural school nurse, the first person in the U.S. to hold that title.

She also has written several articles for the University Quarterly Journal, and edited the first county school bulletin in the state.

Sioux Win Two Big Victories

The University football team, an up-and-down eleven all fall, heads for its final game against Toledo university in the Ohio city with the knowledge that two big games have been won and that the over-all picture may be regarded as successful.

Head Coach Dick Miller and his assistant, Frank Zazula, turning out their first Sioux team, have satisfied the big majority of fans with their method of work, the style of football they taught and the results.

The Sioux won three, tied one and lost two to finish midway in the North Central conference standings but of great satisfaction to football fans here, they finished on top in two games they wanted to win the most.

The outlook-both from the standpoint of weather and actual football success—was grim for the Homecoming clash with South Dakota State. The Jackrabbits were undefeated in the conference at that time and deserved their rank atop the heap. The previous week the Sioux had absorbed a horrible 10-0 shellacking from Iowa Teachers at Cedar Falls and there was little hope of a come-

But the 5,500 who looked on in Memorial stadium saw the Millermen stage a complete form reversal to earn a 19-7 triumph over the tough S. D. S. club on a soggy field. It capped a successful Homecoming celebration.

The following week, Homecoming activities were being observed at North Dakota A. C. in Fargo and the Sioux had a big score to settle down there. A year ago, the underdog Bison had ruined the Sioux, 19-7. They were gunning for another upset but it wasn't in the cards. At the end of a blustery afternoon, the Sioux had gained revenge, 13-6, and the Bison, having a poor season, had still to turn in a triumph in 1949.

Dr. Paul A. Wheeler, 46, brother of Dr. George A. Wheeler, University professor of bi-ology, died October 1 at Rochester, Minn., after an illness of several months.
