## University Receives Large Cancer Grant

Research and institutional grants totaling \$42,850 have been made to the University of North Dakota medical school by the North Dakota Cancer society.

Dr. L. W. Larson of Bismarck, chairman of the Cancer Society's executive committee, said the institutional grant is for \$18,450, and the research grant, \$24,400.

Larson said that the institutional grant is earmarked for the department of pathology, physiology and anatomy. It will be used mainly to buy special equipment for cancer research.

The research grant will cover salaries for research fellows

and students, and technical personnel, and the cost of expendable equipment and materials such as experimental animals and chemicals.

Larson said the grants represent funds accumulated by the Cancer society from its annual campaigns conducted in April of each year.

In announcing the grants to NDU, Larson added:

"The North Dakota Cancer society is happy to help the university medical school develop its research program. It hopes the North Dakota researchers will provide links in the chain which will eventually restrain the great enemy of mankind—cancer.

"It might even be that they will help build the key which will unlock the door and expose the factors which cause cancer."

As the result of its fund-raising campaigns, Larson said, the state society has developed a program of education, service and research.

## Provide Gifts For University

Provision was made for the University of North Dakota in the wills of two prominent graduates who died during recent years—J. F. T. O'Connor and Judge H. A. Bronson.

O'Connor bequeathed his law library, volumes of bound correspondence, photographs and his appointment as comptroller of the currency under the late President Franklin D. Roosevelt.

In addition, he gave \$5,000 to the University, directing that the income from that sum should be given annually to the student or students who make the greatest progress in public speaking each year.

Provision was also made in O'Connor's will that following the death of his last remaining beneficiary, the remainder of the estate is to be divided equally among the University and Academy of St. James, St. Michael's and St. Mary's schools in Grand Forks, with the provision that each institution shall raise a sum equal to this share. The sum raised by each institution is to be held in trust and the income used for scholarship awards.

The will of Judge Bronson directed that "in recognition of the education afforded me by my Alma Mater," a quarter section of land in Grand Forks township be given to the University, "so long as it shall remain a University at Grand Forks."

## Gift Presented By Ford Firm

A complete engine assembly has been presented to the University mechanical engineering department by the Ford Motor Co. and the Forx Motor Sales, Inc., of Grand Forks. The gift was arranged through Prof. Bryce J. Fox and will be used as an instrumental aid.
