588 Get University Degrees

The University graduated the largest class in its history at ceremonies May 31.

Including 91 who completed work at the end of the first semester, there were 588 students listed as graduates.

The largest previous class of candidates for degrees was last year's 394. A large number of the present class were married veterans.

Speaker for the exercises was Dr. Arnold Lowe of Minneapolis, president of the board of trustees for Macalester college. He spoke on "Time is Running Out on Man."

Three well known North Dakota men received honorary degrees at the University and Wesley college commencement.

The University granted honorary degrees to A. G. Arvold, founder of the Little Country theater at NDAC in Fargo, and to C. J. Murphy, retired Grand Forks attorney. Wesley college awarded the honorary degree of doctor of divinity to Rev. Hubert N. Dukes, pastor of the Federated church in Grand Forks.

Murphy received the doctor of laws degree and Arvold the doctor of humanities degree.

Murphy was admitted to the bar in 1893 and practiced law in Grand Forks for 56 years before retiring. He was general counsel for the Great Northern railway when he retired and had served three terms of six years each on the state bar board.

Arvold came to NDAC in 1907 and won national recognition as founder of the Little Country theater movement. He was imperial potentate for the Mystic Shrine in 1944-45.

Fred J. Dixon, 1925, has settled in Olympia, Wash., after having lived in seven states, the District of Columbia and three foreign countries. At present he is district engineer for the bureau of public roads.

Lemke, N. D. Solon, Dies At Fargo

Congressman William Lemke (R., N. D.), 1902, died suddenly on a visit to Fargo May 30, and was buried in Fargo June 2. His death was apparently caused by a heart attack. He had come to Fargo from Washington to campaign for re-election.

One of the founding leaders of the Nonpartisan League, Lemke was first elected to congress in 1932 and had served there since, with the exception of one term, 1941-42. He was nominated for congress that year but resigned to challenge William Langer for the U. S. senate, losing by only 8,000 votes. Lemke was also an unsuccessful candidate for president on the ticket of the Union party in 1936.

Born in New Albany, Minn., Lemke grew up in North Dakota, residing with his parents near Cando. He graduated from the University of North Dakota in 1902 with a B. A. degree. He studied law at UND and Georgetown university, and received his law degree from Yale in 1905. He started practicing in Fargo in 1905.

His interest in politics dated back to his University days. When the Nonpartisan League was organized in North Dakota in 1914, he became one of the leaders, but broke with the league in 1937. The ROC has

Thoreson Killed in Accident

Harold (Buck) Thoreson, 1931, was accidentally electrocuted May 21 as he returned with his family from a fishing trip. At the time of his death, Thoreson, 42, lived in Los Angeles.

Thoreson was born in Hansford, N. D., but moved to Fargo as a boy. He played football with Fargo high school and Concordia college of Moorhead before coming to the University. While a student here, he was a fullback on C. A. West's first Sioux outfit which was undefeated in its conference and beaten only once that season. He graduated with a B. A. degree in 1931.

After leaving here, he moved to California, where he served as state relief administrator. He spent several years in Washington as a congressional secretary and later became postmaster in San Bernardino, Cal. He served in the army air corps in England in World War II, reaching the rank of major. At the time of his death Thoreson was an official in a firm of commercial builders in Los Angeles.

He is survived by Mrs. Thoreson, three children, three sisters and three brothers. Services were held in Los Angeles.

Richards, 1916 Grad, Succumbs

Wilson Crosby Richards, 1916, sales director of Goodyear Tire and Rubber company, died at his home in Port Elizabeth, South Africa, March 26.

Richards arrived to take up his present appointment in South Africa last September. For 11 years before that he was sales director of Goodyear in Australia and would have completed 25 years with the company April 1.

For the past 20 years he had been on overseas duties for Goodyear. In 1929 he was appointed to Italy and after a year took control of the Goodyear operation in Trieste. In 1930 he was transferred to Manila as manager of Goodyear in the Philippines. His next tour of duty, in 1937, took him to Brazil, where he served as general manager before being assigned to Australia in 1938 as sales director.

He is survived by his widow, the former Genevieve Burrell, 1916, who is in South Africa, and two sons, Donald and Robert, who are in the United States.
