DePuy Dad's Day President

William DePuy, class of '26, of Grafton was elected president of the University's Dad's Day association as the group held its dinner and meeting during the second annual Dad's Day weekend.

DePuy succeeds Loyde C. Thompson of Grand Forks. Lloyd Stone, alumni director, was re-elected secretary-treasurer.

More than 300 attended the dinner and program, at which Dr. Fred S. Hultz, president of North Dakota Agricultural college, was the principal speaker.

Tours of the campus were conducted for visiting parents, with emphasis placed on new building projects underway.

C. A. Gillette of Chevy Chase, Md., received a plaque for coming the longest way to attend Dad's Day. Dads sat in a special section in Memorial stadium for the Dad's Day football game between the Sioux and N. D. A. C. and watched a 33-0 University triumph.

Mrs. Arthur Fleckten (Bernice Smith, 1935) lives in Drayton, N. D. She has two daughters.

Sioux Football Team Strongest in Years

Sioux football fans this fall have been watching the best home team to play in Memorial stadium in years and although it will not be crowned North Central conference champion, the over-all record for the season is excellent.

The two biggest crowds of the season, Homecoming and Dad's Day, saw the Sioux

score convincing victories. South Dakota U, with a big, fast club rated one of the conference's best, was toppled at Homecoming, 28-7, and a big Dad's Day crowd saw the Sioux crush North Dakota A. C., 33-0.

Reserves Take Over

A victory over the Bison is always welcome and the one

this year was one of the most decisive in history, although larger scores have been compiled. Coach Frank Zazula used 37 players against the Bison and the reserves played a good share of the third quarter and the fourth.

Zazula, in his first year as head coach, and his assistant, Roy Hausauer, a former Sioux line star, have built a powerful eleven. It has improved from week to week. Early season fumbles cost the Sioux two games which they could have won.

After opening with an easy 53-0 victory over Moorhead Teachers, they lost, 33-21, to Iowa Teachers in their conference opener. Fumbles led directly to the setback. The following week, the Sioux had Morningside beaten until a fumble in the closing moments cost the game and the Maroons gained a 13-13 tie.

Defense Improves

From then on, the defensive improvement became more marked. A strong Bemidji Teachers eleven was humbled, 26-6. South Dakota fell, 28-7, but the next week the fumble jinx hit again and instead of scoring a 21-14 victory over South Dakota State, the Sioux were tied, 21-21. A last-minute fumble presented the Jackrabbits a chance on which they capitalized.

In that game, the Sioux were three-touchdown underdogs to the conference leaders and new champions. It was Homecoming at Brookings, S. D., and some 8,000 fans who had expected to see State win were happy to settle for a tie. So were the Bunnies.

Zazula and Hausauer have developed a powerful running attack with Lloyd Hallada, Cy DuCharme, Al Heising, Herb Claffy and Herb LeMoine spearheading the drive. Mark Foss and Al Thogersen, at ends, spark an aggressive line.

Advisory Group Meets

University problems were discussed by the University alumni advisory committee which met at a breakfast meeting during the Dad's Day weekend celebration.

Recruiting of students, the athletic program, publicity for the University over the radio and in newspapers and the work of the alumni advisory committee were considered. The committee is composed of 35 University alumni who are residents of North Dakota.

Union Fund Receives \$1,000 Gift

A pioneer Grand Forks woman, born too early to enjoy the advantages of the University of North Dakota, has left UND's Memorial Student Union \$1,000 in her will.

Mrs. M. S. Titus, who died in Minneapolis September 6 at the age of 84, was one of the first white children to live in Grand Forks. Born in Ohio in 1866, she came to Grand Forks with her parents, Mr. and Mrs. Frank Viets, in the early 1870's. Because there were no schools here, she was educated at St. Mary's hall in Faribault, Minn.

She was married to Mr. Titus in 1887, just three years after UND opened its doors. She resided in Minto until Mr. Titus' death and in recent years divided her time between Grand Forks and her summer home in Bemidji.

Survivors include two daughters, Mrs. M. C. Bachelor of Grand Forks and Mrs. Frances Plunkett of Bemidji. Most of Mrs. Titus' five grandchildren attended the University.

The will is now being probated.
