Rebuilding Started



John M. Hancock, 1903, New York banker and industrialist, forwarded a \$15,000 gift and Maxwell Upson, 1896, sent stock certificates valued at \$4,500.

In addition to his wide business interests, Hancock has been called often to handle important assignments for the federal government. The most recent was to study the recent automobile price cutback order and work out a new price formula for the economic stabilization agency.

Upson is chairman of the board of the Raymond Concrete Pile company in New York.

Following his graduation from U. N. D., he attended Cornell university, where he received his M. E. degree in 1899. In 1931 he was awarded his doctor's degree from the University of North Dakota.

From 1899 to 1905 Upson was with Westinghouse, Church, Kerr and company of New York, advancing to the position of project manager. In 1905 he joined the Hauckanum Mills company of Rockville. Conn. and was with that firm two years as chief engineer and assistant to the president.
