THOMAS WHELAN New Ambassador

Thomas E. Whelan, 1916, one of North Dakota's most videly known farmers and pusiness men, has been appointed United States ambasador to Nicaragua and will ake over his new duties this all.

Whelan is a lifelong resilent of St. Thomas, N. D. He vas born there April 15, 1895, nd graduated from St. Thoms high school in 1912. He ttended the University of North Dakota for four years, eceiving a degree in 1916. ater he attended George Vashington and Georgetown niversities until entering the rmy in 1918. He was at the fficers training school at when dis-'t. Grant, Ill., harged.

Whelan was married to fiss Mabel Stewart at Fargo n 1927. He is a member of he American Legion and the brand Forks Elks lodge.

On entering the diplomatic ervice, Whelan carries with im a long record of successul political activity and a ride acquaintance with the inide of governmental affairs.

He served in the North Daota state senate from 1932 to 1940 and that year was a candidate for the Republican nomination for U. S. Senator, opposing the present North Dakota senior senator, William Langer.

From 1938 to 1940 Whelan was a member of the Republican program committee and helped to map the farm plan which was adopted by the party. He was Republican state chairman from 1940 to 1948 and previously had been acting state chairman. Whelan has been prominent for many years in both state and national American Legion circles.

Whelan is associated with his brother, Louis, in the firm of Whelan Bros. of St. Thomas, grain dealers and farm operators.

John Page, Educator, Dies at 54

John A. Page, first director of the North Dakota state medical center, died at his home in Grand Forks at the age of 54 years.

Mr. Page, ill since December, became director in 1949. He previously headed the University teacher placement bureau and was a professor in the school of education.

He was considered largely responsible for enactment of the one-mill constitutional levy for support of the medical center.

He came to the University in 1935 where he had served as state director of secondary education for eight years. He after graduating from the University in 1921. He received a master's degree in 1934 from UND. He was born in Hamilton, N. D., and is survived by his wife and a son, John.

Mr. Page was Alumni Association president in 1944-'45.

Mr. Page served in the United States army from June, 1918, to May, 1919, and was overseas from August, 1918, to March, 1919.
