Sioux Finish Second In Close Cage Race

A great finish against the North Dakota State Bison gave Coach Louis Bogan's Sioux basketball team second place in the final North Central conference standings, just a game back of the pace-setting Iowa Teachers.

The Peds finished with 10 won and 2 lost; the Sioux had a 9-3 mark.

Paced by Chuck Wolfe, who re-wrote the conference scoring record book, the Sioux won three of the four games from the Bison, which gave them two loop wins, to wind up their league play for the season.

They defeated Minot Teachers, 83-64, to gain a berth in the NAIA tournament at Kansas City but their bid for a national title was quickly squelched there when they lost their first game, 69-66, to St. Benedict's of Kansas.

However, fans here were eminently satisfied with the splendid conference showing after the opening games saw the Sioux look very bad. Starting in mid-January, they hit the stride expected of them and had a run of 10 straight wins (league and non-conference) before dropping the third game of the Bison series.

In that annual struggle, the Sioux spotted the Bison early leads in both games in the fieldhouse here, then rushed back to sink the downstaters, 74-67 and 85-78. They lost the opener at

Fargo, 65-56, but took the final, 73-59. In that one they rammed in 16 points while blanking the Bison through more than half of the final period to overcome a big deficit.

Wolfe, who finished his Sioux competition, has four North Central conference records now. They are:

Total points, 313 (old record 271); field goals, 107 (old record 105); free throws, 99 (old record 70); game average, 25.08 (old record 22.58).

To climax his splendid career, Wolfe was awarded the N.D.A.C. Rahjah club's trophy given to the player deemed outstanding in the Sioux-Bison series. There was no question about the justice of the award. Wolfe has earned his place among the list of all-time Sioux and North Central conference greats.

HOCKEY TEAM FADES AT END

North Dakota's hopes of gaining a berth in the NCAA hockey title tournament at Colorado Springs were shattered when the Sioux lost their last two games of the season to Michigan at Ann Arbor and finished third in the Midwest league.

While the frenzied fans here and through the area were bitterly disappointed, the team did finish a respectable third, only two points behind first-

Map Commencement Plans

Plans for the 1953 University Commencement are under way and this year will feature reunions of classes ending in the years 3 and 8—as 1913, 1928, 1933, etc.

Activities start June 8 with the traditional alumni gatherings, including an oldtimers

breakfast and the annual alumni banquet. Graduation exercises will be held June 9.

Committees to handle the various phases of the two-day event are being appointed and details of the complete program will be announced in the next edition of the Review.

Remove Building Projects

North Dakota's 33d legislative session adjourned early this month after 60 days work in which oil legislation was one of the prime subjects discussed.

Institutions of higher learning were not neglected, even though all building projects were removed from the budget.

The educational service budget allowed the University was large enough so that the school will be able to hold its own for the coming biennium and small increases in salaries for the staff will be granted.

Of the \$9,419,369 in state funds granted to colleges, the University received \$2,920,000 for operating and \$127,821 for special projects. Added to this will be the school's estimated income of \$500,000.

Funds were made available for purchasing additional land west of the Gamma Phi Beta sorority house, for equipment for the school of education building and for power plant equipment. In addition to this legislation was approved making it possible for the athletic department to pledge future revenue from the Winte Sports building so that fund might be borrowed to purchase artificial ice equipment.

Another bill passed by the legislature of vital importance
