## Madrigal, Band Tours Successful

The University's Madrigal Club, directed by Hywel C. Rowland, has completed its thirtieth annual spring tour, appearing in Minneapolis, Clinton and Delavan, Wis., Chicago and Evanston, Ill.

The annual home concert, sponsored by the Grand Forks Lions Club; an appearance at the inauguration of President George W. Starcher April 20; concerts at the Bathgate School for the Blind and Hoople high school April 26 still remain on the Madrigal Club's schedule.

The group concludes activities for the year at Commencement activities.

The spring tour was another in the group's long series of successes and part of the pleasure of the trip was meeting former University students in cities on the route.

### BAND PLAYS NINE CONCERTS ON TOUR

The University Band under the direction of John E. Howard was on tour from March 13 through 19 playing seven concerts in Chicago, one in Minneapolis, and one in Ellsworth, Wisconsin.

Fifty-five members of the band were chosen for the tour. Howard reported that all committees have asked for a return of the band next season if the tours can be arranged.

As a climax to the tour the band gave its seventeenth annual home concert, sponsored by the Rotary Club of Grand Forks. The band at that concert received a splendid ovation.

## Inauguration of UND President Scheduled

Dr. George W. Starcher will be inaugurated as the ninth president of the University of North Dakota, April 19-20. Prof. John E. Howard is general chairman.

A partial list of inauguration events include an address by N. D. Supreme Court Justice Nels Johnson, 1924, and the appearance of Ernst Von Dohnanyi, renowned composer and pianist, during the week of the inauguration at several appearances.

Inauguration plans call for the formal inauguration Wednesday, April 20, at 10 a. m. in the University Fieldhouse, preceded by an academic procession of the UND faculty and members and delegates from institutions of higher learning.

Dr. Starcher was named president by the North Dakota Board of Higher Education last spring and assumed the

office July 1 on the retirement of Dr. John C. West. Dr. Starcher came to UND from the University of Ohio.

At the inaugural, greetings will be extended from the UND faculty by Prof. W. E. Koenker, from the UND student body by Thomas Sullivan of Lisbon and for the UND alumni by William DePuy of Grafton, 1926.

Dr. Starcher will deliver the main address and Law School Dean O. H. Thormodsgaard will preside.

Prof. Howard said all American colleges and universities had been invited to the inaugural and in many instances distant schools have delegated graduates in the Upper Midwest to represent them.
