New Grant Made for Research

Receipt of an additional grant of \$2000 from the Bremer Foundation, St. Paul, for research in physiology at the University of North Dakota has been announced by Armin F. Rohde, president of the Alumni Association.

The grant will be used under the direction of Dr. W. F. Potter, head of the physiology department, and is similar to one made by the Bremer Foundation in 1953.

Potter and his associates are in the process of building a Gibbs artificial heart in the laboratory to aid them in the study of kidney functions.

Expressing his thanks for the grant, Potter said that upon completion of research projects under way the staff will do research on liver circulation and related subjects.

President George W. Star-cher, speaking on behalf of the University, thanked the foundation and said that funds of this kind for unrestricted research in various fields will be of great benefit to the University.
