Mr. BURDICK introduced the following bill; which was referred to the Committee on Public Lands

A BILL

To provide for certain per capita payments to members of the Three Affiliated Tribes of the Fort Berthold Reservation, North Dakota.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That when the Secretary of the Interior determines that the
4 purposes of sections 2 and 12 of the joint resolution entitled
5 “Joint resolution to vest title to certain lands of the Three
6 Affiliated Tribes of the Fort Berthold Reservation, North
7 Dakota, in the United States, and to provide compensation
8 therefor”, approved October 29, 1949, have been accom-
9 plished, he is authorized and directed to use the unexpended
10 balance (1) of the fund of \$5,105,625 made available for

1 disbursement under section 2 of such joint resolution, and
 2 (2) of the sum of \$7,500,000 placed to the credit of such
 3 tribes under section 12 of such joint resolution, to make equal
 4 per capita payments to members of the Three Affiliated
 5 Tribes who are living at the time of such determination by
 6 the Secretary.

7 SEC. 2. Amounts paid to members of the Three Affili-
 8 ated Tribes under this Act shall not be subject to any lien
 9 or other claim arising prior to the date of such payment.
