2nd Lt. Arne M. Vinje, 1954, is an instructor in leadership department in the Seventh Army Non-Commissioned Officer Academy in Germany.

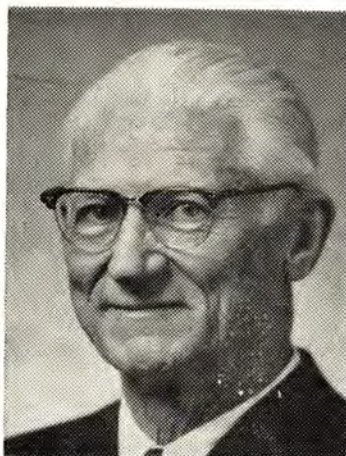

European Tour Plans Announced

Dr. Dorothy J. Lipp, Dean of Women at the University, has announced the opening of applications for a European student tour for nine weeks this summer. The group will be limited to 20 or 25 students of the University, other North Dakota colleges, alumni and older high school students who can qualify. The itinerary is expected to cover the major centers of cultural and historical interest in England, France, Italy, Austria, Germany, Switzerland, Belgium and the Netherlands. Miss Lipp will accompany the group as adviser. They leave New York July 12.

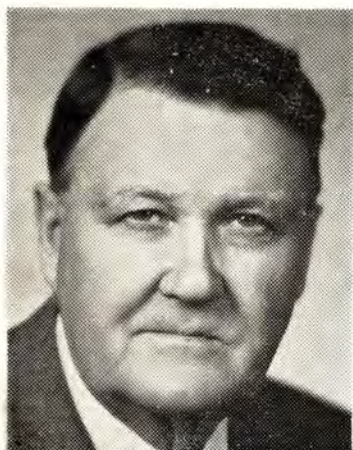
In connection there is an optional 10 days tour of the Scandinavian countries, while the main group goes to London, visits Stratford-on-Avon, and embarks for home August 26, landing in New York September 4. The group which goes to the northern countries will reach England August 30, spending five days in London and its environs, sailing for home September 5 and landing in Quebec.

"Our emphasis will be educational rather than touristic," Miss Lipp explained, "And as such we are planning a series of meetings and special events with students and other citizens in each country. Also we plan to include such summer highlights as the Salzburg Music Festival in Austria and the Shakespeare Theater in England."

On board ship there will be intensive language instruction to enable the students to get along comfortably in the countries they visit. Miss Lipp can give further details and has application forms for those who are interested.
