## A BILL

To provide for the segregation of certain funds of the Fort Berthold Indians on the basis of a membership roll prepared for such purpose.

1 Be it enacted by the Senate and House of Representa-2 tives of the United States of America in Congress assembled, That the Secretary of the Interior is authorized and directed 3 to segregate the fund on deposit in the Treasury of the 4 5 United States titled "The Three Affiliated Tribes of Fort 6 Berthold Reservation, North Dakota" on the basis of a mem-7 bership roll prepared for that purpose and approved by the 8 Secretary. The segregated shares of adults, including inter-9 est accruals thereon, shall be subject to expenditure in ac-10 cordance with plans prepared and submitted by such adults and approved by the Secretary. The segregated shares, including interest accruals thereon, of persons who are minors
or non compos mentis shall be subject to expenditure in
accordance with procedures approved by the Secretary. The
Secretary may require any segregated share of a member to
be used to pay a debt that is owed by such person to the
Tribes or to the United States and that is due and payable.
