### \$16,000 Allocated for Awards to U Faculty

A total of \$16,080 has been allocated by the University of North Dakota Alumni Association for faculty awards from March, 1955, to this month, according to J. Lloyd Stone, association director.

Dr. E. L. Grinnell, chairman of the faculty awards committee, will recommend an additional \$8,000 for this an addition \$8,000 for this purpose in the coming year. The report will be made at the association's annual meeting during Commencement events on the campus next month.

The money is allocated through the University president and deans, who determine the projects for which it is to be used.

To date the funds have been made available to assist deserving retired faculty members, to aid professors in research and writing projects, to pay expenses of University personnel to scholarly conferences when the expenses could not be underwritten by the University, and to meet expenses of various faculty groups and meetings.

Included in this list was the financing of the Conference on Higher Education for faculty improvement, held at the University last fall. The awards fund also paid for publishing a booklet summarizing the discussions and findings of the conference. In addition to Dr. Grinnell, committee members are Mrs. Milton Kelly of Devils Lake and Armin Rohde, UND Alumni Association president.

## Graduate Featured In Article

Grover J. Holt of Ishpeming, Mich., a 1916 graduate of the University of North Dakota, was featured in an article in the February issue of Mining Engineering magazine.

Holt has been named president of the American Institute for Mining Engineering for 1957.

A native of Northwood, N. Dak., he received a B.S. degree in mining engineering at UND in 1916. He became a research fellow in metallurgy at the University of Utah and last year was awarded the honorary degree of Doctor of Engineering by the Michigan College of Mining and Technology.

The magazine pays tribute to Holt's achievements, saying "he has not only pioneered in

Mrs. T. E. Waldon of Grand Forks, Alumni Awards Chairman, in calling the roll of this group of diploma winners and in giving the charge to the class, will point to the many sacrifices made by these wives of students in assisting their mates to their goal of a college degree.

It is recognized, she will tell the wives, that they are the real motivating force in this "battle for education," and that, if it were not for them, there would be far fewer married men in the University today.

Pointing out that they already had attained their first degree of MRS .- which had entitled them to such "honors" as round-the-clock domestic help, infant raising, balancing the family budget, bringing in income and generally supplying the moral and financial support needed by their husbands-Mrs. Waldon will tell them of the Alumni Association's desire to see that they, at last, get the recognition to which they are entitled.

The diploma, designed in the office of Alumni Director J. Lloyd Stone, will even give the wives credit for their activities in the "L.W.U.P.E.S.-B.T."— the League of Women United for the Purpose of Enforcing Study Before Television.

But, more seriously, it will admit the wives to honorary life membership in the Alumni Association.

In commenting on the new alumni recognition ceremony for the wives, Stone pointed out that it will be the culmination of a phenomena that did not exist in colleges a quarter of a century ago. To have two or three married students enrolled in those days was a rarity, he said.

### Seek Photographs for University History Book

Photographs are being sought to be used for illustrative purposes in the publishing of a book on the history of the University of North Dakota. The history is being written by Dr. Louis G. Geiger, associate professor of history.

Scheduled for publication in 1958 in conjunction with the University's 75th Anniversary, the book will contain more than 300 pages of text. The project is approximately three-fourths completed.

Photographs desired are those concerning the earlier stages of University history, primarily before World War I, with particular need for those dealing with the University's first 15 years, 1883 1889. Actual photographs-not newspaper clippings-are requested.

Specific photographs being sought include the following: 1. Dedications of Old Main, Budge Hall, Davis Hall and other early buildings.

2. Scenes of life and buildings in early Grand Forks.

3. Portraits of informal pictures of Homer Sprague, Henry Montgomery, John Macnie, Horace B. Woodworth, William Blackburn, William Budge, Ludovic Estes, Hannah Davis.

4. Early graduating classes. 5. First, or nearly first, football team.

6. Student life in early years, including classes, social events, or other activities. 7. Old streetcar line on Uni-

versity Avenue. 8. The "Black Maria," horse-

drawn hack used in the early davs of University history.

9. The railroad track between the University and the city.

10. Sod house any student lived in when he left home to enroll at the University.

11. Railroad station which preceded the one the University has now.

12. First Board of Regents, including Dr. W. T. Collins, Dr. C. A. Teal, Dr. R. M. Evans, the Rev. E. A. Healy, and James Twamley. (Group or individual.)

Photographs of any University event or activity in UND's early years are wel-

come, said Dr. Geiger. The pictures will be helpful not only in the publication of the history, but for the Dacotah yearbook's special 1958 edition and for souvenir anniversary booklets planned by the University News Bureau.

Photographs will be returned or added to an anniversary scrapbook, as the contributor desires.

Eight chapters of the 11chapter history have been completed. Descriptions of contents follow:

Chapter 1-Founders and the founding.

Chapter 2-The first year: President William Blackburn. Chapter 3-The University takes firm root: Henry Montgomery and Homer Sprague, 1885-1891.

Chapter 5-The progressive era of building and expansion: the second phase of Merrifield's presidency, 1899-1909.

Chapter 6-Administration of Frank L. McVey, 1909-1917. Chapter 7-Transition in student life; general description of student life, 1899-1917.

Chapter 9.-Administration of Thomas Kane, 1917-1933.

Chapter 10-The West administration, the depression and the war.
