Robert May Named New **Hockey Coach**

Robert (Bob) May, 30, former UND all-American hockey player and team captain, has been named University head hockey coach to replace Allan Renfrew according to an announcement by President George W. Starcher.

Renfrew resigned in May. He accepted a similar post at his alma mater, the University of Michigan, after one season at UND

May was graduated in 1951 with a bachelor of science degree in education, including a double major of physical edu-cation in history. This past vear he has coached hockey at Roosevelt High in Minneapolis, Minn., and has guided Several Minnesota high school teams to championships.

Visits Campus

Making his first official visit to the University since taking office in January, Governor John E. Davis addressed UND alumni gathered in the Memorial Student Union June 7 for their annual commencement season smorgasbord.

As governor, he declared the year beginning in February, 1958, "shall be officially designated as the 75th Anniversary Year of the University of North Dakota."

Lauding the University for its continued growth and service to education, Governor Davis said the school "has been blessed by an alumni organization that has been constructive and helpful in building the University program."

Governor Davis Prominent Alumnus Leaves \$50,000 to U

A check for \$50,000 from the estate of the late John Hancock, prominent University alumnus who died last fall, was announced by the Board of Directors of the UND Alumni Association at its annual meeting in the Student Union June 7.

Convening during spring commencement events on the campus, the directors placed the Hancock money in a bank trust account for investment along with other resources of the University Development

Enrollment **Breaks Record**

A total of 1026 students have enrolled for the University's 57th summer session. This is the largest registration in history, according to Ruby M. McKenzie, registrar.

Of this total, 738 are men, 288 are women, 260 are veterans and 499 are graduate students. Enrollment in the 1955 and 1956 summer session topped the 900 mark.

Swelling the total this year are the 80 students enrolled in the Summer Institute of Linguistics and 53 more in the Science and Mathematics In-

Award Service Citation To 4 University Alumni

Four UND alumni were awarded the Alumni Association's Distinguished Service Citation June 7 at the group's annual meeting.

Dr. John C. West, retired president of the University, received the honor "serving the University as chief executive for 21 years, the first alumnus of UND to become its president;" and for his "good judgment, hard work, integrity and loyalty to the staff" during that time.

Another recepient was Maxwell M. Upson, 1896 UND graduate and prominent New

York engineer and industrialist, for his achievements as "inventor, administrator and humanitarian" and for his pioneering with reinforced concrete construction.

Lawrence R. McCoy, member of the UND class of 1910 and prominent Vermont artist, received this recognition for "his brilliance as an artist, for his success as a business executive and for his interest and support of education of the fine arts.

The citations were awarded by Directors of the Alumni Board.

Six Win Fritz Scholarships

Four 1957 North Dakota high school graduates and two UND students have been named winners of the first annual Chester Fritz Scholarships at the University. The grants total \$5,000.

Receiving undergraduate scholarships of \$800 each are Judith Ann Sturnick, Minot; Janet Parkinson, Bismarck; Robert Nelson, Fargo; David Myers, Enderlin; and Shirley Ebel, Lidgerwood. Miss Ebel has completed her sophomore year at the University and the other four recipients are spring high school graduates who will enter UND in September.

Winner of a \$1,000 scholarship for graduate study at the University is Glenn Muir, Inkster. He received a bachelor of science degree in business and public administration at UND June 9.

The awards are the first to be made from the Chester Fritz Scholarship Fund established at the University last November. The \$5,000-per-year gift from the New York Banker and financier represents the largest scholarship fund ever received by the University.

Born in Buxton and graduating from Lidgerwood High-School, Fritz attended UND from 1908-1910. He received an honorary doctor's degree from the University in 1952.

In establishing the awards, Fritz stipulated that preference be given to applicants who are North Dakota residents, and that at least once in two years preference be given a graduate of Lidgerwood High School.

Selection is based on character, dependability, scholarship and leadership.
