Open House Held at New Med Center

The newly-completed Medical Center Rehabilitation Unit at the University of North Dakota held an informal open house for the public January 25.

Open to patients from the state and area, the unit is a single-story brick building with partial basement for storage. Approximate cost for construction of the building and for equipment was \$350,000. Construction began in October, 1956.

Building funds were provided on a matching basis by the University Medical Center and the Hill Burton program.

The unit has been named in honor of Dr. Archie D. McCannel, Minot, who served for a number of years as a member of the State Board of Higher Education.

Staff for the new facility includes Dr. Doral West, Pittsburg, Kansas, chief of psychological services; Frank Brown, Oklahoma City, Okla., chief of social services; Kenneth Koch, Valparaiso, Ind., chief of physical therapist; and Arthur Bergquam, pre-vocational supervisor. Dr. E. G. Olmstead, assistant professor of medicine at UND, will serve as consultant in internal medicine.

Miss Frances Landon is executive director of the rehabilitation unit, and Dr. T. H. Harwood, dean of the School of Medicine, is secretary of the Medical Center, which sponsored the construction.

Miss Landon said the services, to be available to the physically disabled persons of North Dakota and adjoining states, will be those usually included in a comprehensive rehabilitation unit; that is, medical services to include physical and occupational therapy, speech and hearing testing, and therapy and consultations as indicated by the medical specialists.

In addition, social and psy-

University Arranges Telecasts

A series of three educational telecasts on closed circuit were televised on January 23 from the KFJM Studio on the University of North Dakota campus.

Professor Myron M. Curry is the director of the University Broadcasting Service. Each of the telecasts was one hour long.

Dean Cushman, UND College of Education, said that plans are to extend co-axial cables to several buildings on the UND campus from the KFJM studio, which is located in Science Hall.

Sevareid to Speak at Founders Day Event

Eric Sevareid, one of the nation's most honored newsmen, will be the main speaker February 21 at ceremonies launching the University of North Dakota's 75th Anniversary. Sevareid is chief Washington correspondent for the Columbia Broadcasting System.

A native North Dakotan, Sevareid will address the Founders' Day convocation on the campus at 10 a. m.

The Founders' Day observance, scheduled to be held in the University Fieldhouse, is the ceremonial opening of a year-long series of commemorative events. Preceding the talk, four UND musical organizations will combine to present "The Towering Vision," a special Anniversary cantata written by two members of the UND faculty.

Sevareid has received many awards in broadcasting, including the Freedom Medal from Norway, the George Foster Peabody Award for interpretation and reporting, the "One World" Award for radio, the Alfred I. Dupont Award, the George Polk Memorial Award, the Brotherhood Award of the National Conference of Christians and Jews, the Sidney Hillman Foundation Award, the Outstanding Achievement Award of the University of Minnesota, and the National Headliners Award for Consistently Outstanding Radio Network News Broadcasting.

During World War II, Sevareid covered battlefronts for

CBS News on both sides of the globe. He landed with the first wave of American troops in Southern France, and reported the course of the war through France and Germany. At the end of hostilities, he returned to this country to cover the founding of the United Nations at the San Francisco Conference. He has been one of the mainstays in the CBS News coverage of the 1948, 1952 and 1956 presidential election years.

U to Host Institute On Typing

The World Institute on the Teaching of Typewriting will be held July 7-9 on the campus of the University of North Dakota, John L. Rowe, professor and chairman of the business education department, announced.

Approximately 500 educators from South American countries, Latin America, Puerto Rico, Canada and the United States are expected to attend the institute, which is sponsored by the University business education department in conjunction with UND's 75th anniversary.

The main purpose of the conference is to study the improvement of instruction of typewriting and the role of typewriting as a "tool of literacy," Rowe said. Rowe is in charge of conference arrangements and is assisted by members of his department.

Several world champion typists will perform and a historical display of all material since 1878 written on the subject of typewriting will be shown.

Sevareid was born in Velva in 1912. At 18, he began his newspaper career on the *Minneapolis Journal*. He studied political science at the University of Minnesota and later, in London and Paris. He joined the staff of the *Paris Herald Tribune* and, later, the *United Press*.

Sevareid's book "Not So Wild a Dream," published in 1946, sums up much of the philosophy and adventures of the author drawn from his worldwide travels and reporting experiences. A collection of Sevareid's broadcast essays, "In One Ear," was published in book form in 1952. Another collection, "Small Sounds in the Night," was published in 1956.

The Founders' Day observance, originally scheduled for Feb. 22, was changed to Feb. 21 so that Sevareid would not be forced to cancel his appearance due to a television commitment, according to John E. Howard, chairman of the University's 75th Anniversary Steering Committee.
