Long Law Career of Grad Noted

(Below are excerpts taken from the Oregonian, Portland, Ore., Sunday, February 16, 1958 from a story on Bardi Skulason).

Bardi Skulason, "the lawyer's lawyer," is one of Oregon's oldest practicing attorneys.

He recently passed his 87th birthday, but works all day, five days a week in his office, or in court, if necessary. In addition, he is a veteran member of the Public Welfare Commission of the State of Oregon (15 years), has been Consul for Iceland since 1942 and at present is secretary to the Portland Consular Corps.

Bardi Gudmundson Skulason was born Jan. 19, 1871, on a farm near Akureyri, Northern Iceland, just 60 miles south of the Arctic circle.

When Bardi was five years old his parents immigrated to Canada. After four years in northern Manitoba the family moved to more fertile terri-

On Minnesota Board of Park Commissioners

Mrs. Clinton F. Phillips is the second woman in Minnesota history to be a member of the board of park commissioners.

The former Lorna Laney last attended UND in 1922 and received a teacher's certificate, she went on to study at a business college in Spokane, Wash., the University of California and the University of Minnesota. Mrs. Phillips also studied one year of law at the Minneapolis-Minnesota College of Law.

Mrs. Phillips was deputy county superintendent of schools for Logan county (Napoleon) N. Dak. She also served as state secretary for the North Dakota American Legion Auxiliary.

In Minneapolis, where she lives, she was secretary of the Minneapolis Research Bureau, and was author of a number of articles on "What Goes On In City Hall."

For the past 16 sessions of the Minnesota legislature she has conducted the Phillips Legislative service, keeping tab on legislative actions for her clients.

Her main hobby has been the Kenny Foundation, and she counts the late Sister Kenny among her friends.

In 1946 she was an unsuccessful candidate for the state house of representatives from the 34th district.

Medic Student Gets Fellowship

The department of anatomy of the University has been notified by the National Institute of Health of the United States Department of Health, Education and Welfare that Douglas Allen Miller, Cando, has been awarded a Post-Sophomore Medical Student Research Fellowship for work in the anatomy department.

He knew no English but he had read the Bible in Icelandic and he started to school.

Science Honors Institute Inaugurated in Pittsburgh

University graduate Milton M. Wachtel has inaugurated the Science Honors Institute held every Saturday in Pittsburgh, Pa. for 200 bright high school students.

Wachtel, a 1942 graduate, was featured in an article in the April 7, 1958 issue of the Pittsburgh Sun-Telegram which explained his plan to encourage promising science students.

Alumni Service Awards Given

Mrs. Edgar A. Massee (Evelyn Suter, 1924) and Dr. Ralph E. Mahowald, 1935, alumni members of Kappa Alpha Theta sorority and Sigma Alpha Epsilon fraternity, were presented alumni service awards at the fourth annual University Greek Week banquet.

They were selected from nominations by each sorority and fraternity.

Scholarship trophies were presented to Delta Gamma sorority and Alpha Tau Omega fraternity for maintaining the highest active and pledge combined averages in their two divisions last semester.

His idea is first to deliver a series of scientific fact-filled lectures on some of the newer phases of science and second to expose the students to real live scientists in their natural habitat, the lab.

Approximately 70 scientists are conducting these lectures without extra pay Saturday mornings. The 200 youngsters are picked for their outstanding record from schools in Allegheny County.

Wachtel stated, "Truth is, we can hardly pry them out of here. The institute is supposed to run from 9 a.m. to noon. They hang around here until 1:30 most Saturdays."

He continued that the idea for the institute came to him in March but the hysteria over Sputniks had nothing to do with it. It was prompted by the ill-trained students who go into universities.

Each Saturday a lecture is presented by a scientist. After the lecture other scientists take 15 to 18 youngsters into groups to discuss the lecture.

After a short break they visit labs and watch research teams in action. Each week a different group of scientists take over.

Although they don't get credit, the students will have their diplomas of recognition entered on their academic records.

The lectures cover such fields as solid state chemistry, light and crystals, atomic collisions, low temperatures—some of the things which aren't yet in text books.

Wachtel is convinced American youngsters have as much brains as any youngsters in the world—they just need to be cultivated.

After 41 years absence from general law practice, 1906 UND graduate Arthur B. Comfort, veteran Tacoma, Wash., political and insurance figure, is going back to the legal arena.

Bardi a book named Smile's "Self-Help" which was a collection of stories about great men who had risen to prominence through self help. Bardi read and reread this book many times.

He asked his father about this business of education. "I can't help you," the father told him, "but I understand that this is a country of self-made men. If you ever do anything, you have to be a self-made man."

When Bardi was 16 years old, he had a permit to teach in a country school. He taught until he had enough money to go to school. In 1888 he attended classes at the University until his money ran out, he then returned to teaching. He followed this plan for seven years. In 1895 he received his bachelor of arts degree, his life normal diploma and a Phi Beta Kappa key.

He began to read law and in 1897 he took an examination before the supreme court of North Dakota and was admitted to the Bar.

Bardi was assistant state's attorney for a number of years and was active in Republican politics.

He was lecturer on private corporations in law school for 10 years and served a term in the state legislature in 1908. He was author of North Dakota's non-partisan judiciary law and child labor law.

In 1911 he, his wife and two children moved to Portland, Ore., because of Mrs. Skulason's health.

He has practiced law in Portland. In 1923, he obtained a \$1,200,000 estate settlement for the widow of Eugene Day of Wallace, Idaho, now Mrs. Loretta Dean, and received a \$400,000 fee, to that date believed the largest attorney's fee west of the Mississippi River.

In addition to being a Knight of Iceland Falcon, an award which must return to Iceland upon his death, Mr. Skulason is a member of the Masonic lodge, the Oregon bar and the American Bar Assn., Paris Post No. 1 of the American Legion and Phi Beta Kappa, Delta Sigma Rho and Phi Alpha Delta law fraternity.

Cites Need Of Better Education

In his February 21 Founders' Day speech, newsman Eric Sevareid stated that improved education contains the one solution to the complicated problems of the United States in this shrinking world.

Sevareid said that pre-college schooling is "wanting." "Our schools are, I think, too idle too much of the year; too crowded, too easy, too understaffed by underpaid, underappreciated and often, undereducated teachers," he said.

He also placed the blame for inadequate education on parents, legislatures, our political leadership, our magazines and motion pictures for giving us a confused value system. These, Sevareid stated, substituted "popularity for greatness; publicity for fame."

He said we must lead the vast proportion of humanity into a workable non-Communist political and trading and communications system, or Soviet Russia will lead it into its own kind of system.

Before Sevareid spoke the cantata entitled "The Towering Vision," composed by Philip Cory with words by Dr. St. Claire, was given.

At the luncheon following the Convocation President George W. Starcher and Sevareid cut a 15 layer birthday cake, and Sevareid was presented a citation by Theta Sigma Phi, women's journalism honorary and Sigma Delta Chi, the men's counterpart.

U Extension Division Shows Rapid Growth

From one English class at Finley Air Base a year ago to 29 classes at present in seven North Dakota communities: This is the story of the growth of the University of North Dakota Extension Division in the past year.

Although some education classes had been offered spasmodically prior to setting up the Finley Class, the establishment of that class marked the initial installment in a new well-defined program of regular UND class offerings conducted off the campus.

The classes now being taught include three at Finley, 12 at Williston, two at Devils Lake, two at Minot, three at Bismarck and five at Grand Forks.

Enrollments in the 29 classes total 434, according to Ben G. Gustafson, Extension Division director. The enrollments include about 240 persons, several of whom are registered for more than one course, he pointed out. The off-campus classes are a service program, with courses established only upon request, Gustafson stated.

Programs offered in the various areas are based on demands and results obtained in surveys, Gustafson explained.

At Williston, the full freshman program is being taught, including English, mathematics, science, humanities, commerce, history and business education. Among other offerings are graduate education, mathematics and accounting at Grand Forks; English and psychology, Finley; education and guidance, Bismarck, and education at Devils Lake, Rugby and Minot.

The Extension Division aims to carry instructional opportunities to citizens of the state qualified to profit by them and to render service to schools, communities and individuals, he said.

The University, with its research material and library resources, is in a position to render this type of service at a minimum cost and with a maximum of efficiency, he added.

Regular University faculty members teach the courses at Grand Forks, Devils Lake, Finley and Rugby, whereas in the other areas classes are conducted by available qualified professional personnel under special appointment.

As the program has expanded, Gustafson said, it has become self-supporting. Fees pay instructional costs, travel and incidental expenses, he explained.

Courses may be taken for credit or non-credit. More than 90 per cent of the enrollees are registered for credit courses, Gustafson stated.

Gustafson said the rapid growth of the program is indicative of increasing demand for adult education in North Dakota based upon expanded cultural and professional needs.
