U Receives \$225,000 Endowment

One of the largest scholarship endowments ever received by the University of North Dakota has been presented to the institution by the late Dr. John G. Arneberg, pioneer Grand Forks physician who died in 1958.

This was revealed recently with the entry of a final decree of distribution of his estate. His will added \$225,000 in securities to the lifetime contribution of \$25,000 he had made for the study of foreign languages at the University.

Trust Increased

This will made provisions for his widow and other members of his family to supplement those made during his lifetime and then decreed that the residue, after various charitable contributions, should be added to the John G. Arneberg Trust he established in September, 1957.

The residue, the final accounting revealed, consists of various securities with a present market value of approximately \$225,000, which with his lifetime gift brings the trust total to more than a quarter of a million dollars.

In establishing the trust Dr. Arneberg said: "My trustee shall at all times bear in mind that my principal object in establishing this trust is to promote better international relations through better knowledge and understanding of the languages, customs, literature, art and traditions of other countries, especially those of continental Europe. It is my belief that the ability to read, understand and appreciate the literature of a country is much more important than the mere ability to speak the language, as it is through the literature of a country that the best thoughts

U Graduate Heads Bar In Michigan

Burney C. Veum, 1927, of Sault Ste. Marie, Mich., is the 25th president of Michigan's State Bar Association. Veum's story starts in north-central North Dakota, where he was born in Esmond, Sept. 17, 1902. His parents were natives of Minnesota who moved westward in 1899 to homestead on the plains.

The family lived there for about 12 years and then moved to Parshall, N. D., where the father went into the hotel business and also continued with a farming operation in which his sons participated during their school days.

Parshall, Veum recalls, was "too new a town" to number a high school amongst its community facilities, so he attended high school in Fargo for one year, completing at Fessenden in 1922.

He then enrolled in the University of North Dakota and was graduated from its law school June 7, 1927, and admitted to practice in July 18, 1927. From that year until 1942 he was employed by the Aetna Casualty & Surety Co., with the claim department in Omaha, Neb., from 1927 to 1929; in Grand Rapids, Mich., from 1929 to 1933; and in Detroit from 1933 to 1942. Veum was admitted to practice in Michigan Nov. 16, 1936.

In the fall of 1953, Veum was elected State Bar Commissioner for the 11th congressional district. He has now served two three-year terms and was re-elected without opposition in September, 1958. He was vice president of the State Bar in 1958-1959.

He has devoted considerable time toward work of the bar. He was a member of the general committee of the building fund campaign, and a member of the committees on site acquisition, building plans, and campaign organization.

Veum is a member of Phi Delta Phi legal fraternity, the Rotary Club, Elks, is a director of the Sault Savings Bank, and a member of the Chippewa County Bar Association

The distribution of the income is placed in the hands of a committee consisting of the University president, the dean of the College of Science, Literature and Arts, and the ranking member of the faculty engaged in teaching each of the languages involved.
