first governor of the Hawaiian Islands.

The week's activities included a cruise into the Pacific through Pearl Harbor, and other points of interest, a one-day tour of the Island of Oahu, a Hawaiian luau, a visit to the government offices, and the national memorial cemetery, a full-day's trip to the outer islands, and many other functions.

Never shall we forget the hospitality of our old friends—the Min Hin Lis, Tashimas, Saikis, Miyasakis, Ishiis, Katsukis, Chung Hoons, Burgesses, Budes—and no less delightful was the forming of new friendships.

To us the memory of the soft music of the trade winds whispering through the palms and the surf on Waikiki Beach always will bring a lump to our throats as we think first of the gentle people of Hawaii opening wide their hearts and their arms to we "mainlanders" and gently calling "Aloha—Sayonara. Goodbye. Come back again."

UND's Heroic Sons: Silenced Sioux Are Remembered

The University Alumni tour to Hawaii had a moment of silence with memories of UND's heroic sons.

Most of the group had an opportunity to visit the National Memorial Cemetery in Honolulu.

They noted the graves of several North Dakota boys who lost their lives at Pearl Harbor and in other World War II action. They said a prayer at the Carlton Simensen marker, which reminded them of an editorial which appeared in the Dakota Student, campus newspaper, on Dec. 4, 1942, the first anniversary of Pearl Harbor.

Written by Larry Schlasinger, a young journalist who later himself lost his life in his country's service, the editorial is reprinted here:

Monday is an anniversary, and it reminds us here of a guy and a song, both associated almost inseparably with this University.

There was a guy we knew. One of the most popular, genial, earnest, modest BMOCs who ever stood head and shoulders above a campus.

We called him Sim. His real name was Simensen—Carlton Elliot Simensen—ROTC, Blue Key, Iron Mask, Second Lieutenant Marine Corps.

Sim stood on the deck of the U. S. S. Arizona a year ago, when literally out of a clear sky he found himself in the middle of a war.

Perhaps fifteen minutes later he was out of it—machine gun bullets through his white Sunday uniform. Not before he had done enough, though, to earn the praises of the secretary of the navy.

And there was a song Sim knew—he and the others like him. The last verse goes

"Alma Mater, thine the glory"

... the reflected glory ... of Sim and, Verne P. Augustine, and Edwin C. Borusky ...

"If a thought of ours or deed find a place in song or story, ... there will be songs, and stories, for men like these ... Richard J. Bridgeman ...

Daniel J. Hennessy ... Bertham P. Kampf ... "Win endeavors glorious meed."

Dr. Richard Beck, UND professor of Scandinavian languages and head of the foreign language department, was re-elected for his fourth term as president of the Icelandic National League of America at its convention in Winnipeg.

U President Lauds Faculty Policy Role

The place of the teacher in policy-making is discussed by Dr. George W. Starcher, University president, in *College and University Business*, a national magazine for educators.

Author of the guest editorial, "Faculty Participation in Administration," the president says "Academic freedom . . . now includes a high degree of faculty participation in decision-making—even faculty studies and research that gives us more intelligent bases for policy determination."

"If faculty members display less hostility now toward so-called 'administration' than they once did, it is not because they are becoming less 'intellectual' but rather because they are more concerned about understanding the requirements of getting the job done," he comments.

"The flagrant abuse of power and the arbitrary exercise of authority by boards and administrative officers in our colleges and universities are

matters of the past. The primary importance of the work of the individual teacher, and the necessity that all those concerned maintain a university-wide point of view, requires that boards and administrators seek the help of the faculty," Dr. Starcher states.

Faculty participation in policy-making "has paralleled, and is in fact partly responsible for," the advancement of higher education, Starcher concludes.

In another section of the magazine, the editors commend the University of North Dakota's efforts to bring high school and university into better understanding, mentioning in particular a recent UND conference for high school officials.

President Starcher's views on faculty participation are also quoted in the latest issue of *Memo to the Board*, a publication for trustees and others interested in higher education.

Lund himself died a few years later, his death most certainly hastened by the long months he spent in a German prison camp when the Air Force plane he was flying was shot down in combat.

Constitutional Changes Proposed

Major revisions in the Alumni Association Constitution are proposed by the Board of Directors for adoption at the June 3, 1960, annual meeting of the Association. The Constitution, originally adopted in 1908, is presented here as it reads now and as it would stand with the proposed amendments, as they were approved by the Directors at their February meeting.

●Present Constitution

ARTICLE I. Name

This association shall be called The Alumni Association of the University of North Dakota.

ARTICLE II. Membership

Section 1—The membership of this Association shall consist of all graduates and former students and all persons who have received advanced or honorary degrees from the University.

Section 2—Members of the faculty and the Board of Higher Education are honorary members.

Section 3—Patrons and friends of the University who are interested in the advancement of education in North Dakota are eligible as associate members.

ARTICLE III. Officers

Section 1—The officers of the Association shall consist of a board of eighteen members elected to three year terms. At the annual meeting in 1958, eight members shall be elected of whom six shall be elected for a term of one year; thereafter at each annual meeting six members shall be elected for three year terms. A member may serve a maximum of three consecutive terms.

The Board of Directors shall elect from their number a president and two vice presidents. They shall also choose a general secretary of the Association. The business manager of the University shall be the treasurer of the Association and all moneys collected and disbursed are to be handled through his office.

Section 2—The Board of Directors shall have general charge of the business of the Association, shall authorize all disbursements and investments of funds not otherwise specifically appropriated, shall appoint the Alumni representative on the University Athletic Board of Control and any such other Alumni representative as may be necessary, and shall make a report at the regular annual meeting of the Association. The Board shall meet for transaction of business at the call of the President or by a petition signed by eight members and notice of such meeting shall be given to each member in writing.

ARTICLE IV. Duties of Officers

Section 1—The President and Vice President shall perform the usual duties of these officers, both for the Board of Directors and for the General Association.

Section 2—The Secretary shall keep a permanent record of the

proceedings of the Association and of the Board of Directors, shall act as the general agent of the Association under the control of the Board of Directors, performing such duties as may from time to time be prescribed, and shall render every service possible to the Association and for the welfare of the University. He shall receive such compensation for these services as the Board of Directors shall determine.

Section 3—The Treasurer shall keep all accounts of the Association, shall receive all moneys and deposits and disburse the same as prescribed by the Board of Directors and shall at each annual meeting make a report showing the exact condition of the finances of the Association, the amount of money received, the amount expended and for what purpose.

ARTICLE V. Meeting

The annual meeting of the Association shall be held at the University on Alumni Day, being the day preceding commencement, unless otherwise authorized by the Board of Directors.

ARTICLE VI. Quorum

Fifteen (15) members shall constitute a quorum in the Association and five (5) members a quorum in the Board of Directors.

ARTICLE VII. Dues

The dues of the Association shall be three dollars (\$3.00) per year. This includes subscription to the Review and the privilege to receive all general publications of the Association.

ARTICLE VIII. University Development Fund

Section 1—The University Development Fund is designated as the official agency for the solicitation of contributions for the maintenance of the Association and for the benefit of the University.

Section 2—No official solicitation for funds shall be conducted in the name of the Alumni Association, nor shall the records of the Association be used for fund raising without the authorization of the Board of Directors of the Association.

ARTICLE IX

Amendments to the constitution must be recommended by a majority vote of the Board of Directors and "Notice must be sent to each alumnus at least twenty days before the annual meeting." Notices of proposed changes to the constitution will be published in the Alumni Review or by letter to the alumni.

ARTICLE III. Officers

Section 1—The officers of the Association shall consist of a board of eighteen members elected to three-year terms. At the annual meeting in 1960, eight members shall be elected of whom six shall be elected for a term of one year; thereafter, at each annual meeting six members shall be elected for three-year terms. A member may serve a maximum of three consecutive terms.

The Board of Directors shall elect from their number a president and two vice presidents. They shall also choose an executive vice president who shall also be ex-officio secretary of the Board of Directors. The business manager of the University shall be the treasurer of the Association and all moneys collected

and disbursed are to be handled through his office.

Section 2—The Board of Directors shall have general charge of the business of the Association; shall authorize all disbursements and investments of funds not otherwise specifically appropriated; shall appoint the alumni representative on the University Athletic Board of Control and any such alumni representative as may be necessary and shall make a report at the regular annual meeting of the Association. The board shall meet for transaction of business at the call of the president or by a petition signed by eight members and notice of such meeting shall be given to each member in writing.

ARTICLE IV. Duties of Officers

Section 1—The president and vice presidents shall perform the usual duties of these officers, both for the Board of Directors and for the general association.

Section 2—The executive vice president shall act as the general agent of the corporation under the control of the Board of Directors, performing such duties as may from time to time be prescribed, and shall render every service possible to the corporation and for the welfare of the University. In his capacity as secretary to the Board of Directors, he shall keep a permanent record of the proceedings of the corporation and of the Board of Directors. He shall receive such compensation for these services as the Board of Directors shall determine.

Section 3—The treasurer shall keep all accounts of the corporation; shall receive all moneys and deposits and disburse the same as prescribed by the Board of Directors; and shall at each annual meeting make a report showing the exact condition of the finances of the corporation, the amount of money received, the amount expended, and for what purpose.

ARTICLE V. Meeting

The annual meeting of the corporation members shall be held at the University of North Dakota in either May or June of each year upon twenty days notice published in the Alumni Review. The Board of Directors shall meet at such times and places as it may specify, either within or without the State of North Dakota, as specified in Article III.

ARTICLE VI. Quorum

Fifteen (15) members shall constitute a quorum in the corporation and nine (9) members a quorum in the Board of Directors.

ARTICLE VII. University Development Fund

Section 1—The University Development Fund of the University of North Dakota Alumni Association is designated as the official agency for the solicitation of contributions for the benefit of the University, including public relations projects, scholarships, faculty awards, publishing the Alumni Review, student, faculty, and alumni promotion and general welfare projects of the University of North Dakota.

Section 2—No official solicitation for funds shall be conducted in the name of the Alumni Association, nor shall the records of the association be used for fund raising without the prior authorization of the Board of Directors of the Association.

Section 3—The board governing the University Development Fund shall be composed of the Board of Directors of the Alumni Association

of the University of North Dakota. The president of the University of North Dakota shall serve as an ex-officio member of the Budget Committee for the University Development Fund.

Section 4—The president of the Alumni Association of the University of North Dakota shall appoint and serve as chairman of a Budget Committee for the University Development Fund, which committee shall be composed of the following:

- President of the Alumni Association of the University of North Dakota
- President of the University of North Dakota
- A faculty representative from the University of North Dakota
- The executive vice president of the University of North Dakota Alumni Association
- Three members selected from the Board of Directors of the Alumni Association.

This committee shall prepare the annual budget for the consideration and approval of the Board of the University of North Dakota Alumni Association.

Section 5—The Executive Vice President: The executive vice president of the Alumni Association shall serve as the executive vice president of the University Development Fund.

Section 6—Duties of the Executive Vice President: The executive vice president of the University Development Fund shall be generally responsible for the carrying out of the plans and purposes of the Board of Directors as determined from time to time. He shall receive such compensation as the Board of Directors of the University Alumni Association shall determine. He shall be provided with such assistance in the carrying out of his duties as may be required by the volume of the work, and all appointments shall be subject to the approval of the Board of Directors of the University Alumni Association.

Section 7—The Treasurer: The business manager of the University of North Dakota shall be the treasurer of the University Development Fund.

Section 8—Compensation: All officers of the University Development Fund shall serve without compensation except the executive vice president, but shall be entitled to be reimbursed for traveling expenses incurred in connection with their official duties.

ARTICLE VIII

Amendments to the constitution must be recommended by a majority vote of the Board of Directors and "Notice must be sent to each alumnus at least twenty days before the annual meeting." Notices of proposed changes to the constitution will be published in the Alumni Review or by letter to the alumni.

New Plan Adopted

The University Summer Session for 1960 will include an 8-week session, June 13-Aug. 6, and two 4-week sessions June 13-July 8 and July 11-Aug. 6. The plan to have two shorter sessions running simultaneously with the regular Summer Session is new to UND.

●Proposed Constitution

ARTICLE I. Name

This corporation shall be known as the Alumni Association of the University of North Dakota. It shall be permissible to refer to it as the University of North Dakota Development Fund.

ARTICLE II. Membership

Section 1—The membership of this association shall consist of all graduates and former students and all persons who have received advanced or honorary degrees from the University.

Section 2—Members of the faculty and the Board of Higher Education are honorary members.

Section 3—Patrons and friends of the University who are interested in the advancement of education in North Dakota are eligible as associate members.
