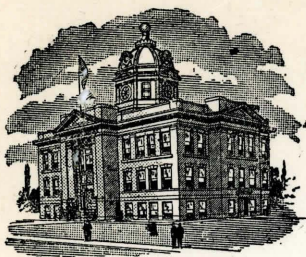

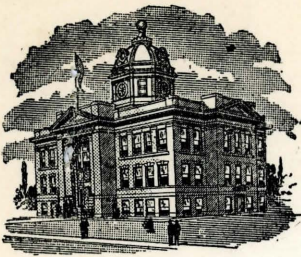
Friend Langer;
