Another Banner Year

600 Contributors Buy 'Share' in U Progress

Individual contributions to the University Development Fund by UND alumni and friends added up to another brilliant chapter in 1960.

In all, nearly 600 contributors added approximately \$60,000 to the fund during the past year.

This is exclusive of large contributions for buildings, scholarships or other specific purposes.

Dr. E. L. Grinnell, Alumni president, declared that the Alumni Association is proudest of all of this long list of faithful and generous supporters of their Alma Mater—with their individual contributions averaging out at about \$10 per person.

"This broad foundation on which the University bases its progress is its greatest insurance for continued success in all of its endeavors," Executive Vice President J. Lloyd Stone added.

SIoux HOCKEY PLAY-ers dropped a close 5-4 decision to the Russian National team in an international encounter at UND. The Russians later won 10-2 from Minnesota U and 8-3 from the U. S. National Team.

UND VARSITY CAGERS won their final contest preliminary to North Central Conference competition, downing Bemidji State, 85-73.

THE BUSINESS EDUCA-tion faculty, headed by Chairman John L. Rowe, attended the National Business Teachers' Association convention in Chicago. Thirty UND graduates held an alumni breakfast during the sessions.

APPROXIMATELY 165 students are scheduled to get degrees at Commencement Jan. 29—the largest mid-year class in UND history.
