Ny dear Mr. Commissioner:

Martin Cross, Chairman of the Three Affiliated Tribes, Fort Berthold Reservation, New Town, North Dakota, William Deane, member of the Turee Affiliated Tribes, and Q. R. Schulte, attorney for said tribes, met with the staff of the Commissioner of India n Affairs on April 25, 1956 relative to the implementation and practical application of the proposed legislation, S. 2151 and H. R. 10221.

The representatives of the Three Affiliated Tribes were very pleased with the meeting and now make request of the Commissioner for a written statement to be sent forthwith to Martin Cross, Chairman, New Town, North Datota covering the agenda of said meeting and affirming the opinion of the said representatives concerning the results of the meeting.

The following matters were discussed and the results arrived at were as follows:

1. That full cooperation would be exercised between the Three Affiliated Tribes and the Indian Bureau in expediting the practical application of the said bills.

2. That all means would be taken to transfer the money involved to the individual members as quickly as possible.

3. That the Bureau staff would take immediate steps in clearing the money involved for immediate payment upon passage of said cill, subject to the approval of the individual family plan.

L. That the Three Affiliated Tribes would commence the preparation of individual family plans immediately.

5. That said plans should contain provision for education, food, clothing, shelter, business or ranching plans and payment of delinquent indebtedness.

6. That upon passage of the bill the money would immediately be transferred to the individual Indian accounts, subject to the approval of the family plan before actual distribution.

7. That all delinquent indebtedness to the United States Government and individual delinquent indebtedness to the Three Affiliated Tribes must be paid before distribution to the individual and authorized deduction will be made at the local agency level.

8. That the processing of the individual family plans shall be handled speedily and efficiently with the purpose in mind to make immediate payment of the monies involved. It was felt that if the family plans were cleared at the local level payment would be forthcoming.

We would appreciate a prompt reply substantiating the informating contained herein.

Resolution No. 56-35

RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

WHEREAS, S. 1523, an Act to authorize enrolled members of the Three Affiliated Tribes of the Fort Berthold Reservation, North Dakota, to acquire trust interests in Tribal lands of the Reservation, and for other purposes, was introduced and passed in the United States Senate, and

WHEREAS, S. 1528 came on for hearing by the Sub-committee of Interior and Insular Affairs on April 25, 1956, and

WHEREAS, official delegates of the Three Affiliated Tribes of the Fort Berthold Reservation were asked to and did testify before said Committee in support of S. 1528, and

WHEREAS, as a result of said hearing, the sub-committee requested the Bureau of Indian Affairs, Department of Interior, to amend said Act to allow the individual Indian to purchase said lands from the Three Affillated Tribes in trust or patent fee at the discretion of the individual Tablen, and

WHEREAS, the said Bureau did amend said bill by deleting the word "Indian" from line 4, page 2 and adding the following language, "unless the Secretary determines that the Indian is competent to manage his own affairs, in which event unrestricted title shall be taken in themse of the Indian. Any trust created pursuant to this Act may be terminated by the conveyance of an unrestricted title whenever the Secretary decides that the trust is no longer needed for the protection of the Indian," and

WHEREAS, The Tribal Council has duly considered the said amendment and all its ramifications;

NOW THEREFORE, BE IT RESOLVED BY THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION, NEW TOWN, NORTH DAKOTA, That the said Tribal Business Council does not favor said amendment because it confers upon the Secretary unlimited authority to declare any Indian competent whenever he should desire; That it deprives the Tribal Council of the right to manage the sale of said lands to the members thereof; That said amendment goes beyond the scope of the original Act in that, even though the land is purchased in trust, the Secretary has the authority to terminate said trust, as well as other lands the Indian might own or hold in trust, whenever he should see fit; That passage of said Act as amended would desbroy the very purpose of the Act and seriously prevent and retard the complation of farming and ranching units.
