**Fund Soars Again**

**UND Development Contributions  
Reach \$131,361 Total in 1961**

Contributions to the University Development Fund by UND alumni and friends in 1961 topped 1960's record in two ways — first, in the total amount contributed and, second, in the number of persons contributing.

The year's gifts added up to \$131,361.06, given by a grand total of 685 contributors. The gifts came

from 42 states plus the District of Columbia, Canada, Panama Canal Zone, APO's and several other foreign countries.

Swelling the contributions this year were gifts of stocks and oil property presented by Franklin Lunding and Edward McDermott, both of Chicago, valued at \$91,456.00.

The average amount of

each individual contribution in 1961, excluding the oil properties, was \$58.42 per contributor.

The number of individual contributors was termed by Alumni President Robert Eddy of Jamestown and Executive Vice President J. Lloyd Stone "the backbone of the Alumni Association's great record of success."

"We cannot help but continue to succeed with so many of our alumni and friends maintaining a great interest in their Alma Mater," Stone said.

# U Willed Another \$1,000,000 Gift

A bequest of \$1,000,000 to the University for a fine arts center is included in the will of Edmund A. Hughes, a Bismarck electric power and telephone pioneer.

The gift is revealed in a biographical sketch of Hughes written by Dr. Robert P. Wilkins, UND professor of history, and published by the University Press.

The sketch was prepared for private circulation only, going to libraries and to friends and associates of Hughes, now a resident of Coral Gables, Florida.

The new million-dollar bequest will finance construction of an "Edward A. Hughes Fine Arts Building" on the campus. "Thus Ed's influence will carry on, serving generation after generation of young men and women from the state where he achieved his success," the biography says.

When received it will be the second gift of such size the University has been given for a new building. Earlier this year the Chester Fritz Library, built with a \$1,000,000 gift from Chester Fritz, a former student who is now an international investment banker, was dedicated.

Hughes was born at Elk Point, S. D., Oct. 24, 1873, and moved to Bismarck with his family five years later. His

father was a member of the territorial legislature and Hughes served as a state senator from Burleigh County in 1913 and 1915.

Hughes established Bismarck's first commercial electric generating plant in 1898, and before he sold the business in 1928, it included several generating plants and long-distance telephone service from Minot to Billings, Mont. The Hughes facilities have been acquired by Montana-Dakota Utilities Co. and Northwestern Bell Telephone Co.

As athletic activities at UND halted late in January for semester final examinations, the Sioux basketball team had demonstrated it was going to be a factor in the current North Central Conference race.

Coach Lou Bogan's outfit convincingly knocked off the league leader, South Dakota State, by a 90 to 60 margin in the Fieldhouse. Previously in loop games the Sioux cagers had split with Augustana, had defeated South Dakota U and had lost to S. D. State, 73-77, at Brookings.

In non-conference play UND had won decisions from Augsburg and Moorhead Teachers and had lost to the Phillips Oilers and Concordia.

The young Sioux hockey team dropped two close encounters to the strong Michigan Tech Huskies in the Winter Sports Building. Tech inched out the first victory, 2-1, and took the second in overtime, 3-2.

Previously the Sioux six had dropped 3 out of 4 to Denver, including a 5-4 overtime heartbreaker. Coach Barry Thorndycraft's men split two games with Michigan State, took a pair from Colorado College and dropped two to Michigan.

The big series with Minnesota U opens at Williams Arena in Minneapolis Feb. 9 and 10, and continues Feb. 23 and 24 at UND.
