Development Fund Marks Great Year

Founders Day Slated Feb. 27 on U Campus

Lawrence O. Aasen of San Francisco, a 1947 graduate of the University of North Dakota, will be the featured speaker at the annual Founders Day on the UND Campus, February 27.

Aasen is public relations director for the New York Life Insurance Company in the western states, and will speak at 6:30 p.m. at the Founders Day banquet in the Student Union Ballroom, with the general public invited.

Founders Day activities will start at 9:45 a.m., February 27, with the President's Convocation at the UND Fieldhouse. Dr. George W. Starcher, University president, will deliver his annual "state of the University" address.

Aasen will be introduced at the banquet ceremony by one of his former instructors, Alvin E. Austin, chairman of the journalism department. Henry G. Lee, associate professor of speech, will be master of ceremonies.

Included on the banquet program will be the University Bards, UND male chorus. A special recognition ceremony will be given R. D. Koppenhaver, chairman of the accounting department, who will be honored for 25 years of service to the University.

A native of Hillsboro, Aasen received a Ph.B. degree from UND in 1947, and an M.S. from Boston University in 1949. During World War II, he served in France with the airborne glider troops; in 1947-48, he was on the staff of the Agricultural Supply Co. in Grand Forks.

Aasen joined the New York Life Insurance Co. in New York in 1954, and has been in the western area of the United States since 1955.

He has been associated with national magazines, including Hunting and Fishing magazine in Boston and the McGraw-Hill Publishing Company in New York City.

Aasen has been president of the New York City and San Francisco UND alumni organizations. He is also a mem-

Award Mid-term Degrees at Exercises

Approximately 170 Students received degrees from the University of North Dakota at the mid-year commencement exercises on January 26, with Harold Shaft, Grand Forks attorney, giving the commencement address.

Shaft was awarded an honorary Doctor of Laws degree at the exercises. A 1922 law graduate of UND, Shaft has practiced law in Grand Forks for 29 years, and has been a

special lecturer in the UND Law School since 1940. He has served as legal advisor to the University for several years.

Father Robert Branconnier, director of the University Newman Foundation, gave the invocation and benediction, with the University band playing the processional and recessional. Dr. George W. Starcher, UND president, awarded the degrees.

Shaft was one of the planners of the State Medical Cen-

ter, helping to draft the laws creating the Center and has served for 10 years as representative of the public on the Medical Center Advisory Council.

Born in St. Paul, Shaft received his grade and high school education in Minot, and was associated in Fargo with late Congressman Usher L. Burdick. In Grand Forks, he was a law partner of the late Congressman Olger B. Burt-

It was more than 40 years ago in July of 1922 that Lawrence R. McCoy started his "one-man" wholesale lumber business with his wife, Dorothy, in Worcester, Mass.

When he founded his lumber operation in Worcester, it was McCoy's conviction that merchandising of lumber and lumber products at wholesale is a young man's forte. From

the very beginning, he attracted and hired young men—the abler the better.

The men in the Lawrence McCoy and Company organization have come by their knowledge of the lumber business by a planned training program, thanks to the foresight and wisdom of the founder.

Today, a McCoy trainee is introduced to a wide scope of learning. All phases of traffic, credits, communications and personnel become additional assets to his growing knowledge of wood.

As a result of Lawrence McCoy's conviction that youth is no hindrance and that youth can perform, the average age of the buying and sales staff of Lawrence R. McCoy and Company remains a young 41 years 3 months. The addition of able young men keeps the average age reasonably steady, despite the passage of time.

James W. Conners, 74, who served as a technician in the University of North Dakota chemistry department for 15 years and as program sales supervisor and concession assistant in the UND athletic department, died in Grand Forks Dec. 20.
