## U Alum Spends 25 Years Traveling Foreign Lands

One of the most traveled of all UND Alumni is Martin V. Linwell, who resides in Lima, Peru where he is in charge of that office for Geophysical Service, Inc., a firm engaged in oil exploration.

Linwell is the son of Mr. W. H. Linwell of Grand Forks, and is a native of Ray, North Dakota. He attended UND in the early 1930's where he was a member of Sigma Chi Fraternity.

For the past 25 years, he has been in many foreign lands, including Columbia, Brazil, West Africa and Canada. In 1949, he married Nazy Pinto, a Brazilian. They have three children, who attend

school in Lima, a city of one and one half million persons. The children are tri-lingual, speaking Spanish, English and Portuguese.

Linwell makes frequent trips throughout South America, and often uses the air-planes of "Linguistics", which he is permitted to use by special arrangement with the Institute of Linguistics.

He and his family spent ten days in North Dakota this past summer, visiting his father in Grand Forks, and his sister (Mrs. Al K. Simpson) in Fargo. Linwell expects to remain in Lima for an additional two year assignment.

**William Crane Nichols, M. D.**, passed away July 11, 1963. Dr. Nichols resided in Anaheim, Calif.

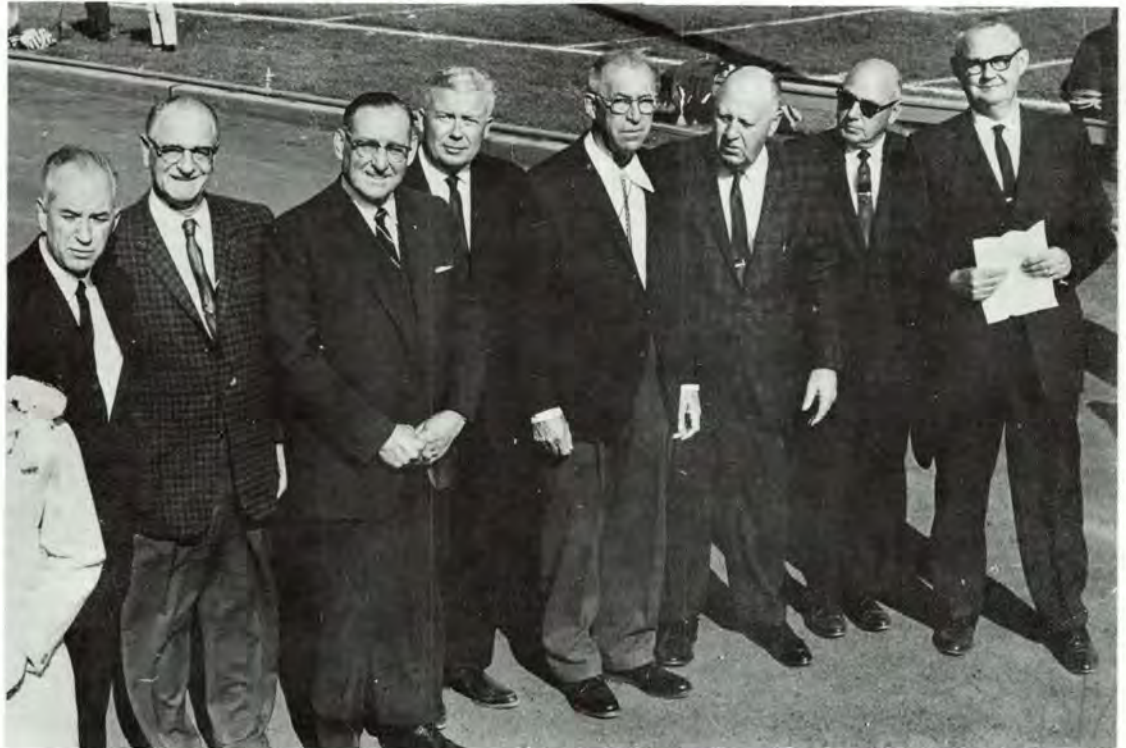

## Along the Sports Trail...

One of UND's finest football teams of the post-war era again is the bridesmaid instead of the bride in the North Central Conference—and a total of 11 points separates the Sioux from an undefeated season to boot.

Coach Marv Helling's Sioux opened the season with a resounding 33-0 victory over highly-touted Minnesota Duluth here. Then in the first conference game the Sioux sneaked by Augustana, 7-6, in a tough ball game.

The first road trip found the Sioux sweeping by Montana University, 19-13, before about 75 UND alums at Missoula. Returning home the Sioux mangled Morningside, 21-0.

Then came the first loss, 7-6, to the current conference leader, South Dakota State. Many observers feel the Sioux were deprived of a two-point conversion in this game played before 10,000 Homecoming fans in beautiful weather.

Next the Sioux hammered the Bison, 21-7, to spoil the AC Homecoming at Fargo. The Bison, with a five-man coaching staff, are improved and their supporters had been very vocal, which is unusual since the Sioux have now bludgeoned the hapless Bison 11 straight years. The Nickel Trophy is safely back here.

The next road trip resulted in a 9-0 loss to State College of Iowa (formerly Iowa Teachers) at Cedar Falls Oct. 26. Defense almost won it for the Sioux, who turned in their poorest offensive performance of the season.

Remaining road trips found the Sioux at Montana State in Bozeman and at the University of South Dakota Nov. 9.

Coach Helling and his assistants have done a marvelous job, under the direction of Athletic Director L. R. Marti.
