**UND Celebrates 81st Birthday:**

**Founders Day Speakers Outline Challenges**

**Hulteng Links  
Education  
And Journalism**

Dean John L. Hulteng of the University of Oregon School of Journalism reviewed the close relationship between journalism and teaching in his address at the Founders Day banquet on February 27 as the University of North Dakota observed its 81st birthday.

A native of Grand Forks and a UND graduate, Hulteng said there are two points of significant similarity between journalism and education. "In both fields, the sense of public service is or ought to be a powerful motivation. And the continued functioning of both the press and schools is essential to the preservation of the democratic society in which we live."

"The roll of the press, he continued, "in a democracy is to provide the people with the information they need in order to function as citizens in a representative system of government.

"The roll of education is to identify and sustain the central values and objectives that give significance to life, and to provide the opportunity for others to acquire understanding of these values and objectives."

Hulteng continued "We see evidence of taxpayers revolts in many states and in some a flat refusal to shoulder any further tax burdens in order to accommodate the student wave through yet another level of public education".

He touched on the dangers that face both journalism and education and said "We are witnessing a further growth of the anti-intellectual movement that developed first in the late '40's on a wave of fear about communism. This

**Starcher Tells  
Of Needs  
For Future**

"We believe we can have here on campus at one and the same time a quantity of quality with diversity". This is President George W. Starcher's phrase that was the keynote of his remarks at the Founders Day convocation on the 81st birthday of the University of North Dakota.

Dr. Starcher outlined the purpose of education, stressed the need of academic freedom, and told of the need of more classroom space at UND.

In a surprise ceremony, Dr. Starcher was presented with a birthday cake on which were ten large candles, each of which represented a year of his tenure as UND president.

In explaining a university, the president said: "A university, like a peak on the prairie, is something to look up to, a height that gives beauty, depth and meaning to the surrounding landscape. But for those who live somewhere along the slope, it is not easy to see the top of the mountain".

He said the sculpture which houses the eternal flame of knowledge now located at the site of Old Main symbolizes the torch of learning which Macnie, Blackburn, Merrifield and other great UND teachers of the past have handed down. He emphasized that there must always be a constant supply of new fuel for the torch.

Dr. Starcher said "the confusion about what a university really should be has been pretty well cleared up by now. We know there must be learning, but there must also be learning how to learn".

**UND Expands Its Services  
To the State and Nation**

In addition to carrying out its main teaching job, the University of North Dakota in 1964 will continue to extend numerous educational and research services to the people of North Dakota and the nation.

The demand for services in the fields of community development, military and adult education, geriatrics and services to professional groups and others that meet the cultural needs of people is increasing "in a geometric progression" according to Ben Gustafson, director of the UND Extension Division.

"The Spring semester will see the Extension Division operating non-credit undergraduate and graduate credit classes in 17 different centers," he said. Some will be in co-operation with the Universities of Minnesota, Manitoba and Montana.

In addition, there will be professional and vocational workshops and short courses in 15 separate academic and professional areas, as well as

academic service classes for trades training and statewide none-credit instruction in civil defense.

High school students are also being touched by the influence of the University long before they enter college. Last year, the Chester Fritz Library began offering library privileges to gifted high school students.

Superior secondary school students at the end of their junior year are now being allowed to take University courses for college credit during summer months, under a program begun by University College.

Late 1964 will also see educational television off the ground in North Dakota. The State Board of Higher Education has given the green light to a plan for joint operation of educational television by the University and North Dakota State at Fargo. Committees from both institutions are exploring types of programs to be offered and preparing ap-

## REPORT FROM THE CAMPUS

**What is a University?** This subject is discussed in a recent issue of the ALUMNI NEWS by Ed Haislet, executive director of the Alumni Association at the University of Minnesota.

We read his article with great interest and agree with his interpretation. Some people think a university is brick and mortar . . . some think of it as students, faculty and classes, and some think of a university as an expense—a huge budget, a per capita cost. Some see a university as place to send their children to gain a profession, some see a university as a custodian of the past. Some see a university as an adventure in new ideas—a place to lift the horizons.

Well, a university is all of these things. It is an idea, an opportunity, it is truth; it is beauty, it is light; it is freedom to learn, to think, to know, to equate, to understand, to write, to express and to create.

John Masefield, Poet Laureate of England, writes: "There are few earthly things more beautiful than a University. It is a place where those who hate ignorance strive to know; where those who perceive truth may strive to make others see; where seekers and learners alike, banded together in their search for knowledge, will honor thought in all its finer ways . . . there are few

earthly things more splendid than a University; wherever a University stands, it stands and shines; wherever it exists, the free minds of men, urged on to full and fair inquiry, may still bring wisdom into human affairs".

UND has been informed that a new chapter of Alpha Kappa Delta, national sociological honor society, will be established on our campus, and notice of this new honor society was received by Dr. Max Burchard, of the UND Dept. of Sociology.

**New Scholarship:** The Bismarck Tribune and its publisher, Alton G. Sorlie, have established a new scholarship in journalism at UND. It carries a stipend of \$150 and is available to a high school senior in the circulation area of the Bismarck Tribune who plans to major in journalism at UND.

**Plan Summer Guidance Institute:** UND, with NDSU of Fargo, will conduct a summer training institute for high school guidance counselors starting June 15 on the UND campus. The objective is to give high school counselors guided, practical experience so they will be better equipped to develop and improve their own school's counseling program.

**Gets National Recognition:** a course in "legislation" at the UND Law School has been cited in a national casebook as "an innovation in traditional methods of classroom instruction". The course is taught by James P. White, associate law professor, and he organizes his class into model legislative committees which proceed to do all of the work preliminary to the enactment of legislation. Hearings are conducted on proposed bills and testimony or written statements from witnesses.

**Enrollment:** the totals are still incomplete at this writing, but it appears that another new record has been established at UND. The second semester enrollment is 4770, 245 more than the final semester figure of last year. There are 3,217 men, and 1,553 women enrolled.

**Honor Faculty:** Three UND faculty members were honored at the Founders Day banquet. They are Dr. John L. Hundley, professor of physics; Dr. W. F. Potter, professor of physiology and pharmacology, and Miss Myrtle Pederson, associate professor of English. Miss Pederson has served on the

UND faculty for 25 years, while Dr. Hundley and Dr. Potter are retiring at the end of the academic year.

**Honor Students:** slightly more than 15 percent of the 1100 freshman students at UND last semester have been named to the Dean's List in the University College freshman division. The list includes 167 freshmen who attained an average of B or higher.

**Korean Folk Musicians:** a company called the Sahm-Chun-Li Dancers and Musicians performed Korean folk dances as ancient as 1286 B. C. as a featured presentation of the UND Convocation Series in February.

**Spring Art Exhibition:** the eighth annual North Dakota exhibition of art will be held on the UND campus from April 19 to 30, sponsored by the UND Art Department. Prizes in excess of \$1,200 will be awarded at the exhibition.

**Orient Tour:** as you receive this issue of the ALUMNI REVIEW, seventy-seven UND Alumni and friends will be somewhere in the Far East on the 22-day tour of the Orient, returning to Seattle on March 20. The arrangements for the tour are being handled by Armin Rohde, assisted by Jerome Dunlevy and Tom McElroy, all of Grand Forks.

Several "bon voyage" parties were held for the group, including one at Fort Lawton Officers Club on the eve of departure. The group meets in Tokyo with embassy officials, as well as in Hong Kong with consulate officials and wives.

While in Honolulu, the UNDers will be guests at the home of Dr. Min Hin Li, UND graduate, while the UND Alumni group in Hawaii also entertained the travelers at the Lau Yee Chai Restaurant in Honolulu.

I'm happy to report that a registration fee will go to the Alumni Association for handling arrangements, and that this fund will be approximately \$3,000. It will be transferred to the UND Development Fund for scholarship. This tour is the third such sponsored by the Alumni Association, with previous trips to Hawaii in 1960 and to Europe in 1961.

**Fellowships:** under a grant from the Newspaper Fund of the Wall Street Journal, the journalism department at UND will award 15 all-expense paid fellowships to the Newspaper Fund Workshop for high school journalism teachers, set next June on campus.

**Scholarships:** James Eissing-er of Wishek has received the first annual Brink and Sobolik \$200 law scholarship at UND, which was announced in the last issue of the ALUMNI REVIEW. Partners in a law firm at Hallock, Minn. Brink is a 1934 UND law school graduate, while Sobolik was graduated in 1959. The D. Bruce McDonald-Phi Delta Theta Scholarship for the current school year has been awarded to Douglas A. Hallatt of Brandon, Manitoba. Established in December, the scholarship carries a \$200 stipend and is awarded on the basis of need, leadership qualities and scholastic ability.

**Enrollment Doubles:** Several revisions in the industrial arts department at UND are being made, with the enrollment doubling over the past two years. Changes include a course in plastics, and the addition of a minor in technical drawing to the curriculum.

**Honor U Engineering Professor:** Donald P. Naismith, associate professor of mechanical engineering at UND, has been awarded the certificate of recognition for outstanding service to the society and community for the promotion of engineering during the past year.

## Massachusetts Alumni Appoint Executive Board

An executive board of UND alumni has been appointed from the group that met last November in Plymouth, Mass. The board consists of **Coleman J. Barry, '48, Dedham; Russ Ireland, '42, Plymouth; Joseph Junger, '39, Concord; Lincoln C. Klabo, '59, Boston; and David W. Leckart, '35, Brockton.** The executive board will plan future alumni activities in the Massachusetts area.

Julie Moore, a graduate student and part-time instructor at UND, is one of the nation's top candidates for the U. S. Olympic fencing team which will be selected in July.

Miss Moore, who took up the sport just two and one half years ago, has qualified high in preliminary tryouts and finished first in the foil fencing division in a recent competition in Milwaukee.

plications for a license and a federal grant.

In educational radio, UND already is reaching all corners of the state. The UND music department, in cooperation with the UND Broadcasting Service and through radio stations at Williston, Bismarck and Dickinson, is presenting weekly broadcasts of musical experience for more than 900 classes in elementary schools.

The Law School also is taking an interest in providing leadership service to the state. The agricultural law research program, in conjunction with North Dakota State, is engaged in studies of legal techniques in successful farm management. And under consideration for the early summer is an institute for Indian Tribal judges from reservations throughout the states of North Dakota, Minnesota, Montana, Wyoming and South Dakota.

The engineering department is also working on research projects beneficial to North Dakota. One such project is investigation into the field of soil stabilization for highways, which may improve the highways and simultaneously decrease costs to North Dakota. The Public Health Department is sponsoring investigation aimed at achieving more efficient sewage disposal systems.

tention to UND's increased enrollment, which topped 5,000 the first semester, and stated "First, we had to have a place for students to live" and reviewed the construction of new dormitories on the campus.

Other needs of the University, as pointed out by Dr. Starcher, include an adequate health center, a place for good programs of physical education and recreation for women, a law school building, and a museum and center for the training of science teachers.

### More Funds Needed

Dr. Starcher said: "The American dream of higher education freely accessible to all is not yet realized, and it cannot be until adequate classrooms, gymnasiums, playing fields and operating budgets are provided. Tell our legislators in Washington we need more loan funds. At the same

tems. Engineering research is also underway to find new uses for lignite.

The geology department is studying microscopic fossils found in North Dakota earth formation and doing research with salt in the Williston Basin, including studies with cores and geochemistry.

The Geological Survey does surface mapping, conducts studies of the subsurface in samples taken at oil drilling sites and conducts ceramic research and work on underground water work and geophysical exploration.

The purpose of the survey is to investigate the natural resources of the state and to bring them to the attention of the public through published reports.

The trend toward increased research and research training is also continuing in the medical school, according to Dean T. H. Harwood.

The number and size of research grants continues to grow. "The current total for the year Sept. 1, 1963, to Aug. 30, 1964, is \$499,913.00" Dr. Harwood said.

These include research grants, instrument grants, fellowships for students, salary grants for teachers and research, as well as two undergraduate training grants, one for cancer and one for heart study.
