Nomadic Alumni Return from Orient

The year of 1964 will remain one of very fond memories for 77 UND Alumni and friends who shared a 24-day tour of excitement, sight seeing and adventure as members of the UND Orient Tour.

It would take an entire issue of the ALUMNI REVIEW to share all the experiences of this long journey which started in Seattle on February 26, with a "bon voyage" party.

Seventy-seven UNDers gathered from the USA and Canada in Seattle, and the "bon voyage" party was a perfect send-off, with a crowd of 160 gathered to wish them a pleasant trip. Richard Rouzie, a brother of Grace Stone, is an engineer with the Boeing Company, and he briefed the travelers on the Boeing 707 plane that would soon start them on their Far Eastern adventure.

The first leg of the journey brought the group to Anchorage, and then on to Tokyo, with arrival in the early hours of the morning. The home base for the group was the famous Okura Hotel in Tokyo, considered one of the finest hotels in the world. Accommodations were superb, and the staff was extremely friendly, courteous and helpful.

Tour Tokyo

During the days in Tokyo, the UND Tour Group saw many wonders of this largest city in the world. There were exciting sights like the Imperial Palace Plaza, Meiji Shrine Outer Gardens, the Diet Building, Tokyo University, Asakusa Amusement Center with the popular Kannon Temple, and Nihonbashi, the heart of Tokyo's Shopping District.

The group took the electric

express to visit Nikko, where some of the most beautiful scenery in Japan was viewed, including the Tochogu Shrine, the famed Yomeimon Gate, Lake Chuzenji, Kannon Temple and Kegon Falls.

It was quite evident that the people of Japan are eagerly awaiting the Olympics that will start next fall, and are already making extensive preparations including the building of a Mono-rail and other attractions for the thousands that are expected to visit the Olympics from all over the world.

From Tokyo, the Nomadic Nodaks visited Fuji-Hakone National Park, Atami, Yokohama, Kyoto, and Nara Osaka.

Ambassador Hosts Group

It was with regrets that the group said "farewell" to Japan, with the friendly atmosphere making everyone feel as

truly honored guests. The U.S. Ambassador, Mr. Reischauer, invited the entire group of 77 to his home, and gave a "briefing" on many of the things that have happened in Japan since World War II.

(Upon returning home, the tour group learned of the stabbing of Ambassador Reischauer, and were saddened to hear of the incident, but pleased that his injury was not extremely serious).

Leaving Japan, the flying Sioux group went by jet to Hong Kong, the international cross-roads of the world, with a blending of oriental and western cultures. As in Tokyo, there were extensive tours of the city and its sights, high lighted with a trip to the border of Red China, where they viewed this Communist land.

Report From the Campus

Upcoming Events — It will be a busy spring on the UND campus for the final eight weeks of the second semester. Some of the events will include Mothers Day Weekend, April 11-12; Fine Arts Festival, April 17-May 16; Honors Day Convocation, April 21; Northern Interscholastic Press Assn., Convention, April 27-28; Baccalaureate and Commencement, May 31. We hope you will be able to return to the campus and enjoy any or all of these events.

Establish Historical Society—More than 40 persons from North Dakota, Minnesota and Manitoba attended an organizational meeting of the Red River Historical Society. Glenn Smith of the UND faculty is treasurer of the new group, which is organized to collect and preserve historical data on the Red River Valley.

Visiting Scholar Program — Morris Bishop, who is a poet, biographer and humorist, will be on the UND Campus on April 24, as part of the Visiting Scholar Program of Phi Beta Kappa, honorary scholastic society. Bishop, who retired in 1960 from Cornell University, will give a public lecture in Abbott Hall auditorium, and meet informally with students and faculty.

Plan New Fraternity House — Lambda Chi Alpha will be building a new fraternity house this year in the 500 block on Harvard Street, with completion slated by December. The University purchased the fraternity's present building on Oxford street, with the site to be used for a dormitory.

Chemists Probe Research Areas—UND chemists are exploring the frontiers of science at a rate unexcelled in the department history. With a record enrollment of 900 undergraduate and 20 graduate students, the Chemistry department boasts of a faculty made up entirely of Ph.D.'s. Perhaps one of the best barometers is the number of papers submitted for publication in professional journals. In the past year, 18 scientific papers contributed by UND chemistry faculty have been published or accepted for publication by reputable scientific journals. During the past year, research grants awarded UND

chemists totaled about \$100,000.

Among the Faculty—Robert A. Nelson, chairman of the UND art department, has received a Tamarind Lithography Workshop grant for a six-weeks seminar this summer in Indianapolis. The purpose of the workshop is to bring some of the nation's outstanding painters, printmakers and sculptors together where there can be a "collision between European techniques and American inventiveness". Nelson has had his work exhibited in New York, Boston, Chicago, Philadelphia, Denver, Washington, D. C., and Minneapolis, as well as in Spain and Canada.

Dr. Paul B. Kannowski chairman of the UND biology department, was in Washington, D. C., recently where he visited with officials of the National Science Foundation regarding teaching and research projects in biology at UND.

J. Donald Henderson, director of the Academic Year Institute for High School Teachers of Science and Mathematics at UND, attended the annual meeting of the Science and Mathematics association in Chicago.

Miss Valborg Oslund, assistant professor of English at UND, has been invited to serve on Governor William Guy's commission on the "Status of Women". The Governor recommended that the commission should help in focusing attention on women's achievements and problems.

Wins in National Competition

James W. Clarke of Ellendale, a senior music major at UND, has been accorded an Honorable Mention Award in the 1964-65 Woodrow Wilson National Fellowship Foundation competition. Clarke was nominated by UND faculty members and screened carefully by regional and national selection committees of college professors, deans and presidents.

To Travel Abroad

Three UND students have been chosen as community ambassadors to travel abroad this summer as part of the Experiment in International Living. They are Richard Barton, Valley City; Barbara Robert-

son, Grand Forks, and Patricia Gronowski, Mandan.

Honor UND Professors — O. M. Hager, state director of Business and Distributive Education and associate professor at UND, received a plaque at the associations recent conference in Williston. He was recognized for his leadership in the Distributive Education field. Others honored at the conference were Leonard Havig, Williston school superintendent, Thomas J. Clifford, dean of the UND College of Business and Public Administration, and Ben G. Gustafson, director of the UND General Extension Division.

From Hong Kong, the UND Orient Tour started the long trip home, and basked for several days in the wonderful state of Hawaii. Dr. Min Hin Li and other Alumni of the Honolulu area entertained the visitors at many get-togethers, and it was there that we found hospitality at its finest.

All of the travelers were sad to see the 24 days of the tour end in Seattle, and they returned to their homes, bringing never-forgotten memories, sun-tans and experiences that will be unforgettable.

First Alumni Group

Mr. John Lacey, who is the U. S. Consulate General in Hong Kong, gave a briefing to the UND Tour Group, and stated that he thought this was the first university alumni group to ever visit the orient, and hoped that there would be other college and university alumni groups that would make similar tours. He stated that it would be a fine way to get better acquainted with the Orient and with their customs and people, and would do much to promote greater understanding.

UND Engineers' Fair Scheduled May 8-9

The 1964 University of North Dakota Engineers Fair, featuring one of the nation's astronaut candidates and a variety of science exhibits will be May 8 and 9, announced Palmer J. Reiten, chairman of the UND mechanical engineering department.

Two addresses by Major Donald M. Sorlie, chief of Manned Spacecraft Operations Division, Edwards Air Force Base, Calif., will highlight the two days of exhibits, banquets, demonstrations and tours of the UND engineering laboratories and classrooms.

The purpose of the annual event is to acquaint the public with the field of engineering and to honor high aptitude engineering and science senior high school students who are contemplating an engineering or science career.

Exhibits will be in categories of professional engineering provided by industrial firms, top exhibits by North Dakota high school science students and displays built by the UND engineering departments.

This year's fair will be of

special interest to high school students, said Reiten. Invitations are being extended to top high school science students in each county. They will receive recognition at a special banquet.
