Upson Establishes \$100,000 Fund For Lectureships

It's Homecoming!

Record Alumni Crowd Expected For Reunion October 15-16-17

A gift of \$100,000 from alumnus Maxwell M. Upson for establishing a series of lectureships was announced at the University of North Dakota. Upson, who lives in New York, is a retired construction engineer. Dr. George W. Starcher, University president, announced the gift at the first general faculty meeting of the 1964-65 school year.

The purpose of the lectureships, said Dr. Starcher, is to bring to the campus outstanding lecturers who will spend a day or perhaps a week lecturing to faculty and student groups. "The lectures will be designed to help make clear the American heritage of free enterprise which has made this country great," said the president.

More than \$4,000 from the trust will become available each year to pay travel expenses, honoraria and publication expenses of distinguished speakers. An Upson Lectureship Committee composed of faculty and administrators will select the lecturers.

"Mr. Upson has for years been generous with his time

Six UND Alumni Named For Sioux Award Honors

Six University of North Dakota alumni will be honored with Sioux awards from the UND Alumni Association during Homecoming activities this fall.

One, the late Lt. Col. Grant N. Nelson, Roswell, N. Mex., will be honored posthumously. Homecoming is scheduled Oct. 16-17. With two exceptions, the awards will be presented at halftime ceremonies during the Homecoming football game Oct. 17.

Announcement of the awards was made by Gordon Caldis of Grand Forks, chairman of the Alumni Association citations committee. The awards, presented to six alumni for the first time at the 1963 Homecoming, are given as recognition for the achieve-

ments of the former students and their loyalty to the University.

Group Listed

In addition to Col. Nelson, alumni to be honored are Thomas C. Barger, Dhahran, Saudi Arabia; Bruce E. McArthur, Canfield, Ohio; B. Fred Davidson, Minneapolis; Mel Ruder, Columbia Falls, Mont.; and Dr. O. W. Johnson, Rugby.

Col. Nelson, a 1925 UND graduate, died Jan. 14 of this year at Roswell, where he was assistant professor of chemistry and chief of the visual aids department at the New Mexico Military Institute. While at UND he won honors as a football player. His wife will accept the Sioux award for him

It's Homecoming!

These two words sum up the big news on the UND campus, with a record-breaking crowd of Alumni and University friends expected for the October 15-16-17 annual reunion.

A summary of the Homecoming Time-Table of Events is listed in this issue of the ALUMNI REVIEW. Highlight of the activities will be the dedication of the newly-completed University Center with ceremonies at 3 p.m., October 16. Tours of the building will be held throughout the Homecoming week-end.

The University Center is more than twice the size of the Memorial Student Union, which it replaces. The \$1.2 million addition was built into the east wall of the original building, which has been completely remodeled.

The new structure is designed for a University of 7,000 students, about 1500 more than the expected fall enrollment. Financing for the addition and remodeling project is through self-liquidating bonds, to be paid off through student service fees.

Barger is president and chief executive officer of the Arabian American Oil Co. He began working in the oil industry in Saudi Arabia in 1938. From 1941 to 1956 he was in charge of relations with the local government for the oil company and since 1956 he has served in administrative posts. He is a 1931 graduate of the University.

McArthur is with the Ajax Magnethermic Corp. of Canfield, manufacturers of induction heating and melting equipment. He started his career with that corporation in 1951 and is now senior vice-president and heads the company's technical operations and is secretary and a member of its board of directors. The 1939 UND graduate is also on the board of directors of Elumin Corporation of Stow, Ohio.

Davidson began his career with Gamble-Skogmo, Inc., at Minneapolis shortly after his graduation from UND in 1927. He is serving in a corporate administrator capacity with that company.

He is vice-president, treasurer and director of Founders, Inc.; a director of Cussins and Fearn Co., Inc.; assistant secretary and director of Macleod's Limited, a Gamble-Skogmo subsidiary; director of Marshall Wells of Canada; Stedman Bros. Ltd.; serves on the board of a number of other Gamble affiliated companies; is a trustee of the B. C.

Gamble Foundation; secretary, treasurer and a member of the board of trustees for the P. W. Skogmo Foundation; co-trustee of the Gamble-Skogmo Profit Sharing Trust; and is a director of the Third Northwestern National Bank of Minneapolis.

Ruder '37 Graduate

Ruder was graduated from the University in 1937 with a B.A. degree and in 1942 with an M.A. He is editor and publisher of the Hungry Horse News of Columbia Falls, Mont., a 12-time winner of National Editorial Association awards. Ruder was editor of the University News Service, 1938-40, and assistant professor of journalism in 1940-41. He was president of the Montana State Press Association in 1957-58 and is currently on the executive board. He is a member of the Columbia Falls School Board.

Dr. Johnson received his bachelor's degree from the University in 1927 and is presently with the Johnson Clinic in Rugby. He is active in and a member of 10 medical associations. He is past president of the North Dakota State Medical Association, a past member of the Board of State Medical Examiners, past director of the Mental Health Association for North Dakota and is a member of the board of directors of the North Dakota State Heart Association, a member of the board of directors of the National American Cancer Society and president of the North Dakota division of the American Cancer Society. He served as University Alumni Association vice - president from mid-1961 to mid-1963.

Engineering Scholarships Recently Awarded to 7 University Students

Seven University of North Dakota students in engineering were recently awarded scholarships. Six freshmen received \$240 North Dakota Foundation for Engineering and Science Scholarships while a junior, Robert Tovsrud, Leeds, received the first annual \$240 John B. Jardine Civil Engineering Scholarship.

Recipients of the Foundation Scholarships were Arlon Steinolfson, Mountain; Leon Fetter, Reynolds; Robert Rhine, Rugby; Randall Rohman, Hillsboro; William Stephan, Valley City; and Gordon Zarep, Williston.

The North Dakota Foundation for Engineering and Science is composed of the North Dakota Associated General Constructors, the North Dakota Society of Professional Engineers and the North Dakota

Academy of Science.

Presenting the scholarships were Lloyde Richmond, Grand Forks, president of the North Dakota Society of Professional Engineers; G. W. McCoy, Bismarck, manager of Associate General Contractors; and Walter Swingen, Grand Forks, president of the Foundation for Engineering and Science.

The six Foundation scholarships and the Jardine scholarship are seven of 10 awarded in the state by the Foundation this year. The Jardine scholarship was named after John B. Jardine, a 1937 UND graduate, who died last October at the age of 49. He operated the Concrete Sectional Culvert Co., and the Jardine bridge firm and was associated as an engineer with the companies since 1938. He resided in Fargo at the time of his death.

and money in supporting a variety of University programs," said Dr. Starcher. "This gift is a recognition of the nobility of the research for truth and the value of education. In addition to reflecting the donor's accomplishments, the gift will advance and perpetuate his interests and ideals."

In 1958 Upson donated the largest scholarship fund ever received by the University. The trust fund he established provides 16 scholarships of \$500 each for outstanding UND students every year. The trust fund totals more than \$200,000 and provides \$8,000 a year in perpetuity.

"The University of North Dakota has been called the University of Outstanding Alumni. Mr. Upson's gift of \$100,000 for a series of lectureships is one of the major reasons why the University has established this reputation for alumni loyalty, and we are very proud", stated Dr. Otis Simenstad, president of the UND Alumni Association and Development Fund.

Upson spent his youthful days on a farm near Cummings, N. D., later going to the University. His achievements in the field of concrete engineering were closely related with the growth of Raymond International Inc., in which he served for many years as chief engineer, general manager, president, and chairman of the board. He is currently director and honorary chairman of the board.

Born in Milwaukee, Upson received a Bachelor of Arts degree from UND in 1896, a Mechanical Engineering degree from Cornell University in 1899, and an honorary Doctor of Engineering degree from UND in 1931, when he delivered the June commencement address on the subject "Humanics."

In 1957 the UND Alumni Association awarded Upson a Distinguished Service Citation for "distinguished achieve-

ments as a construction engineer, inventor, administrator and humanitarian." A formal portrait of Upson was unveiled on the campus in 1960 and now hangs in the Chester Fritz Library.

Early in his career he was employed by Westinghouse, Church, Kerr and Co., at that time one of the largest engineering and contracting firms in the United States. Beginning as a field superintendent he early became one of the managing engineers and directed the planning and construction of many power houses, including the design and construction of a group of reinforced concrete buildings for Canadian Westinghouse in Hamilton, Ont. This was the first industrial plant entirely built out of reinforced concrete in the world.

While serving as chief engineer of the Hockanum Mills Company in Rockville, Conn., 1905-1907, he designed and supervised the construction of the first reinforced concrete textile building in the United States. Prior to that, engineers had considered concrete unsuitable for this service because of the loom vibration.

In 1925 Upson was elected a trustee of Cornell University. He served in this capacity for 35 years. Among his contributions to Cornell is a mechanical engineering building named Upson Hall.

Squires Hall Dedication Honors Late UND Dean

Dedication of a new four story dormitory as Squires Hall will be made during the Homecoming week-end, with six of the seven surviving members of the family of the late Vernon P. Squires, who was dean of the College of Science, Literature and Arts at UND for 16 years, planning to attend the ceremonies.

The structure, which houses 248 students and was occupied in February, will be dedicated at 1:30 p.m. Oct. 16 during Homecoming festivities. Dedication ceremonies will take place in the recreation room of Squires Hall, according to Dr. Gerald F. Hamerlik, chairman of the Squires Hall dedication Committee.

Mrs. Ethel Squires, wife of the late Dean Squires will be among the members of the Squires family at the dedication. She resides in Evanston, Ill. Mrs. Squires received a diploma from UND in 1901.

Squires was instrumental in inaugurating Founder's Day observances at UND, was the first chairman of the Convocation Committee, helped bring Phi Beta Kappa to the University, and was a leader in obtaining for UND an appropriation from the 1927 State Legislature for building the Liberal Arts Building, now known as Merrifield Hall.

Two daughters of the late dean, Emily, now Mrs. Bert Harry Wabeke and a resident of Washington, D. C., and Hope, now Mrs. R. E. Beam and living in Evanston, will also be present. Their husbands will not be able to attend. Emily is a 1928 UND graduate and Hope received a degree from UND in 1937.

Three sons of the dean, Dr. J. Duane, Vernon C. and Dr. Alden W., plan to come to Grand Forks. Duane, who will be the main speaker at the dedication, is chairman of the social studies department and history professor at Colby Junior College, New London, N. H. He was graduated from the University with a B.A. in 1925. Vernon, a 1931 graduate, is presently employed as an architectural engineer with the Goodrich Tire Co., Akron, Ohio. Alden is a medical doctor with the Veterans Administration Center in Togus, Maine. He received a B.A. de-

An All-Time Record!

UND Enrollment Zooms Over 5,600 Mark

Registration for the fall semester at UND has hit an all-time record enrollment of more than 5600, and is expected to approach the 5700 figure by the time that final totals are compiled, according to Miss Ruby M. McKenzie, registrar.

University College, UND's freshman division, had the biggest jump, from 1,168 last

year to 1,427 this fall, an increase of 22 per cent. The Graduate School followed with a 13 per cent rise, from 537 to 609.

Of the students enrolled, 1,858 are women and 3,759 are men.

The enrollment increase this fall is from 3 to 4 times as much as the increase in new faculty positions, Dr. William

E. Koenker, vice-president for academic affairs, noted. While student enrollment has risen 9 per cent over last fall, faculty positions have increased only 2½ per cent, he said. Only six new positions were established this fall.

Enrollment by major University division thus far this fall (compared to last fall's final figures) includes: Uni-

versity College 1,427 (1,168); Science Literature and Arts, 1,115 (1,059); Education, 792 (762); Business and Public Administration, 683 (620); Graduate School, 609 (537); Engineering, 338 (365); Williston Center, 179 (198); Law, 156 (148); Nursing, 139 (125); Medicine, 80 (85); special and unclassified, 52 (77); St. Joseph Nursing, 47 (57).

A stadium-packed crowd of 10,000 is expected to witness the 1:30 p.m. kickoff in the traditional Homecoming football game on October 17 when the UND Sioux meet the NDSU Bison.

Both squads are rated high in early season predictions for the North Central Conference, and both UND and NDSU won "warmup" games prior to the start of conference play.

The Sioux and Bison have

a high percentage of veteran players on their squads, with lines that average well over 200 lbs. Although UND has dominated play with NDSU for the past several seasons, the Bison have expanded their coaching staff and attracted some of the top football talent in the Upper Midwest.

It shapes up as a tremendous battle, and with the Nickel Trophy at stake, anything can happen, and probably will.

Construction Launched On Richards Golf Course

Work on a new golf course at the University of North Dakota has begun southwest of the campus on land donated for that purpose by alumnus Raymond Richards of Tulsa, Okla.

The course will be called the Ray Richards Golf Course and will occupy the old Richards' homesite. It was purchased by Richards' father in 1888 and has been owned by the family since. Raymond was graduated from UND in 1906.

Construction of a new baseball field for UND is nearing completion. The field is located in an area formerly occupied by the old Grand Forks Airport.

A house on the site will be converted to a clubhouse with a permanent caretaker. Land just east of the house will be cleared for a parking lot. The area south of the house will be turned into a 150 yard driving range for about 50 golfers.

The 9-hole course stretching about 250 yards is scheduled for completion in 1960, according to L. R. Marti, UND athletic director.
