Horace Greeley Was Right? Building Expansion Moves Westward

Westward expansion—across the English Coulee—is becoming a common occurrence in the University of North Dakota's building program.

Growing pains produced by an increasing enrollment, which hit a record 5,726 this fall, has forced the University to build west of the campus across the Coulee, formerly considered the "western boundary" of the UND campus.

The big changes on the UND campus map are being caused by an enrollment which has doubled since 1954 and is expected to almost double again in the next 10 years.

John C. West Hall, the first of a proposed six-dormitory complex west of the Coulee, was occupied in September, while two other units are under construction. These two units, known as McVey Hall and Building 83, are both residence halls and are scheduled for occupancy in the fall of 1965. Additional housing for married students is also planned for the nearby area, which is already the main concentration of married housing. The University will call for bids to be opened in December for four new eight-plexes to be ready for occupancy in the fall of 1965. The new eightplexes will be located directly west of the present eightplexes.

Demolition Slated

While workmen are constructing the new buildings, demolition crews will be tearing down three structures long a part of the campus skyline. They are Davis, Macnie and Budge halls, built in 1887, 1907 and 1899 respectively. All are dormitories.

A year ago the State Board of Higher Education ruled that the three old buildings be torn down within five years, declaring them fire hazards and unsafe for student occupancy. University officials report that Davis is scheduled to be demolished this summer, Macnie this summer or a year later, and Budge in the summer of 1966.


One UND official recently reported that although UND dormitory spaces have in-creased 300 per cent in the past 10 years, the number of classrooms and laboratories for students has increased less than 15 per cent for the same period. The only building now under construction which will help alleviate the classroom shortage is the geology building, Leonard Hall, which is expected to be occupied for the second semester. Leonard Hall will contain classrooms, laboratories and offices for the geology department, as well as offices for the North Dakota Geological Survey.

Need Classrooms

The request for buildings submitted to the 1965 Legislature emphasizes classroom buildings. The State Board of Higher Education has approved for submission to the State Budget Board requests for a business-public administration classroom building, \$2 million; engineering classroom building, \$1 million; women's physical education building, \$900,000; industrial arts building and equipment, \$380,000; and service building, \$350,000.

Also approved by the Board are requests for \$4.5 million for self-liquidating buildings, including dormitories, married student housing and a food service building, and \$1.3 million in major plant improvements and repairs, including remodeling of Montgomery Hall, the old library, to better facilitate instructional purposes.

Also a part of the UND building request to the legislature, but rejected by the Board, are a physics building, \$1.2 million; nursing and health service building, \$350,-000, and law building, \$700,-000.

UND Students Come From Everywhere

Students from every North Dakota county and 45 additional states are represented in the University of North Dakota student enrollment.

Latest figures for the first semester of the 1964-65 school year show 3,878 (68 per cent) of the total 5,726 enrollment are students from North Dakota. Of the remainder, Minnesota, with 692 students (12 per cent) leads the enrollment by states. The only states not represented are Delaware, Maine, Nevada and Vermont.

Students from outside the United States number 376 with 312 coming from Canada.

Grand Forks county has the most students attending UND with 1,112. Ranking next in total enrollments are Cass, 199; Walsh, 192; Burleigh, 188; Ward, 186; Pembina, 160, and Williams, 132. Included in the large Grand Forks county enroilment are students who originally came from other parts of North Dakota or the United States but have established residence at Grand Forks while attending the University.

Students from foreign countries other than Canada are from Iraq, Kuwait, Kenya, Germany, India, Singapore, Philippines, Taiwan, Columbia, Greece, Puerto Rico, Chile, Spain, British Guinea, Hong Kong, Korea, Pakistan, Turkey, Sweden and Iran.

Stone Presides At Council Sessions

J. Lloyd Stone, executive vice president of the UND Alumni Association, presided at a District Six meeting of the American Alumni Council in Topeka, Kansas during December.

Stone is chairman of the District Six alumni program, and headed an Alumni Problem clinic. Hyslop Makes \$8,000 Gift To Development Fund

W. Kenneth Hyslop, a 1906 graduate of the University of North Dakota and a native of Inkster, has given \$8,000 to the University Development Fund, announced J. Lloyd Stone, executive vice-president of the UND Alumni Association.

Hyslop now lives at Racine, Wis., where he has been re-

tired since 1950. He is a former chairman of the board of Massey-Harris Machinery Company. He was also European general manager of the firm.

Hyslop's gift brings the 1964 Development Fund to more than \$25,000 Stone said. The goal for this year is \$74,000, to be raised by alumni in all 50 states.
