Reservations Urged for Alumni European Tour

Reservations are coming in briskly at the ALUMNI office for the UND Alumni Tour to Europe which is scheduled to start on Wednesday, May 5.

The escorted tour begins with departure from New York City and concludes on May 26. The tour supervisor is Dr. Arne Brekke, UND assistant professor of German and Norwegian, working in conjunction with the Cham-peau Travel Service of Grand Forks.

Tour officials urge prompt reservations, as many arrangements must be made prior to departure. The tour price is \$815 per person, including transportation, hotel accommodations, breakfast and lunch or dinner, guides, tips and many other items.

The UND Alumni Tour will include France, Holland, Germany, Denmark, Sweden, Norway and England. Previous Alumni Tours have been well attended, and early reservations indicate a large group for the 1965 tour.

Sioux Basketball, Hockey Teams Have Conference Title Hopes

The Bill Fitch Basketball Co., a subsidiary of UND, continues to sell its product. And the Bob Peters Hockey Co., also a subsidiary, is doing

right well, too.

The cagers head into the second semester with a 15-won, 4-lost record and in first place (5-0) in the conference. The Sioux have only seven games left on the schedule, four of which are at home. Many are predicting a conference championship for the young Nodak hardwood performers.

The big feather in the Sioux war bonnet this season is a 61-54 home triumph over the U.S. Air Force Academy before over 6,000 fans. The Sioux have lost only to powerful Bradley, NIT champion, in overtime, to Chicago powers DePaul and Loyola and to Iowa of the Big 10. Victories have been over Chico (Calif.) State 77-65, Superior (Wis.) State 106-60, Bemidji State 101-78, Montana U State 71-69, Montana John's 80-62, Moorhead State 87-53, Concordia 80-65, Air Force, State College of Iowa 69-53, Augustana 84-61, S. D. State 84-72, Morningside 66-55, South Dakota 58-52 and Minnesota Morris 104-63. The Chico, Superior, Bemidji, Air Force, Augustana, S.D. State and Morris wins were at home, the rest on the road.

Two Memorial Scholarships Established at University

The establishment of two memorial scholarships at UND was announced at a banquet at the 15th annual UND alumni reunion at Camelback Inn, Phoenix, Ariz., Jan. 8.

Mrs. Grant Nelson, Roswell, N. Mex., announced a \$5,000 memorial scholarship fund in the name of her late husband, Lt. Col. Grant Nelson. Mr. Nelson, a 1925 graduate of UND, died in January, 1964, in Roswell, where he had been assistant professor of chemistry and chairman of the visual aids department at New Mexico Military Institute.

Born and reared in North Dakota, Nelson attained honors as a football player at UND. He received his master's degree from the University of California. In 1943, he joined the faculty of New Mexico Military Institute as a captain. He was promoted to major in 1951 and to lieutenant colonel in Oct., 1963.

The second scholarship will honor the late Mrs. Sylvia

Steele Nelson and is being established by her husband, Lloyd Nelson of Los Angeles. The late Mrs. Nelson, a UND alumna, was formerly a resident of East Grand Forks. Minn. Lloyd Nelson is a native of Grand Forks. He is a 1932 graduate of UND in business administration. Since 1945 he has been president of the Cal-Dak Company, a manufacturing firm with factories in Colton, Calif., Little Rock, Ark., and Toronto, Ont., Canada.

At the banquet, a Sioux Award was presented post-humously to Lt. Col. Grant Nelson in recognition of his services to education and his loyalty to UND. His wife accepted the award. About 225 persons attended the banquet.

Dr. John Linfoot, '55, was the leader of a University of California team of physicians who successfully treated victims of Cushing's Syndrome, "a rare but devastating disease," by use of new proton beam of unusual intensity.

Loyal Alumni Build Development Fund Total

December was a dandy for the Development Fund! National Chairman William Micklin reports that more alumni sent in more money in December than in any previous month in the Development Fund's history.

"Almost 500 loyal and generous Sioux supporters contributed about \$18,100 in December," Micklin said. "This puts us well on our way toward meeting our goal of \$75,000, and indicates the effectiveness of the efforts of our hard-working campaign

The long-awaited percentage rating of the states for the challenge issued by Missouri Chairman "Pete" Barnes has been compiled. The first report on this contest, as of December 31, finds Delaware showing the "Show Me" state.

Chairman Owen Webster must have used some special magic on his Delaware alumni-40% of them have contributed already. Maine was not far behind: their percentage was 37.5. And Virginia, with 26.3%, just squeezed by Alabama's 25.7%.

A second percentage rating will be figured as of February 28, according to J. Lloyd Stone, alumni director of the Fund. "In the meantime, the Missouri alumni will no doubt be hearing from Chairman Barnes," Stone speculated.

"The rating of all the states is listed in this issue of the REVIEW. If our alumni don't like the position their state is in, they should change it for the next report by sitting right down and mailing a check," suggested Micklin.

A combine-velope mailing will be sent from the University this month, and plans are to wind up the drive in May,
