We're Over The Top!

This enthusiastic statement is the headline in a final report letter mailed to all UND Development Fund State Chairman from William Micklin, National Chairman and J. Lloyd Stone, Executive Vice President of the UND Alumni and Development Fund.

The books are closed on the 1964-65 drive for the UND Development Fund, and a final audit shows a total of \$82,214 contributed to the fund during this fiscal year. This amounts to \$7,965 over budgeted expenses of \$74,249, the goal for this year's compaign.

It is a tremendous response from loyal Alumni, and represents the best year in history with the most contributors.

A great deal of credit for the success of the drive must go to F. P. "Pete" Barnes. In accepting the chairmanship for Missouri, he issued a challenge to the other states. Barnes wagered an extra \$200 personal contribution that his Missouri alumni would participate in greater numbers than those of any other state. Many of our chairmen took up his challenge, and the drive was on.

Fourteen states showed the "show-me" state, and Pete's check is in hand. Chairman Alden Squires convinced 50 percent of his Maine alumni to contribute, thus winning first place. Delaware and Virginia, led by Owen Webster and Robert Simpson, were second and third.

This issue of the ALUMNI REVIEW carries a list of the final state ratings.

Stone complimented all state chairmen for their efforts and stated, "You have been most generous with your time and talents, as well as your money. We deeply appreciate your loyalty and enthusiasm for your Alma Mater. You have made it possible for us to carry out our full program for another year."

REPORT from the CAMPUS

The commencement weekend is over, and there is a brief lull on the campus before the start of the summer school session, which opens on June 21. And, we're glad for this brief lull to reflect on the events of a most active year for your Alumni Association and Development fund, climaxed by the busy events of the 1965 commencement. -UND-

One of the most pleasant surprises was the visit of Dean Olaf Thormodsgard, former head of the University Law School, who returned to the campus for the commencement exercises. It was a real thrill to have Thormie on hand, as he is one of the true greats in the history of the University. and has shaped the careers of so many attorneys. As you know, Dean Thormosgard now lives in France with his wife, Marie, who was unable to accompany the Dean on his trip back to UND. It was a real delight for his many friends to visit with the Dean. And, I know that he shared in the feeling of pride we all felt in watching Judge Ed Devitt receive his honorary degree.

-UND-The commencement activities got underway on June 4 with the dedication of the John C. West Hall, a new residence unit at UND. Judge Devitt gave a fine address. Special guests of honor were Mrs. John C. West, widow of the former president, a son, John M. West and James West, a grandson, of Fergus Falls. The fine new building is named in honor of the University's eighth president, who retired in 1954 after serving 21 years as chief administrator. He died in 1961.

Judge Devitt was also the main speaker at the Commencement Dinner and related some of his recollections of the campus and its faculty back in the depression days. The banquet was well attended, and featured the presentation of diplomas to wives of graduating seniors. These diplomas are awarded for "Putting Husband Through Col-

lege", and the list seems to be larger every year! -UND-

Sunday, June 6 was the big day, 780 students received degrees, bringing the total number of UND degree recipients since last June to more than 1250, including the summer and mid-year commencement exercises.

Dr. Elmer Ellis, president of the University of Missouri and past president of the Association of State Universities and Land-Grant Colleges, gave the commencement address. Dr. Ellis received the bachelor of arts degree from UND in 1924 and the master of arts degree from UND in 1925. He was awarded the honorary doctor of law degree from UND in 1946. He was born near Anamoose, and was graduated from high school at Towner.

Dr. Ellis has been president of the University of Missouri since 1955. He is an excellent speaker, and it was a genuine pleasure to have him back on campus.

Three great men were awarded honorary doctor's degrees during the commencement exercises-each one is outstanding in his field. Judge Devitt was graduated from the UND Law School in 1935, and has an outstanding career in the field of law. He was a municipal magistrate in East Grand Forks, an instructor at the St. Paul College of Law, and an assistant attorney general of Minnesota.

During World War II, Devitt served as an intelligence officer, and then was elected to Congress from the Fourth District of Minnesota. He was appointed a federal judge in 1954.

Bertin C. Gamble is chairman of the board of Gamble-Skogmo, Inc., the company which he and the late Phil Skogmo founded in 1925. His family lived at Hunter, N. Dak. and later moved to Arthur. Gamble-Skogmo opened their first store in St. Cloud, Minnesota. Today, there are more 2600 Gamble-Skogmo than outlets in 21 states and Cana-

Dr. Orin Alva Stevens of North Dakota State, a professor emeritus of biology, is nationally recognized as an authority in botany, ecology, entomology and ornithology. He has published dozens of on North Dakota articles plants, bees and birds. -UND-

Your Alumni Board of Directors was in session during the commencement week-end. and reviewed the activities of recent months, along with some projected plans for the year ahead.

The Board welcomes Adrian McLellan of Great Falls and Fred Davidson of Minneapolis as new members, McLellan is a banker and Davidson is an executive with Gamble-Skogmo. It is with regret that the terms of Gordon Aamoth and Judge Ronald Davies have ended on the Board. There is a maximum limit of nine-years on the Alumni Board, and these men have given much of their talents. We'll miss them!

After a study by the budget committee, a proposed budget of \$88,616, for the UND Alumni Association and Development Fund was approved by the Board for 1965-66. It is an all-time high in budgets, but this is the minimum amount needed to assure a full continuance of the program. It includes student scholarships. loan funds and faculty awards of nearly \$30,000. The mailing list of the ALUMNI REVIEW grows with each graduating class, and our printing and postage costs keep mounting. But, we are confident that our loyal contributors will help make that budget total, and that the full program will be possible in the year ahead.

The Board re-elected the present officers for another term, headed by Dr. Otis Simenstad of Wisconsin. Otis has been a great leader this past year, and the Alumni Association is fortunate to have him continue as president. -UND-

Dr. Alm Named Summer Director

Dr. Kent G. Alm, director of undergraduate teacher education at the University of North Dakota, will become director of UND Summer Sessions in 1966.

Dr. Alm will succeed Dr. C. J. Hamre, who has directed Summer Sessions since Sept. 1, 1957. During this time the summer enrollment has risen by 800 students, reaching 2,033 in 1964. Dr. Hamre will continue to serve as dean of the Graduate School, professor of anatomy and chairman of the department.

A native of Binford, N. D., Dr. Alm received his elementary and secondary education there. He received a B.A. degree from UND in 1951, a M.S. degree from NDSU in 1956 and a Ph.D. degree from UND in 1963. Prior to completing work in his doctorate and joining the UND faculty, he was a guidance counselor in San Jose, Calif.

Dr. Alm will continue to teach education courses and and to direct the undergraduate teacher education program.

He is married and has two children, a girl and boy.


