Larimore Scholarship Established

A half-million dollar scholarship trust fund has been established at UND from the estate of Mrs. Elizabeth J. Larimore.

Mrs. Larimore, one of the earliest settlers in the Larimore, N. D. area, died in 1964. Mrs. Larimore's sister, Sadie Post Mathews, is a 1900 grad-uate of UND. Two grandsons of Mrs. Larimore, Jamison Larimore III and Robert Larimore, are also UND alumni.

The trust fund at UND will provide funds in perpetuity for scholarships. The first scholarships will be awarded for the second semester of the 1965-66 academic year. This is the second scholarship fund established at UND by Mrs. Larimore, who donated \$25,000 in 1964 to provide an annual scholarship of \$1,000 for the valedictorian of Larimore High School.

Another donation to UND from Mrs. Larimore is a collection of Chinese furniture and household items valued at several thousands of dollars. They are on display in

Twamley Hall.

GUSTAFSON NAMED DEAN OF EXTENSION DIVISION

A busy man these days is Ben G. Gustafson, who was recently named Dean of the UND General Extension Division.

Last summer the State Board of Higher Education voted to make Ellendale College a UND extension center, and since August 1 the Ellendale school has been under the guidance of Dean Gustafson. In addition, he supervises the full time extension centers at Williston and the Grand Forks Air Force base.

Nutrition Laboratory Set for UND

A new \$633,000 nutrition research laboratory is expected to be constructed on the University of North Dakota campus following approval of \$50,000 for planning of the facity.

This announcement was made during November by Senator Milton R. Young, who stated that the \$633,000 laboratory will be approved by Congress as soon as all planning can be completed. He stated that the Senate-House Conference Committee on Agricultural appropriations, of which he is a member, had

completed action on the measure. Dr. W. D. Cornatzer, chairman of the UND biochemistry

department, said that "the high quality of personnel and graduates in the Medical School was a major factor in the selection of UND as the site for the laboratory."

He further explained that "UND has a concentrated collection of excellent biochemists and physiologists and the quality of papers published has given the biochemistry department national recognition.'

The laboratory, to be used for research on food and food products, will be staffed by Civil Service employees and UND graduate students.

NOTED SCULPTOR IS ON UND STAFF

Dr. Avard Fairbanks, one of America's most distinguished contemporary sculptors, is now sculptor in residence at UND. Dr. Fairbanks, whose works include the Hon. John Burke. North Dakota's representative in statutary hall, Washington, will lecture to UND students.

One of his tasks at UND will be to create and complete a four-sided statue which will convey the theme "Invitation to Learning" and which will be placed on the campus. Dr. Fairbanks is best noted for his works on Abraham Lincoln.

REPORT from the CAMPUS

The Alumni Board of Directors held its annual Minneapolis meeting with Northwestern National Bank officials on November 5. It is customary at these meetings to go over the portfolio of investments held by the University of North Dakota Development Fund, Several changes in the investment policy were recommended. Following the regular Board meeting a special committee headed by Mr. Bolton met with the Trust Officers of the Northwestern National Bank to consider future investments. Mr. Bolton pointed out the importance of investing in conservative stocks and bonds which will bring good returns for the Deveolpment Fund.

I might point out that the

Alumni Association is fortunate to have a number of Board members who are authorities in the field of finance. Mr. Bolton, who is chairman of the Finance Committee, has had an abundance of experience with investments and in the field of finance and is the logical man to head up this important committee for the Alumni Association.

The Alumni Association, over the past years, has had a semiannual audit by a private accounting firm, the Brady Accounting Co. of Grand Forks. The report was given at our meeting in Minneapolis by Gerald Skogley, business manager of the University. The audit is carefully considered, and the budget is reviewed at each meeting.

Once every two years the University of North Dakota Alumni Advisory Committee meets at the University. I reported on plans for a meeting which will be scheduled for either March or April, 1936. Several changes in the membership of the Advisory Committee were recommended by Board Members.

Mr. Skogley reported on the progress of the Raymond Richards Golf Course, and stated that according to present plans, University students, faculty members, and alumni will be playing golf there in August or September of 1966.

New Footbridge To Span Coulee

A new footbridge will soon span the English Coulee which runs through the University of North Dakota campus. Since a condemmed wooden structure—and all its 22 years of history—was pulled down in January of 1963, UND has been without a convenient coulee crossing.

The walkway is constructed of white pre-stressed concrete and a steel double-T beam, 72 feet long. It will rest in a saddle foundation on either side and have handrails and lights.

Dr. George W. Starcher, UND president, said it was not possible to have a new bridge until a few months ago when E. F. Fox of Billings, Mont., donated \$15,000 to cover the construction cost. "The bridge, when finished, will be dedicated to the memory of Mrs. Fox, and a plaque will be placed on it to indicate this family's contribution to the campus," he said.

Two of the Fox children are UND alumni. Fox has been a farmer, a realtor, and now holds interests in oil properties.

Other alumni play a role in the bridge. Mark B. Foss of Foss, Engelstad, and Foss architects of Fargo contributed the architect's plans and engineering specifications for the structure. Construction for the bridge is by the Swingen Construction Co. The Swingens are also UND graduates and are erecting the footbridge at "near cost."

Secures Gifts

Ernest Tisdale, a 1937 graduate of UND with a major in geology, has been instrumental in arranging for four items of equipment and a money grant to the UND Geology Department.

The contributions come from the Humble Oil Co. of Houston, and the Cities Service Oil Co. of Bartlesville. The Humble grant is \$2,500 in cash to be used as a travel fund to enable geology staff and students to attend scientific meetings.

The Cities Service gift consists of four mirror stereoscopes for three-dimensial study of aerial photographs.
