## U Athletic Teams Gain National Prominence

### \$27,500 Gift to UND

### Gamble-Skogmo Firm Establishes Scholarships

Gamble-Skogmo, Inc., of Minneapolis has contributed \$15,000 to the University of North Dakota faculty improvement program and \$12,500 to be used for scholarships, it was announced by J. Lloyd Stone, executive vice-president of the UND Alumni Association.

The \$12,500, which will provide an annual scholarship of \$500 to a student in the College of Business and Public Administration, is the second such sum given to UND by Gamble-Skogmo for scholarships. The first \$12,500, given in the fall of 1965, also provides an annual \$500 scholarship for a business student. They are known as the B. C. Gamble Scholarships.

B. Fred Davidson, a 1927 UND graduate, is vice-president of Gamble-Skogmo, Inc., and a director of the UND Alumni Association. Bertin C. Gamble, who received an honorary doctor of laws degree from UND at Commencement

last June, is chairman of the board.

The \$15,000 contribution will provide \$1,000 annually to be distributed among University deans and officials, who in turn will allocate the funds to faculty members to cover expenses not provided for by state funds.

An alumni-faculty committee, headed by Thomas J. Clifford, dean of the College of Business and Public Administration and vice-president for financial affairs, will be in charge of distributing the faculty award grants. The money will be used by faculty members for research, to defray travel expenses in attending special conferences and conventions, to bring guest speakers to the campus and to finance research publications.

The first Gamble's store was founded in St. Cloud, Minn., in March of 1925 by Bert Gamble and Phil Skogmo. Today there are more than 2,900 Gamble-Skogmo outlets in the United States and Canada.

## Praise Alumni Help

## Win Bowl Game

During Marti's tenure as athletic director, UND football teams under the very capable coaching of Marv (Whitey) Helling have won two North Central Conference football championships. Last Nov. 27, UND defeated a fine Northern Illinois University team in the 17th annual Mineral Water Bowl game at Excelsior Spring, Mo., 37-20, to cap a season record of 9 wins and one loss. In the last three grid seasons, Helling's teams have won 23 games, lost only five. UND was ranked eighth in the final UPI Small College National Football Poll. Helling has two assistants—backfield coach Jerry Olson and former Iowa Rose Bowl star, Gary Grouwinkel.

## Roar Thru Conference

Last season, the Sioux basketball team under Coach Bill Fitch roared through the North Central conference race, posting a 12-0 loop mark to win the league title, won the NCAA College Division Midwest Regional title and placed third in the NCAA national finals at Evansville, Ind.

The 1964-65 UND cagers recorded a 26-5 overall season and so far this season have a 6-1 mark, having lost only to Minnesota at Minneapolis, 73-59, to open the season. The team has topped the century mark twice—clobbering Chico (Calif.) State, 106-59, and Whittier (Calif.) College, 108-71, here. The team has averaged 88 points a game in first five games and gave up only 66 per game.

## Win WCHA Title

Coach Bob Peter's 1964-65 hockey team came within a whisker of grabbing the NCAA

hockey brass ring at Providence, R. I., last March. The Sioux skaters ended their campaign with a 25-8-0 mark, best in school history for season wins, and finished first in the always-tough WCHA race. UND won NCAA hockey titles in 1959 at Troy, N. Y., beating Michigan State in the final, and in 1963 whipped Denver University at Boston.

To date our young, eager hockey team, which Peters thinks can make another strong bid for league and national honors, has posted a 5-2-1 record. In early games this season the team beat Minnesota-Duluth twice and split a two-game series with Michigan State.

## Pros Like Sioux

In football, UND has six players in pro ranks right now and two more were drafted high by the NFL and AFL in their recent selections of national grid stars. From the 1964 team, which had an 8-1 record, Helling has sent half-back Dave Osborn and tackle Mel Boehland to the Minnesota Vikings, place-kicker Collin Versich to the Dallas Cowboys, guard Don Gulseth to the Providence Indians and from two years ago linebacker Paul Robson to the Winnipeg Blue Bombers. A 1964 star back, Dick Wozney, ranked high among the Canadian pro leaders as a member of the 1965 Winnipeg entry.

This fall Philadelphia drafted giant (6-5, 240) end-tackle Dave (Butch) Lince of Mott, N. D., in the seventh round. Lince was the third straight Sioux to win first team Little All America honors. Minnesota Vikings have already signed their ninth round draft choice, flanker Ron Green.

In hockey, a Sioux star of last season, Gerry Kell, is now with Houston, a Montreal Canadiens farm club. Granger Evans is a wing at St. Louis and Bob Stoyko, who played last year also, is with the Minnesota Rangers.

Titles and winning are becoming a UND habit. We like the habit and hope you do, too. And while old-timers deservedly wave the flag of the Golden Sioux athletic era of the 1930's, we think the soaring sixties have produced titles, stars and won-lost records that at least equal the golden era of the thirties. The Splendid Sioux of the Sixties, Superlative Sioux.—Fight on Sioux!

## 1950 Graduate Donates Funds To U for Purchase of Aged Bible

Dwain E. Duis, a 1950 University of North Dakota graduate now living in Walnut Creek, Calif., has contributed funds for UND to purchase a recently published facsimile of the original printing of the King James Bible. The facsimile is now on display in the lobby of the Chester Fritz Library.

The facsimile edition, reproduced by an offset printing process on specially treated paper which appears as aged as a well-used original, is one of only 1,500 copies made of the first folio edition. Binding and all of the illustrations of the 1611 Bible were faithfully reproduced to show aging and wear of the volume from which the copy was made.

Duis has served as president of the UND Alumni Club in San Francisco, heading the

Alumni Association Development Fund Drive in California. J. Lloyd Stone, executive vice-president of the Alumni Association, said, "During his University days Mr. Duis worked as a student assistant in the Alumni Office and since his graduation he has been one of the University's most loyal and generous supporters."

Donald J. Pearce, UND head librarian, termed the King James Bible facsimile a "very worthwhile addition to the library, providing an important supplement to the facsimile of the Gutenberg Bible." The photo-lithographic reproduction of an original Gutenberg was purchased for UND last fall.

"We are very grateful to Mr. Duis for his gift of the King James facsimile," Pearce said.

## Establish Faculty Grant

A faculty grant has been established at the University of North Dakota as a memorial to the late Ernest C. Hilborn, Valley City, a 1905 graduate of UND.

The grant, to be known as the Ernest C. Hilborn-Alumni Faculty Grant, will be in the amount of \$1,000 to be awarded to a UND faculty member each year. The first grant will be awarded the second semester of this year by an alumni-faculty committee. It will go to the UND faculty member who has made an outstanding contribution to the growth, progress and prestige of the University, according to J. Lloyd Stone, executive vice-president of the Alumni Association.

The donor of the grant, who wishes to remain anonymous, said Mr. Hilborn was one of the University's outstanding alumni and never failed to express appreciation to his alma mater for the education he received at UND.

Dr. William E. Koenker, UND vice-president of academic affairs, said the grant fills an important need on the University campus.

"This grant will make possible the special recognition of faculty members whose teaching and research have been of unusually high quality," he said. "The significance of

this recognition will be enhanced by the fact that it will be based upon the judgment of the faculty member's colleagues and former students of the University."

Mr. Hilborn, who died in 1953, served on the UND Alumni Board of Directors for a number of years. He was born at Ripon, Wis., in 1876 and received his early schooling at Appleton, Wis., and Little Falls, Minn. He came to North Dakota as a young man and was graduated from Valley City Normal School in 1903. He received the bachelor of arts degree from UND, where he was a member of Phi Delta Theta social fraternity.

After teaching for several years, he established the Northwest Nursery Company in 1908 with offices in Valley City. Under Mr. Hilborn's leadership, the nursery became outstanding in the Midwest.

Mr. Hilborn participated in many organizations and civic activities, including the North Retail Nurserymen's Association and the American Association of Nurserymen. He was a charter member of the Valley City Rotary Club, a promoter of the Valley City Chautauqua Association, a member of the Masonic Lodge and served on the board of trustees of the Congregational Church of Valley City.

## Institutes Aid Science Teachers
