Delaware Leads States

Eastern University Alumni Ahead in Fund Drive

UND alumni in the East have jumped off to an early lead in the 1965-66 Development Fund drive, according to first percentage figures released by William T. DePuy, national drive chairman.

The accompanying chart shows that the top eleven states are all east of the Mississippi, DePuy pointed out.

"Contributions are coming in at a good rate and our loyal alumni are donating very generously," DePuy said. "However, the pace must continue to exceed last year's if we are to meet our goal of \$88,616" he continued.

To this end another "combinevelope" is being prepared to be mailed out from the University the first part of March. "We hope enough contributions will be sent to give us that final push over the top," DePuy said.

Delaware alumni have the highest percentage participation in the drive as of December 31 with a total of 29.63%. New Hampshire follows close behind with 28.57%. Last year Delaware finished second to Maine, and New Hampshire was in 28th place.

State chairmen have come up with some original chal-

lenges again this year. Oregon chairman Dr. Willis B. Shepard has bet Arizona chairman Jack Stewart a case of Oregon pears against a case of Arizona grapefruit that Oregon would have a higher percentage of contributions than Arizona. So far Dr. Shepard has his grapefruit!

Virginia chairman Joseph P. Baker is betting his state's alumni against the field. He has pledged a personal contribution of \$200 if Virginia is not Number One, with an additional \$50 donation if it does finish first. He appeals to his alumni with "Your failure to contribute could cost the Fund \$50." Currently Virginia is in ninth place.

Ruder was a 1965 Pulitzer Prize winner and is publisher of the *Hungry Horse News*, Columbia Falls, Mont. He was awarded the honor for his photographic and editorial coverage of the floods in the Montana Rocky Mountain area.

The Founders Day Banquet on Thursday evening will feature an address by Dr. Louis Geiger, former UND faculty member and author of a history book on the "University of the Northern Plains." Dr. Geiger is now chairman of the history department of Colorado College.

The 1966 Founders Day program is made possible by the Dean Squires Memorial Fund, which has been established in memory of the late UND educator.

U INSTITUTES STUDY TEACHING TOOLS

George Voegel, director of the instructional communications department at UND, states that "the new technology in teaching makes educational media institutes almost imperative."

He points out that there are methods of teaching and learning, educators must learn and express new ideas, and that there are many tools and teaching devices to help make the teacher more effective.

In addition to the regular institute, UND will also conduct a media training institute for small school administrators.
