McDermott Fund To Recognize Top Educators

The family of the late Lucile B. McDermott of Chicago has provided a fund at the University of North Dakota to recognize outstanding teachers. The fund will be known as the Lucile B. McDermott Memorial Fund.

Mrs. McDermott's husband, Edward H. McDermott, a 1920 UND alumnus, is an attorney in Chicago.

J. Lloyd Stone, Alumni Executive vice president, said the fund will provide a \$600 award each year to recognize excellence in teaching. Recipients will be selected by an alumni-faculty committee, and the first award will be made in February of 1967.

Although Mrs. McDermott did not attend UND, she became interested in the University when she took part in an Alumni Association-sponsored tour of the Orient in 1964.

Mrs. McDermott, who died in 1965, was born near Parkersburg, W. Va. She received the undergraduate degree from Marshall College, Huntington, W. Va., and the master's from Radcliffe College, Cambridge, Mass. She also attended the University of Chicago, Northwestern University and the University of West Virginia.

Bridston Family Establishes Fund

The family of the late Joseph B. Bridston, former North Dakota state senator and president of the UND Alumni Association, has deposited \$5,000 with the First Federal Savings to establish the Bridston scholarship in perpetuity. The scholarship will be awarded annually to a UND student.

It's A New Record

Enrollment Zooms to Over 7,000

The final totals have been compiled, and the University of North Dakota enrollment for the 1966-67 fall semester has soared to 7,075.

This represents an all-time high for UND, with the enrollment accelerating at a faster pace than was earlier predicted. The total number of students on the UND campus is 6,370, comprised of 4,241 men and 2,129 women.

There are 438 students at UND-Ellendale Branch, while UND-Williston Center has an enrollment of 267. The largest percentage increase on the UND campus was in the graduate school, which rose by 18 percent over last fall's final total.

Development Fund Makes Brisk Start

With the University of North Dakota totalling a record-breaking enrollment, the UND Development Fund is keeping pace with early contributions from alumni coming in generous amounts, according to E. E. "Mick" Simmons, National Chairman of the Drive for 1966-67.

The UND Alumni Budget Board set a goal of \$101,150 for the 1966-67 campaign, covering scholarships for students, faculty awards, publishing of the ALUMNI REVIEW and other activities of the alumni association.

State chairmen have been appointed in nearly all the states, and are already at work in spear-heading the campaign in their areas. With the gift-giving holidays fast approaching, it is expected

REPORT from the CAMPUS

Homecoming 1966 is now in the memory books, but it will be long remembered, even by those who were not on the campus during that hectic week-end.

The football game, of course, was probably the most exciting, emotion-packed sports event in any stadium of the nation. There were nearly 14,000 people packed into Memorial Stadium. I am sure that Jack Stewart, who spearheaded the drive to build the stadium back in 1927, would have been amazed at the crowd. I'm sorry he wasn't back this year.

The Bison and the Sioux were rated the top two college teams in the nation, in the college division, and the game drew great publicity, including stories in News Week and Sports Illustrated, along with state-wide radio and television.

The final score was NDSU 18-UND 15, and the game was just as close as the final tally, with NDSU winning on a late field goal. You can be very proud of Coach Marv Helling and his Fighting Sioux. The final score will never change, but there are many who believe that the Sioux should have been on top. But, the game is over, the Sioux were great, and I offer our sincere congratulations to the Bison. They were great, too.

There was much going on during Homecoming, in addition to that football game. The Alumni Board of Directors met for their fall session and discussed many things, including the investment program. Our president, Dr. Otis Simenstad, was on a trip to the Far East and could not attend, but Jack Traynor did an excellent job of presiding.

—UND—

The Sioux Award Winners were introduced at a noon luncheon, with the Board of Higher Education and the Alumni Advisory Committee as special guests.

After the luncheon, a full afternoon meeting between the Alumni Board and the Advisory Committee was held. Bill DePuy did his usual excellent

job as presiding officer, with brief talks by Gordon Caldis, Dr. Ben Clayburgh, Tom Clifford, Alex Burr and George Longmire.

Each speaker pointed out some of the vital needs of the University and higher education in North Dakota, and I only wish that there were space enough to give their remarks in detail.

Caldis spoke basically about the law school and its needs for a new building and competitive salaries for the faculty. He pointed out that 80 percent of the lawyers in North Dakota are UND graduates. He also stressed the need for greater support in the form of athletic scholarships, particularly hoping for alumni support within North Dakota.

Dr. Ben Clayburgh reviewed the medical school, emphasizing that the mill levy income was not able to keep pace with the financial needs of the school. Dr. Clayburgh recommended the expansion of the rehabilitation center, a renewed interest in a two-year nursing program, and greater emphasis on the "post-graduate" aspect of training for practicing physicians.

Dr. Alex Burr covered the school of engineering, and pinpointed his remarks at the present curricula and the diversified degrees. He felt that there should be revamping of certain courses, and a trend started in the area of new courses.

Dr. Burr discussed the geographical distribution of degrees, and outlined the public image of engineers, research, competition with foreign engineers, salary and building needs.

Dean Tom Clifford pinch-hit for Ed Franta, who was unable to attend the afternoon session. Tom reviewed the priority list of classroom and building needs. Like the other speakers, he emphasized the great need for adequate building space, coupled with sufficient salaries to avoid an abnormal faculty turnover.

Senator George Longmire wrapped up the session with an excellent summation, stat-

ing that North Dakota institutions of higher learning cannot remain on a "pay as you go" basis. He indicated that the North Dakota constitution must be changed to permit a long-range bonding program for our colleges.

I only wish that all of our alumni could have attended this joint session, as it certainly was informative and truly presented the challenges facing UND and higher education in North Dakota.

There's an editorial by Henry Sullivan in a recent issue of the Mohall Farmer, in which he relates a "pleasant and rewarding" visit to the UND-Ellendale Center. Mr. Sullivan is a member of the State Board of Higher Education, and found the UND-Ellendale Center to be impressive, both from the standpoint of the 452 students enrolled and the appearance of the buildings and campus.

He praises the UND Extension Center, under Dean Ben Gustafson, for the "new look" at Ellendale, mentioning that it is the only school in the state that specializes in the field of teaching industrial arts.

A sad note during Homecoming Week was the word from California that Paul Bolton, a member of the UND Alumni Board of directors, died on October 17 after an illness of several months.

Paul was both a fine director for our alumni association and a close friend, and will be greatly missed by all of us.

There's a brand new history book on the market, and I am confident it will be a "best seller" among those who are interested in the wonderful history of our state.

The title is "History of North Dakota" and the author is my neighbor, Dr. Elwyn B. Robinson, professor of history, former chairman of the department of history at UND, and first winner of the alumni distinguished teacher award.

Jack hopes to have his new home completed by January. It's located high up on Mummy Mountain, behind Camelback Inn, and if ready by January 15, it will be the locale for an alumni social hour as guests of the Stewarts.

Jack urges all alumni to make their reservations immediately, as the Inn capacity may be reached soon.

UND has stiffened its grade-point average requirement for students transferring to the University. Students who transfer into UND must not only maintain an over-all C average in order to graduate, but also must do at least C average work in courses taken at the University. The new regulation goes into effect February 1, 1967.

A Harry Lashkowitz Memorial Lecture Series has been established in the UND Law School, with nationally known figures in law and government invited to speak at lectures, alternately in Grand Forks and Fargo. The lecture series was established in memory of the late Harry Lashkowitz, a Fargo attorney.

Dr. John L. Rowe, chairman of the UND business education department, has been named to the editorial board of the "American Vocational Journal."

—UND—

Miss Gladys Black, director of food services at UND, has been elected governor of district 22 of Quota Clubs International. The district includes North Dakota, Minnesota, Illinois and Wisconsin.

Dr. William R. Boehle of the UND music department has been named to the advisory board of the Annual Young Artists competition to be held at the University of Minnesota.

—UND—

The National Science Foundation has awarded UND a \$261,000 grant to support a 1967-68 academic year science institute for high school teachers in general science. Science teachers from all 50 states have participated in past institutes at UND.

—UND—

The Grand Forks City Council presented a plaque to the UND student body in recognition of student participation in combating the flooding Red River last spring. UND students, working in shifts, donated hours of volunteer labor to dike building and sandbagging operations.

—UND—

A novel by William Borden, instructor in English and humanities at UND, has been accepted for publication by a publishing house in England. The novel, Borden's first, is entitled "Superstoe," and is set in North Dakota and Washington, D. C. He has been on the UND faculty since 1962 and has also written several plays.

—UND—

Eighty freshmen were admitted to the UND Honors Program for 1966-67. This record number, combined with other students taking part in the program, brings the total to 162. Now in its sixth year at UND, the program bases admittance on academic records in high school and college, and a student must maintain a 3.0 (B) average in the last three years of study.

—UND—

Dr. Gordon Iseminger, assistant professor of history at UND, has been elected president of the North Dakota Social Science Association.

—UND—

UND is teaching graduate courses in seven North Dakota cities during the fall semester. The courses are in education, counseling, guidance, and physical education and are being offered by the Graduate School and the College of Education through the General Extension Division.

Dr. Blaine E. McLaughlin, chairman of the UND psychiatry department, presented a paper during September at the Fourth World Congress of Psychiatry in Spain. The paper discusses the development of mental health treatment on a public basis in North Dakota. Dr. McLaughlin is medical director of the Northeast Mental Health and Retardation Center, which is the headquarters of one of the four areas into which the state has been divided to facilitate developments in mental health treatment.

—UND—

A dormitory presently under construction at UND will bear the name of Dr. Erich Selke, UND professor emeritus of education who died September 26. The naming of the dorm for Dr. Selke was approved by the State Board of Higher Education several days before his death. UND President George W. Starcher commented: "The naming of this hall for an outstanding teacher further emphasizes the University's concern for recognizing great teaching."

—UND—

J. Donald Henderson, UND professor of physics and science teaching, has accepted an invitation to join the National Science Foundation staff in Washington, D. C., for at least 12 months. Henderson has submitted 19 proposals to NSF seeking support for teacher education programs at UND, with 18 of these being supported with grants totaling over \$2,550,000.

Harold L. Pedersen has been named assistant athletic director at UND and will assist Athletic Director Leonard R. Marti in all phases of the growing athletic and physical education program. Pedersen came to UND from Williston, where he was athletic director and football coach for 13 years.

—UND—

Gene Murphy, former UND quarterback, has been appointed assistant football coach and instructor in men's physical education. Murphy enrolled at UND in 1959, earning his degree in 1963. For the past two years, he has been a coach at North St. Paul; he is married and has one son.
