The Medical Center Rehabilitation Hospital at UND will mark ten years of service to North Dakotans with a public open house on Oct. 18-20.

The three-story hospital on the UND campus treats patients from every county in the state, with the open house planned to coincide with the Homecoming activities.

The hospital was founded in 1948 as part of the UND Medical Center. Its purposes are to provide physical, social and vocational services for the disadvantaged, to reduce their impairments and bring them back to maximum functioning.

## Bohnet Serves Third Term as National Sports Director

Lee Bohnet, '51, is serving his third term as national director of the College Sports Information Directors of America (CoSIDA). He has been UND Sports Information Director since 1953. Such famous alumni as Irv Kupcinec, '35, and Jack Stewart, ex '29, held this position before him.

## Sioux Football Team Practically 'All New'

Football at the University of North Dakota is practically all new this fall. There's new head coach Jerry Olson and the team itself has been described as "sophomoric."

To date the young Sioux haven't won, but local fans see more bright spots than deficiencies and expect the Sioux to break loose anytime. Olson is a shrewd, very personable and hard-working coach highly respected by opposing coaches and his players. With this combination it won't be long before the pen-

dulum swings in favor of the Sioux.

Except for about 11 minutes against the University of Montana the Sioux played excellent football. However, Montana used its speed to win, 37-10. Montana, unlike the Sioux, is a veteran team built around about 50 junior college transfers the past two seasons.

In the home opener before about 7,000 third annual Potato Bowl fans the Sioux were beaten, 14-10, by University of Northern Iowa. Two first (Continued on page 2)

Rowland was judging a music contest in Oregon when he met Ernest Wilcox, who was on leave from the UND music department. Wilcox recommended Rowland to President Thomas F. Kane, and that marked the beginning of the long tenure of service for "Pop" on the campus.

quarter errors (a fumble and a defensive lapse) gave the Iowans the edge and their points, but the last 51 minutes the Sioux were in complete command.

While UND hasn't won it has shown plenty of that good old Fighting Sioux spirit. One veteran follower said he had never seen a Sioux football team "show as much spirit and determination. All these boys need now is to develop consistent performances."

Due to cancellation of a six-year contract by Idaho State University, the Sioux play only eight games this year. UND has four at home and four games on the road. UND had beaten Idaho State, 27-0 and 41-0, before they asked to be relieved of their contractual obligations with four years remaining.

Homecoming this year brings together the young Sioux and highly-touted, much-praised North Dakota State Bison. The date is Oct. 19 and kick-off time is 1:30 p.m. at Memorial Stadium.

Other games remaining: Oct. 12 at S. D. State; Oct. 26 at Augustana, S. D.; Nov. 2 at Morningside; Nov. 9 at home against Montana State.

### New Food Building Under Construction

Contracts totaling \$1,006,094 were awarded during May for a new food service building at UND, with construction now in progress. Completion of the two-story structure is scheduled for the spring of 1969.

It will be named Wilkerson Hall in honor of James W. Wilkerson, who was UND business manager for 45 years. Mr. Wilkerson joined UND in 1903 and remained on the staff until his death in 1948.

The building will contain a cafeteria, snack bar and other services to accommodate the 1500 students who will be housed in the residence halls west of the campus. A tunnel system will link all units in the six-building complex.

## Applications Open for 4-Year ROTC Scholarships

Male high school students who plan to enter college for the first time in the fall of 1969 may now apply for four-year Army ROTC scholarships, according to Col. Robert L. Woodard, professor of military science at UND. The scholarships are awarded annually on a competitive basis to outstanding high school graduates who are motivated toward a career in the regular Army. Eight-hundred scholarships are available nationally for the 1969-70 school year.

Each scholarship pays for the student's tuition, textbooks and lab fees and provides a \$50 per month subsistence allowance for the duration of the award except for a six-week summer camp period when the student re-

ceives one half of the pay of a second lieutenant.

The scholarship winner may attend any one of the 259 colleges and universities offering the four-year Army ROTC program, including the University of North Dakota. Except for officer training classes, the ROTC student may pursue the academic program of his choice.

Application closing date is Jan. 15, 1969, and winners will be announced in the spring of that year. Students who intend to apply for the scholarships are required to take the College Entrance Examination Board tests. Information about the program and application forms may be obtained from the Commanding General, Fifth U. S. Army, ATTN: ALFAG-ZI, Fort Sheridan, Ill., 60037.

## Starcher Presents Views To Frosh, Parents, Faculty

Student activism and freedom of expression on campus were the topics of three separate speeches given during Orientation Week at the University of North Dakota by UND President George W. Starcher. President Starcher addressed the more than 1,300 freshmen entering the University and their parents at a convocation, a special program for parents and the first general faculty meeting of the 1968-69 academic year.

The gist of President Starcher's talks was that the University expects its students to have healthy and lively curiosity about opposing and unpopular ideas, but he warned against student activism that leads to disorder. He added that a university should seek to "maintain an order that makes peaceful change possible" and at the same time guarantees fair play to all points of view.

The University may no longer protect students from all the dangers of the world, Starcher remarked to parents. "But we do care, and that is important. Students do not want us to indoctrinate them with only safe ideas or specify in advance all the moral and ethical principles they must live by and then see to it that they never get to learn about, or even think about, anything else," he said.

He cited as "honorable and commendable" student concern for the underprivileged. "We shall not discourage their protests," he stated. "But we cannot make a place for one who believes only in violent revolution and lawlessness to

accomplish his purposes, without regard to consequences in loss of dignity, decency or even of life itself. We expect students to protest and dissent because they are free to think for themselves," Starcher commented to the parents. "But we cannot allow intolerance in the name of freedom.

"It is wise restraint which makes men free," he told freshmen. "Try to learn what you are for as well as what you are against. Have the courage to restrain impulse, to practice tolerance and charity as well as to seek fairness and justice."

He added, "Whenever the student activist engages in revolution with no concern for decency, dignity, life or even civilization itself, his behavior is no better than those who try to suppress the inspirations of the economically deprived and who thus deny them the universal claim to decency, dignity and equal opportunity."

He complimented the faculty on their long record of working with students in the decision-making process of the University, "keeping the student point of view before us." As tangible products of student-faculty committee work he listed the Student Creed of 1958; Preamble for Higher Education at UND, 1959; Statement of Academic Freedom, 1963; and Long Range Planning Committee Report, 1967.
