## Development Fund Awaits December Boost

It's the 12th month of 1968 when December ushers in the most wonderful season of the year for gift giving, including to the UND Development Fund.

The Development Fund faces a big challenge for 1968-69 with a budgeted goal of \$135,100. The initial support from UND alumni during the fall has been excellent, according to Milton Kelly of Devils Lake, National Campaign Chairman.

"However," says Kelly, "we know that a lot of our alumni and University friends make their contributions during December, and we hope to be a long way toward our goal by the first of the year."

So, say "Merry Christmas" to your Alma Mater and the UND Development Fund by making your contribution during December. Your name will be included in the Honor Roll edition of contributors to be published in 1969.

## DOCTORATE OUTPUT INCREASES 600%

Production of doctorates at UND has increased on an annual basis by almost 600 per cent since 1960, according to A. William Johnson, dean of the Graduate School. There were only eight doctorates conferred by UND in 1960, as compared to 55 in 1968. From 1960 to 1968 there were a total of 207.

## REHAB HOSPITAL GIVEN TOP ACCREDITATION

The Medical Center Rehabilitation Hospital on the UND campus has become the third such facility in the United States and Canada to receive a three-program accreditation from the Commission on Accreditation of Rehabilitation Facilities.



## Season's Greetings from UND

## University Receives \$100,000 Check

The University of North Dakota has received a \$100,000 check as the final payment of a \$200,000 gift from the B. C. Gamble and P. W. Skogmo Foundations of Minneapolis.

The money will be used for furnishings and other items in Gamble hall, the new home of the College of Business and Public Administration. The \$1.8 million building is named for Bertin C. Gamble, head of the Foundations and chair-

man of the Gamble-Skogmo board. He received an honorary doctor of laws degree in 1965 from UND.

J. Lloyd Stone, executive vice president of the UND Alumni Association, noted that this is the third large gift given to the UND Development Fund by the Gamble-Skogmo corporation. The other gifts have been directed towards scholarships and faculty award grants.

## ENROLLMENT COVERS STATE, NATION

Students from all 50 states and each of North Dakota's 53 counties are represented in the UND campus enrollment for 1968-1969, with Grand Forks county topping the list with 1641 of the 7398 enrollment total.

Minnesota heads other states with 815 students from the neighboring state. The 7,398 students at Grand Forks include 4727 male and 2671 female.

## MATH TEACHERS NEEDED

The greatest demand for teachers this year at UND has been in the field of mathematics, according to Cecil Ewing, director of the UND Teacher Placement Office.

Second in demand is English, followed by special education, music and science. In 1968, the Placement Office received notices of 41,000 vacancies, or approximately 40 positions for every prospective teacher enrolled with the office.

## Board OK's U Building Requests

Contracts totaling \$3.87 million were approved by the North Dakota Board of Higher Education during their October meeting, when they also agreed to ask the 1969 North Dakota Legislature for authorization of more than \$19 million in buildings at no cost to the state.

Included in the legislature authorization request are a \$1.6 million winter sports arena, a \$3 million rehabilitation treatment center and a \$2.5 million fine arts center, all at UND.

The self-liquidating building authorization request includes \$5.55 million worth of construction at UND. Included are 150 new married student apartments, costing \$2.25 million; dormitories for an additional 300 students and food service facilities for 600 to 800 students; a University Center addition, costing a total of \$2 million; a \$1 million student health service building; and a \$150,000 warehouse building.

Dr. George W. Starcher explained that "all physical additions to the campus must be cleared by the State Legislature. After approval, then we start looking for the money to do it. We don't have the money for any of these things now, but we're hoping it will be available in the future, and are only getting ready for that possibility."

## MISSIONARY WORK

Dr. Benjamin DeBoer, professor of physiology and pharmacology, has been doing "missionary" work of sorts in his field. He was asked by the International Society for Pharmacology and Experimental Therapeutics to visit colleges in North Dakota, Montana and South Dakota and inform students about opportunities for graduate study and work in pharmacology.

### STATE RANKS 42ND IN APPROPRIATIONS

North Dakota ranks 42nd in the nation in its appropriation of state tax funds for operating expenses of higher education for 1968-69. The report was made by the National Association of State Universities and Land-Grant colleges.

The report states "in spite of record appropriations and impressive percentage increases in state support, public higher education still is not receiving the support it needs to keep up with rising costs and demands."

The report concluded "our state governments have demonstrated an impressive commitment to higher education, but as costs increase and demands on public colleges and universities continue to grow, state governments must not allow themselves to lose the momentum of their support."

### DOCTORATE EXTENDED

The Doctor of Education degree at UND has been revised and broadened and is now available to students in all academic departments offering graduate work to the doctorate level, according to Dr. A. William Johnson, dean of the Graduate School.

The \$1,250,000 structure, on the eastern edge of the campus, was opened in 1968. The physics department is in the basement and first two floors, with the mathematics department on the third floor.

Witmer joined the UND faculty in 1924 and is now serving as a physics professor on the University faculty under a delayed retirement plan. He retired as dean in 1965 and received the title of "University Professor," an honor reserved for UND's most distinguished faculty members, and Dean Emeritus, College of Arts and Sciences.

A native of Bathgate, Dr. Witmer earned his B.S. and M.S. degrees in electrical engineering from UND. He has held many administrative positions at UND, advancing through the academic ranks to professor in 1938.

## Kermott Scholarship Established at UND

A former Towner couple has established a \$30,000 scholarship fund for the electrical engineering department, College of Engineering, at the University of North Dakota in memory of their son.

The gift was made by Dr. and Mrs. O. L. Kermott of Mesa, Ariz., according to J. Lloyd Stone, executive vice-president, UND Alumni Association. The gift, to be known as the Kermott Scholarship Fund, was established in the name of Ormiston Kermott Jr., who died in 1939 during his junior year at the University. He was an electrical engineering major.

The fund will provide \$1,500 annually in student grants to electrical engineering students, based on academic achievement and scholarship. The award will be made by the UND Scholarship Committee on the recommendation of the electrical engineering department.

"The University and the College of Engineering are very appreciative of this new scholarship," Stone said. "It is this keen interest in UND, as

shown by Dr. and Mrs. Kermott, that has enabled our University to make progress that would otherwise not be possible."

Dr. Kermott practiced dentistry for more than 50 years in North Dakota before retiring and moving to Arizona. Mrs. Kermott, the former Ethel M. Kaufman, is a native of Grand Forks and graduated in 1914 from UND. A daughter, Shirley Simmons, is a 1938 graduate. Her husband, E. E. Simmons, also a 1938 University graduate, is a member of the UND Alumni Board. Their son, Craig, attended UND, and their daughter, Jill, is a senior at the University.
