Clifford Named 8th President of UN

20 U Alumni Serve in N.D. Legislature

Alumni Days Scheduled for May 27-28

Two busy days are looming up on the spring calendar at UND, with Alumni Days scheduled on May 27-28. Special activities are planned for the 40-year and 50-year ago classes.

Activities begin at 3 p.m. on May 27, with registration and coffee with new UND President Thomas Clifford at the University Center. It will be followed with a social hour, and an Alumni Dinner for Old Timers, Sioux Award winners and Alumni Board members at Westward Ho Motel.

Friday morning opens with a meeting of the Alumni Board of Directors in Gamble Hall, while Old Timers will gather for breakfast and picture taking at 9 a.m. at University Center. At 11 a.m. Old Timers will have a bus tour of the campus.

Highlight of the day will be Alumni Awards Luncheon and Annual Meeting of the Alumni Association in Wilkerson

Members of the classes of 1921, 1922, 1923, 1924 and 1925 are urged to attend for the 50-year anniversary class, along with members of the classes of 1929, 1930, 1931 and 1932, representing the 40-year ago classes. Alan Gray is chairman for the 50-year classes, while Ruth Fletcher Legvold heads arrangements for the 40-year classes. Reservations can be made by writing the Alumni Office.

Native of State To Succeed Dr. Starcher

Dr. Thomas J. Clifford, vice president for finance at the University of North Dakota, will become the eighth president of UND on July 1, 1971, succeeding Dr. George W. Starcher, who retires this year after 17 years as president.

The selection of Dr. Clifford was made by the State Board of Higher Education in January and is unique in that he is the first native North Dakotan ever to be named president of the state's largest educational institution. Other final candidates for the position were from out-of-state.

Dr. Starcher, who was present when the selection was announced, called Dean Clifford "uniquely equipped for the tasks that lie ahead. He will find the challenge of these next few years as great and as exciting as any ever faced by this University."

As president, Clifford will receive a beginning annual salary of \$30,500. Fred Orth of Grand Forks, a long-time member of the Board of Higher Education, urged Clifford's selection, with Albert Haas, board member from New Rockford, seconding the motion. Orth described Clifford as a very able administrator, while Haas expressed confidence that the newly named president would join the other able leaders of state institutions of higher learning and added, "I pray the Lord will help him get the job done, that he get it done right, and that he have a little fun doing

The search for a new president of UND began a year ago, immediately after Dr. Starcher announced his plans to retire. A 13-member committee was chosen by faculty,

(Continued from page 1) students, alumni and administrators to screen candidates in the 163 original nominations.

A native of Langdon, N.D., Clifford is 49 years of age. He attended elementary and high schools in Langdon and entered UND receiving a bachelor of science degree in 1942 and a juris doctor degree in 1948.

He also has a masters degree in business administration from Stanford University, where he was a Stanford Executive Fellow in 1957-58. Clifford joined the UND faculty in 1945 as an instructor in accounting and business law. In 1948 he became an associate professor and assumed the rank of professor in 1949. Clifford was appointed Dean of the College of Business and Public Administration in 1950, and was elevated to vice president for finance in 1959.

Clifford is a member of the American Bar Association, the North Dakota Bar Association, the American Institute of Certified Public Accountants, the American Management Association, and is a past president of the North Dakota Society of CPA's. Since 1964 he has been a member of the UND Alumni Association Board of Directors and has been on the Board of Directors of the Red River National Bank in Grand Forks since 1958.

A recognition dinner on May 7 will honor Dr. George W. Starcher, who will retire June 30 as UND president. The reception and dinner will be the principal event at which the University, alumni, and community will recognize Dr. Starcher's 17 years of service. Members of the committee planning the event are Mrs. Mabel Curry, chairman; Pat Larson, assistant to the president; D. J. Robertson, dean of the University College; Dr. Henry J. Tomasek, chairman of the political science department; Dr. D. Jerome Tweton chairman of the history department; Mark Joraanstad of Noonan, student body representative; and Gordon Caldis, alumni and community representative.

Clifford served in the U.S. Marine Corps from 1942 to 1946, moving from private to the rank of major; he participated in the campaigns in the Solomon Islands, Saipan, Tinian and Iwo Jima in the

Pacific Theater, earning the Bronze Star, Purple Heart and Silver Star.

The Twin Forks Chapter of the National Secretaries Association honored him as "boss of the year" in Greater Grand Forks in 1964. He is also a former campaign manager and chairman of the United Fund of Grand Forks, a director of St. Michael's hospital, a member of the state board of trustees of Blue Cross; a director of the Northeast Mental Health and Retardation Center, chairman of the Grand Forks County Selective Service Board, a member of the North Dakota Governor's Commission on Status of Women, and a member of the Upper Midwest Research and Development Council for North Dakota.

An enthusiastic sports fan, Clifford has worked more than 1,000 basketball games as time - keeper at the UND Fieldhouse; he is an excellent handball player and is coholder of the doubles title in North Dakota for 1970. He played football at UND as a freshman in 1938, until a knee injury ended his gridiron career.

Mrs. Clifford, the former Florence Schmidt of Ashley, N.D., met her husband-to-be while at a fraternity party at UND, and they graduated together from the University. This summer, they will move

from their home on Harvard Street to the low, contemporary style President's home on the banks of the English Coulee.

A fine musician, Mrs. Clifford has studied piano extensively and has given numerous recitals. Interior decorating is one of her hobbies, along with antiquing and furniture refinishing, copper enameling, mosaic tiling, creative embroidery and cooking German dishes.

Mrs. Clifford is a member of the St. Michael's Altar Guild, North Dakota Dames Club, North Dakota Music Teachers Association, the Thursday Music Club and Sigma Alpha Iota, music honorary. She is a part-time instructor on the University music faculty.

The Cliffords have two sons, both married, and two grandsons. The family consists of Mr. and Mrs. Thomas Clifford, Jr., and son, Gregory Paul, of Laramie, Wyo. He is working for his Ph.D. in biology at the University of Wyoming. Stephen Clifford is a medical student at UND and has one son, Scott Stephen; Tom Clifford, Jr. received his bachelors degree from UND and masters degree from South Dakota State University. His wife is the former Linda Petrich, '66; Mrs. Stephen Clifford is the former Debby Alger (ex '68).

The naming of Clifford as the eighth president of UND

drew favorable reaction from throughout North Dakota. The Fargo Forum editorial said "the elevation of Thomas J. Clifford to the presidency of the University of North Dakota at Grand Forks is indeed welcome news to those of us who think that North Dakotans are as capable as any outsider of handling the important jobs this state has to offer."

The Dakota Student, in its concluding paragraph of an editorial on Clifford, stated, "The Dakota Student has not often been considered an accurate barometer of student opinion on this campus, nor have we tried to be; that is not in keeping with our concept of what a student newspaper should be, for reasons that need not be explained here at this time. But we believe we speak today with a certain unanimity of student opinion behind us when we say this university wil continue to receive in Tom Clifford the high quality leadership it has enjoyed for the past 17 years."

The Minot Daily News, noting that Clifford was the first native of North Dakota to head the University, wrote in part "Certainly the need for restraints, financial soundness and judicious planning will call for stability and common sense in the president's office. We wish for the presidentelect all the acumen and strength that will be required."

The Grand Forks Herald, in an editorial headed "Hail To New Chief," said in part, "Dean Clifford will immediately be aware of the needs, problems and opportunities of the school. He will not have to be meeting a new faculty and a new governing board. As Dr. Starcher said after the announcement of his successor's selection, 'he is in many ways uniquely equipped for the tasks that lie ahead'."

As Dr. Thomas J. Clifford received word of his appointment, he said he was "thrilled, honored, surprised, incoherent and deeply appreciative." When congratulated by Dr. Starcher, he said, "you're a tough act to follow." Clifford intends to visit with all segments of the University before taking office on July 1, and to determine a short term and long term planning process of priorities. UND has an en-

rollment topping 8200 (first semester), a faculty of 600 and 2,000 other employees.

When President Starcher retires on June 30, he will have served as UND president for 17 years, the third longest tenure of any UND president. His predecessor, John C. West, holds the record for longest tenure (21 years) from 1933 to 1954. Webster Merrifield also topped the Starcher tenure, heading the institution for 18 years from 1891 to 1909.

The first president of UND was William M. Maxwell, an ordained minister, who served during the first academic year, 1884-1885. He was succeeded on an acting basis by Henry Montgomery, who served for two years before Homer B. Sprague became the second UND president with a regular appointment, serving from 1887 to 1891.

Merrifield succeeded Sprague and headed the University until he resigned in 1909; Merrifield Hall is named in his honor. Frank L. McVey succeeded Merrifield, and was the first president to hold a doctorate except for Maxwell who was a doctor of divinity. In 1917, McVey resigned to become president of the University of Kentucky, holding that position for 23 years.

A member of the UND faculty for 36 years, Earle J. Babcock was named acting president after McVey, until the appointment of Thomas F. Kane, who served as UND president for 15 years, from 1919 to 1933, retiring at the age of 70.

John C. West succeeded Kane, having served as Superintendent of Schools in Grand Forks; he retired in 1954, when Dr. Starcher took over the reins of UND. During his tenure the University has made its greatest growth.

SEARCH BEGINS

The search for a new Dean of the UND College of Business and Public Administration has begun to select a successor to Dean Thomas J. Clifford, who will become president of UND on July 1. The committee is headed by R. D. Koppenhaver, chairman of the UND accounting department, who hopes to have a replacement by July 1.
