Campus Awaits Alumni for October 7-9 Homecoming

The stage is set on the UND campus for an activity-laden schedule of attractions for alumni and friends on October 7-9 to mark Homecoming '71.

October 7 opens with the fall meeting of the Alumni Board of Directors, beginning with luncheon and climaxed with a dinner.

Registration begins at 9 a.m. Friday, October 8, for the all-

day session of the 190-member UND Alumni Advisory Committee in Leonard Hall.

Highlight of Friday will be the Alumni Awards luncheon, honoring five North Dakota graduates. The Sioux Award winners are featured elsewhere in this issue.

Friday night's schedule includes a buffet at Westward Ho for the Award Winners, Advisory Committee, Alumni

Board members and special guests. The UND Lettermen's Club will hold a smorgasbord at the Golden Hour.

Saturday gets rolling with Lettermen's breakfast and annual meeting, a breakfast to honor state and city chairmen of the UND Development Fund, followed by a reception for UND President and Mrs. Thomas Clifford at the University Center, along with

Campus tours. A smorgasbord at the University Center precedes the 1:30 p.m. kick-off for the football game between the Sioux and South Dakota State Jackrabbits, followed by open houses at the residence units.

The day wraps up with an All-Alumni party at the Westward Ho with a buffet dinner and dancing.

190-Member Advisory Committee to Meet October 8

The 190-member UND Alumni Advisory committee will hold an all-day meeting on the campus October 8, in conjunction with Homecoming activities, according to J. Lloyd Stone, executive vice president.

This will be the 26th annual meeting of the committee, made up of UND alumni and leaders from throughout the nation, and will include the entire membership of the UND Engineering Alumni Council.

Dr. Edgar Dale of Ohio State University will serve as meeting chairman. He is a UND alumnus and nationally recognized authority on the educational use of audio-visual materials.

While on campus, the com-

mittee will be briefed on UND's plans and programs, and will have an opportunity to meet with University administrators, faculty and students. The committee will be divided into nine meetings which will focus on different UND academic programs. These will include arts and science, business and public administration, education, engineering, fine arts, graduate studies, law, medicine and nursing.

Registration will begin at 9 a.m. in Leonard Hall, followed by a general session. Also scheduled are a luncheon and evening buffet.

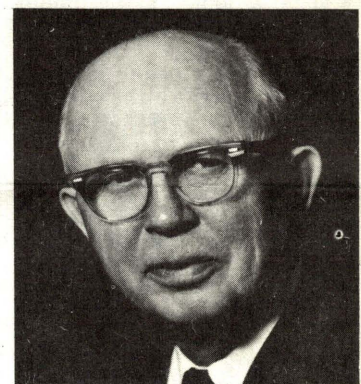

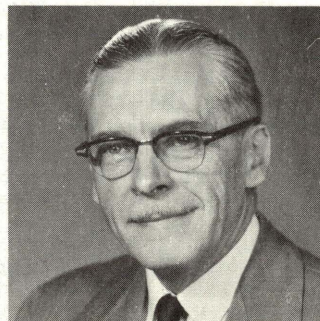

Four UND Faculty Members to Receive Alumni Grants



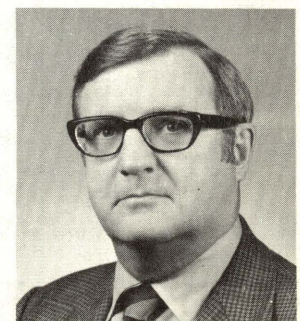

There will be many highlights of this particular Homecoming, and one of them will be a full day session of the Alumni Advisory Committee, as reported elsewhere in this issue. It's the strong assistance that is given the University from these leaders that is so vital to continued growth, and your thanks — and mine — should be given each member of this advisory group.

Take a look at the photograph on this page that accompanies this column. It expresses a significant day last August 26, when the University of North Dakota said "thanks" to Senator Milton R. Young.

The photograph shows Senator Young receiving the "President's Medal" from UND President Thomas Clifford. It is the highest award the University President can give.

In making the presentation to Senator Young, President Clifford noted that the face of the medal was inscribed with these words: "seek knowledge, gain wisdom and render love for humanity through greater service," and said that these attributes described Young so very well.

Earl Strinden, my able assistant, presented a new putter to the Senator, who is an avid golfer. The putter bears the UND seal, and was "guaranteed to one-putt any green if the seal were properly lined-up with the hole."

Seated in the photograph is Dr. W. E. Cornatzer, head of the UND Biochemistry Department, who also paid tribute to Senator Young, who was instrumental in obtaining federal funds for the new U.S. Department of Agriculture Human Nutrition Laboratory on the campus.

Other speakers praised Senator Young for his assistance in getting help for other UND projects including the sea and coal research projects, the new Federal Aviation Administration program to train air controllers and others.

Senator Young has depos-

ited some of his official papers in the Chester Fritz Library at UND. Daniel Rylance, archivist at the library, called the Young papers a "fantastic historical record of his career in Washington, D.C."

Senator Young was also in attendance at a history-making ceremony on August 27, when Paul Benson of Grand Forks became the seventh U.S. District Judge for the District of North Dakota since statehood.

Benson was sworn in by Judge Ronald N. Davies, who was also in private law practice in Grand Forks before his appointment to the bench. Judge Davies was also a member of the UND Alumni Board of Directors.

A goodly number of UND Law School graduates were on hand for the swearing in ceremony of Benson, who grew up on a North Dakota farm, worked his way through the University of North Dakota, and lived in "Camp Depression" during his college days on the campus.

We add our tributes to both Judge Davies and Judge Ben-

son, and are proud that both of them are UND graduates.

Four Faculty Members Receive Alumni Grants

Four members of the University faculty will be recognized for their teaching excellence by the Faculty Awards Committee of the UND Alumni Association and presented with \$250 cash awards at the Alumni Awards Luncheon October 8.

The Mr. and Mrs. Charles de Bruyn Kops award of \$250 each will be made to Miss Valborg Oslund and to Philip A. Rognlie. This fund was made possible by children of the Mr. and Mrs. de Bruyn Kops.

The children all attended UND and include: Alice S. de Bruyn Kops, Walnut Creek, Calif.; Charles W. de Bruyn Kops, Oakland, Calif.; Marguerite de Bruyn Kops McClintock, Solebury, Pa.; and Paul F. de Bruyn Kops, Orinda, Calif.

Miss Oslund has been on the UND faculty since 1946 and holds her bachelor and masters degrees from UND. She was named associate professor in the English department in 1966 and has served on many administrative committees and advisory committees.

Rognlie is associate professor of mathematics and received his bachelor of science degree and master of science degree from UND. He is a member of the Mathematical Association of America and has been active on numerous University committees.

The B. C. Gamble Faculty Awards of \$250 each will be

made to Prof. Charles C. Bullard, chairman of the UND College of Business economics department, and to Prof. Lyle C. Steinmeier, professor of accounting and business law.

The grants are made possible by contributions from the B. C. Gamble and P. W. Skogmo Foundations and recognize excellence on the part of faculty in the College of Business.

Professor Bullard has been on the UND faculty since 1948, and has been chairman of the economics department since 1961. In 1969 he became executive director of the newly founded North Dakota Council of Economic Education and executive director of the UND Center for Economic Education.

A native of Bottineau, Professor Steinmeier earned his masters degree from UND in 1948, and was in the accounting department as an instructor from 1958 to 1962, before moving to Minot to teach in the UND AFIT Minuteman Program. In 1965 he rejoined the University faculty in Grand Forks.

U Enrollment Shows Increase

The fall enrollment of 8,395 at UND marks a 3.27 percent increase over the first semester enrollment of last year and is another all-time record high.

"The enrollment on the Grand Forks campus exceeded the expectations," said UND President Thomas J. Clifford. "Considering the leveling off—in some cases, decreasing—college enrollments nationally, we are delighted with our substantial and significant enrollment."

With the UND-Williston Center enrollment of 482, the combined total of both campuses is 8,877. A significant increase of 25 percent in new transfers to UND helped make the record total.

Even though football is of prime interest now, UND winter sport coaches and their athletes have started training for rapidly approaching seasons. Generally, the Fighting Sioux outlook in winter sports is good.

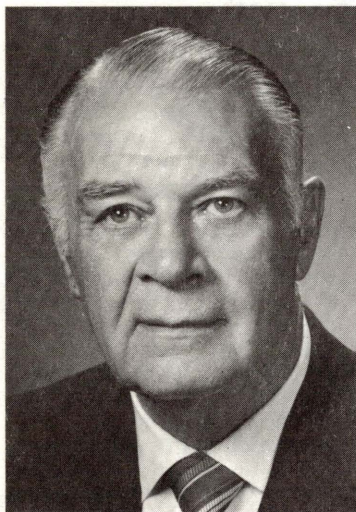
In football the Sioux opened with a 17-15 victory over Montana State at Billings, Mont. Alumni in that area attended the game and had a fine get-together before the contest.

Coach Rube Bjorkman has his 50 hockey candidates in daily running sessions in preparation for daily practice sessions on ice October 1 in the "old barn." UND opens its regular season November 12-13 here against Notre Dame, newest member of the Western Collegiate Hockey Association, of which UND is a charter member. UND will play 32 games, 16 at home. Leading a group of 15 returning hockey lettermen are co-captains center Brian DePiero and defenseman Rick Wilson.

Basketball practice doesn't start until October 15, but the cagers also will be in daily running sessions for physical conditioning. Coach Dave Gunther will be working with 16 varsity candidates, which includes five lettermen and four returning starters. UND will have three junior college transfers on its cage team. Competition in the North Central Conference this season will be tough, since five of the eight teams have not lost a starter. The Sioux cagers will play 25 games, 12 at home. UND opens the season December 1 at University of Minnesota.

There are thousands of outstanding lawyers who have earned their degrees from the University of North Dakota but none has worked more diligently for his Alma Mater than William T. DePuy.

A native son, he is a senior partner in the law firm of DePuy, Fair and O'Connor in Grafton and is city attorney in that community. He has been special assistant attorney general for the State Highway Department, State Tax Commissioner, assistant states attorney for Benson and Walsh Counties and he is the retained attorney for several groups in North Dakota.

While attending UND he was a Cadet Colonel in the ROTC and was a member of the U.S. Army Reserve for six years. DePuy served for nine years on the UND Alumni Board of Directors and is a past National Chairman of the University Development Fund.

His business career includes serving as a director of the Walsh County Bank in Grafton, the Hebron Brick Co., the Community Rental Corp., the Unity Hospital, and the Northern National Life Insurance Co. He is a past president of the Grafton Civic Club.

DePuy's interest in the University is shared by his family; his wife, the former Madelyn Colton, '27, one son and daughter attended UND, and his wife served on the Alumni Board of Directors.

Dr. Robert M. Fawcett is an internal medicine specialist at Devils Lake with a very busy practice who still found time to serve for nine years as a dedicated member of the UND Alumni Board of Directors.

Born in Starkweather, N.D., Dr. Fawcett attended UND from 1933 to 1938, then received his medical doctor degree from the University of Pennsylvania. He received a master of science degree in medicine from the University of Minnesota Graduate School in 1947.

Dr. Fawcett was elected to Phi Eta Sigma and Phi Beta Kappa while at UND, and was honored with a Grey Gown. During World War II he served at the 237th Station Hospital in New Guinea and the Philippine Islands.

He served on the Board of Education in Devils Lake for three years and as a director of the Chamber of Commerce.

Dr. Fawcett is a past president of the North Dakota Heart Association, a member of the North Dakota and American Medical Associations, the American Heart Association and is a Fellow of the American College of Physicians. He was governor of the American College of Physicians of North Dakota for six years.

Since 1948 he has been a specialist in internal medicine with the Lake Region Clinic. He and his wife, Margaret, have two daughters, both UND graduates.

Donald R. Heistand is another native of North Dakota who joined a major United States firm as a graduate student and then advanced in a lifetime career with the company to become a top executive.

It was back in 1940 that Don Heistand received his Bachelor of Science degree from UND. He was active on campus, serving as president of his fraternity, of the interfraternity council, assistant homecoming chairman, and was active in bands and orchestras.

Hiestand joined Westinghouse in 1940, with his first responsibilities as an industrial engineer. He has moved up the career ladder with Westinghouse since that year, and today is manager of Industrial Relations of the East Pittsburgh Divisions, which is made up of 11,500 employees.

His responsibilities include labor contract negotiations, contract administration, employment, medical, insurance, pension and a host of other areas under the heading of industrial relations.

Hiestand has moved from several communities during his assignments with Westinghouse, yet found the time to serve actively on civic boards such as the Community Chest, Urban League, Chamber of Commerce, Church Council, Symphony Orchestra, Kiwanis, Red Cross and Township School Director.

He is married to the former

The career of James F. Seifert for the past 20 years is almost like a story from the Horatio Alger vintage, with a North Dakota son growing from a one-store operation to a 19-store chain with sales in the millions of dollars.

Seifert, president of Seifert's Stores for Women, earned his degree from the UND School of Commerce in 1950, and was a member of Blue Key Honor Society, the Interfraternity Council and president of ATO.

After serving in Korea in the U. S. Air Force for two years, he began his business career by forming a partnership with his brother, and opened a women's specialty store in Washington, Iowa. Today there are 19 Seifert's Stores for Women employing more than 500 people.

His firm was the first apparel group in Iowa to employ data processing in the accounting and merchandising of women's wear, and the firm has its own computer center in Washington, Iowa, while the main merchandising center is in Cedar Rapids.

Seifert is married to the former Nancy Lou Dunlevy, a 1951 graduate of UND, and they have three children and make their home in Cedar Rapids.
