## Clifford Inaugural Ceremonies Set for April 14

UND alumni from throughout the Greater Grand Forks area, as well as the nation, will be among those in attendance at inaugural ceremonies on the campus Friday, April 14, honoring Thomas J. Clifford as the eighth president of the University of North Dakota.

Clifford has served as UND president since July 1, 1971, and is the first native of North Dakota to serve as president of the state's largest institution of higher learning.

The ceremonies will begin at 10:30 a.m. at the UND

Fieldhouse, following registration and an academic procession at 10:15 a.m. made up of visiting representatives of colleges, universities, learned societies, UND faculty, members of the State Board of Higher Education and other dignitaries.

Governor William L. Guy will present greetings, as will representatives of alumni, faculty and students. Rev. Peter Hinrichs, chairman of the State Board of Higher Education will conduct installation ceremonies, followed by an inaugural address by President

Clifford. A luncheon for guests will follow the ceremonies.

A symposium at 2:30 p.m. in Leonard Hall will be held under the theme of "The University and the State," while the inaugural activities will include a concert by the University Choral Union at 8:15 p.m. in the UND Fieldhouse. Sebastian Cabot, actor and television performer, will be a featured guest star at the concert, providing narration.

Dean D. J. Robertson is chairman of the inaugural committee, assisted by Dean

M. L. Cushman, Dr. Vera Facey, Dr. Harvey K. Jacobson, Ludwig Kulas, Dr. John S. Penn, Dr. Gerald Potter, LaVonne K. Russell, and Earl S. Strinden.

Charles Goodman of Grand Forks will represent alumni and the community, while student committee members include Kathleen Ryckman Anderson, Pollock, S.D., and David R. Olson of Valley City.

Clifford joined the UND faculty in 1945 as an instructor in accounting and business law, and held administrative

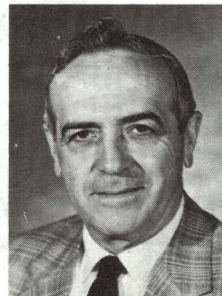

# REPORT from the CAMPUS

Before leaving on the tenth UND Alumni Tour, I stopped in to chat with Dr. George Abbott, professor emeritus of UND. Dr Abbott will be 98 years old on July 7, 1972. He came to the University in 1910 and has known it intimately for some 62 years. The Abbott Chemistry Building, dedicated in 1962, is named in his honor. Following are some observations made by Dr. Abbott:

... I consider it a great honor that my good friend, Lloyd Stone, asked me to take over his column during his tour of the Greek Islands.

I came to the University in 1910, from what was then the Agricultural College in Fargo. I had been "decoyed" to North Dakota from my Indianapolis home and had just received my doctorate in chemistry from MIT. It may interest some that I am the only survivor of six who received the first Ph.D. degrees in chemistry from MIT.

President McVey invited me to organize the first separate chemistry department at the University. Chemistry had

been taught by School of Mines Dean Earle J. Babcock, and he was reluctant to give it up. But he was persuaded to do so!

When I first came to North Dakota, I wondered how a human could live in a climate like this. It didn't take me long to blossom-out in fur-collared coat and fur cap, replacing my derby hat and velvet-collared overcoat.

I had the honor of working with some great men at the University during those early days. One was A. Hoyt Taylor, who became world famous, but few people here have honored him. He was considered the father of radar, and was a pioneer in every sense of the word.

The University has always had great students. I love the students today, as I love all young people, and my life has been devoted to them. The great mass of today's students are better students than we were, and are far advanced beyond what we were at their age.

The ideals of men are not new, and the Golden Rule acquires a new luster when you make it a slide-rule by which to measure daily conduct. If young people today live by principles, they cannot help but add to man's accomplishments. I have seen the accomplishments of our University, growing from a small family affair to a modern university with more than 8,400 students.

Likewise, I have witnessed great accomplishments in the scientific areas. I saw man struggle to get off the ground, then launch himself into space. I watched science and technology become what they are—age after age successively. Man would never have landed on the moon without the coordinated effort of all the major sciences. It shows that we must work in a unified manner—and in doing so, we can perform miracles!

If the present generations think they can dispense with scientific research, they are sunk. I have said this many times. The great masses are

content to go through life—without much question or thinking. They accept fire, the hatching of an egg, the attraction of iron to a magnet, and even the splendor of the heavens, much without curiosity or emotion.

They are content to bask in the blessings that applied science has bestowed upon them. They enjoy luxuries far beyond the reach of ancient kings, but accept it all, much as the fish accepts the ocean. They just swim in it.

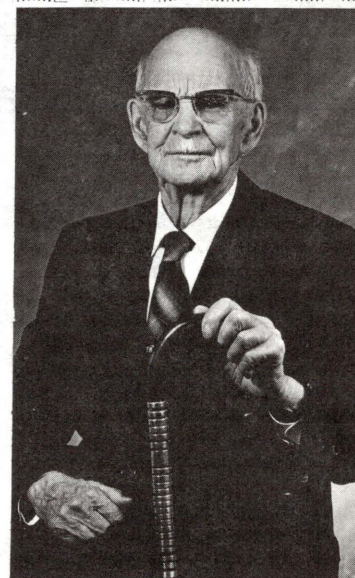
Fortunately for humanity, there have been a few great creative minds through the ages who have the simplicity to wonder, the courage and energy to investigate, plus the capacity and willingness to apply their discoveries and inventions to the benefit of their fellowman.

Like Atlas of Greek mythology who lifted the world on his shoulders, they have lifted their world on their giant shoulders and borne it to higher plains of living.

But most of us have been dropped like paratroopers into a world in which we rightfully do not belong and which—for the most part—we do not understand. Science makes us change our ways of living—but we don't let it change our modes of thought and feeling... they are the same as they were in the days of our ancestors, before science developed. It is still a question whether man has given humanity a horse it can ride!

... everything we have is the product of prior generations who have built it up, step by step. Without that cumulative effect of human effort, our world would never be what it is...

(ED. NOTE: Dr. Abbott developed many other of his philosophies about life, but space imitations required abbreviation for this column. He is a man who will be eternally young in spirit; he is constructive in his viewpoints, and so interested in his fellowman. About five years ago (September 13, 1966), Dr. Abbott awakened in the middle of the night from a dream. It

## Sioux Whip 'No. 1' Teams In Three Major Sports

Athletically, 1971-72 was successful at UND. It will be remembered as the season the Sioux whipped national leaders in three sports and as the final year in the old Winter Sports Building.

Alumni and friends may have read in Sports Illustrated magazine in February of the "Giant Killer" role their teams played as UND defeated national leaders in hockey, football and basketball. Nodak skaters began the ambush capers against Michigan Tech in the WCHA playoffs in March 1971, winning 6-4. Tech was ranked first in the country.

After six years of frustration UND crushed ND State in football, 23-7, October 16, 1971 at Fargo, giving the number one ranked Bison minus 11 yards total offense.

Eau Claire (Wis.) State, ranked number one in the country in two polls, suffered its only regular season loss to UND, 73-70, January 24, 1972. None of the three wins by UND were flukes.

March 8, 1972, in all probability will be recorded as the date of the final hockey game in the Winter Sports Building, affectionately called the "old barn" by fans and players. Built in 1936, through WPA assistance, the old arena served well, and many have memories of great UND triumphs there.

### HANGSLEBEN HONORED

**Alan Hangsleben was named in March to the All American Hockey Team as a defenseman, marking one of the rare occasions that a freshman has been so honored.**

UND played 394 games in the old facility, winning 254 and tying 22 for a winning percentage of .673. In the final series the Sioux hammered an old nemesis, University of Michigan, 5-1 and 10-2. Fittingly the final goal was scored by freshman center Gary Purper, son of the legendary Cliff (Fido) Purper, who coached the Sioux 1949-56.

UND finished third in the

WCHA race with an 18-10 record and had a fine 21-14-1 season mark, including a 1-1 tie in the WCHA playoffs against Wisconsin. Had the Sioux beaten Wisconsin once more at Madison they would have earned a seventh UND trip to the NCAA finals at Boston.

Head hockey Coach Rube Bjorkman would be reluctant to single out players. Three skaters earned post-season honors. Junior center Jim Cahoon and freshman defenseman Rick Wilson was picked on the second team. Hangsleben was also named Freshman of the Year by a wide margin. WDAZ-TV of Grand Forks and Devils Lake, N.D., instituted its first annual All WCHA team, selected by all WCHA players themselves. Hangsleben was named on that team and Cahoon was voted to the second unit.

It was a great hockey season and with five seniors departing, all quality players, Coach Bjorkman thinks we can begin 1972-73 in our new 5700-seat arena with a strong nucleus. The seniors, in addition to Wilson, are center Brian DePiero, wings Dave Bragnalo, Greg Cameron and Mike Lundbohm.

UND posted a good 18-7 basketball record and tied for second place in the North Central Conference race, which was not decided until the final game of the season. UND was considered for the NCAA post-season college division midwest regional tournament at St. Louis but to the dismay of many was not selected. Coach Dave Gunther and the Sioux were great.

Senior guard Craig Skarperud and senior center Chuck Dodge were named to the All North Central Conference team. Other seniors on the team were guard Jon Tufte and reserve forward Ed Fick.

Our swimming and gymnastic teams both placed third in conference meets, and our wrestlers continued to work hard all season.

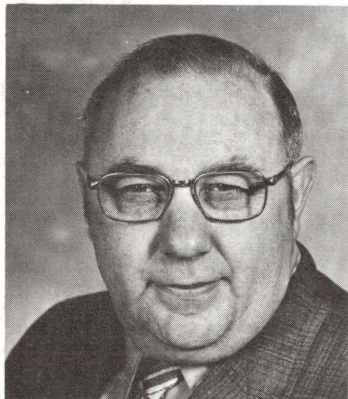
