The impact of the Ukraine invasion has affected the UND community especially to our armed services members taking classes.

RATIONALE:

WHEREAS the North Dakota Century Code (NDCC) <u>Chapter 15-10.4</u> and the State Board of Higher Education (SBHE) <u>Policy 401.1</u> affirm the importance of academic freedom to the proper functioning of universities, in line with the American Association of University Professors' <u>1940 statement of Principles on Academic Freedom and Tenure</u>, by virtue of which faculty, who are experts in their respective disciplines, have responsibility for curriculum; and

WHEREAS state legislative proposals are being introduced across the United States that target academic discussions of subjects considered divisive, difficult, controversial, or challenging in schools, colleges, and universities; and

WHEREAS educating about our nation's history of racism, sexism, and gender discrimination is critical to the active and engaged pursuit of knowledge necessary to produce engaged and informed citizens in a multiracial democracy; and

WHEREAS failing to teach the history of racism, sexism, and gender discrimination is manifestly an incomplete and therefore misleading account of our nation's history that would tend to impede progress on equity and justice; and

WHEREAS institutions of higher education have a responsibility and opportunity to help build equity and advance justice through evidence-based curriculum; and

WHEREAS diversity and an understanding and appreciation of diverse people, experiences, and ideas are part of the <u>mission and core values of the University of North Dakota (UND)</u>; and

WHEREAS legislation preventing evidence-based teaching of race, gender, and other topics from university instructional curricula poses a threat to continued institutional and program accreditation from the Higher Learning Commission and/or other accrediting bodies; and

WHEREAS North Dakota is currently facing a <u>workforce shortage of K-12 teachers</u> and a recent <u>North Dakota United poll</u> found that an increasing number of K-12 teachers have considered or are already leaving the profession, as they <u>experience pressure to not teach "controversial" topics</u>; and

WHEREAS the K-12 environment is relevant to UND as it delivers dual credit courses and has Teacher Education programs that, by design, prepare future teachers within the K-12 system and state legislation banning discussions of race, gender, and other topics works against campus efforts to recruit and retain students in the state; and

WHEREAS the education received in K-12 provides the foundation for higher education and directly impacts the nature and quality of learning that students can achieve at the college/university level; and

WHEREAS UND's Senate acknowledges and respects existing constraints on speech that is illegal, defamatory, threatening, harassing, or that impedes the work of the ND University System;

RESOLUTION:

THEREFORE BE IT RESOLVED that the UND Senate steadfastly upholds the principles of academic freedom and the independence essential for institutions of higher learning in allowing for students and faculty to explore and educate themselves on any topic deemed of value to students and faculty.

BE IT FURTHER RESOLVED that the UND Senate resolutely rejects any attempts by bodies external to the faculty to restrict or dictate university curriculum including matters related to race, gender, and other topics.

BE IT FURTHER RESOLVED that the UND Senate stands with our K-12 colleagues throughout the state of North Dakota and other U.S. States who may be affected by restrictive legislation when they teach from diverse evidence-based perspectives in U.S. history and civics education.

BE IT FURTHER RESOLVED that the UND Senate affirms the <u>Joint Statement on</u> <u>Efforts to Restrict Education about Racism</u>, authored by the American Association of University Professors (AAUP), PEN America, the American Historical Association, and the Association of American Colleges & Universities, endorsed by over seventy organizations, and issued on June 16, 2021.

BE IT FURTHER RESOLVED that the UND Senate affirms the statement on Open Academic Inquiry and Vigorous Debate released by the American Council on Education (ACE) and more than 90 other higher education groups, issued on March 3, 2022; and the Resolution on Defending Academic Freedom adopted by the North Dakota University System Council of College Faculties on March 1, 2022.

WHEREAS the K-12 environment is relevant to the North Dakota University System (NDUS) as many of our institutions deliver dual credit courses and our campuses have Teacher Education programs that, by design, prepare future teachers within the K-12 system and state legislation banning discussions of race, gender, and other topics works against campus efforts to recruit and retain students in the state; and

WHEREAS the North Dakota Council of College Faculties (ND CCF) acknowledges and respects existing constraints on speech that is illegal, defamatory, threatening, harassing, or that impedes the work of the ND University System;

Review of Goals

The goals/plans for 2021 - 2022 were outlined at the end of the previous academic year with goal #5 added at the beginning of the 2021-2022 academic year as follows:

- Review assessment data to develop recommendations for the University Senate and UND
 Online
- 2. Define what "successful" retention of online students means
- 3. Work with UND Online to better track online students
- 4. Develop retention strategies for online students
- 5. Understand the different modes of course delivery including online and face-to-face.

Summary of Committee Activities for 2021 - 2022

The Senate Online and Distance Education Committee met 6 times per Zoom during the 2021 - 2022 academic year (more specifically between September and March), with one additional meeting scheduled in April after the submission of this report. Rhoda Owens serves as Chair and Heather Terrell served as Past Chair during the 2021-2022 academic year. Jennifer Reichert was elected as Vice Chair for the 2021 – 2022 Academic Year and will serve as Chair for the 2022-2023 Academic Year.

- Fall semester, the committee reviewed the survey data reports containing the data results collected during the 2020-2021 academic year by the subcommittee. Originally this survey was done because the committee decided to prioritize Item 6 of the committee's goals: "What was learned from the rapid shift to all remote instruction and how that can inform future needs of the university in terms of expanding online instruction?" Another purpose of this survey was to create an opportunity to gather information about how the university can better meet the needs of its students in the future. Lastly, the information gained from this assessment may be useful to the Task Force for the Future of Education at UND, or in the implementation of the Task Force recommendations. Three Qualtrics surveys (students, staff, and faculty) were emailed and posted to the Blackboard shells from April 8, 2021, to May 6, 2021. Subcommittee members included Heather Terrell, Rhoda Owens, Tim Burrows, Lynette Krenelka, and Amy Carlson. The report was made available on the shared committee's TEAMS site. The survey results are available to committee members and other UND committees upon request. The UND On-Line team prepared reports from the data results of the three surveys and shared the results February 2022 with the Provost and Deans (see attached reports).
- During the fall semester, members reviewed the committee's charge (functions/responsibilities, purpose) and goals for the 2021 – 2022 academic year.
 These documents were used to guide the committee's work throughout the year.

- To meet Goal #5, UND's registrar's office presented on the definitions for modes of course delivery. The terms and definitions are used by NDUS and available on the website.
- The committee served as a forum for members. Committee work primarily focused on updates about the ongoing challenges associated with online student recruitment, retention, and learning and access to academic technologies. Faculty development opportunities on best practices for online/distance students offered by TTaDA were communicated to members. Committee members advised UND Online, TTaDA, and Senate as related to the committee's charge and goals. In addition, changes and updates were provided to the committee members to help meet our six goals for the 2021 2022 academic year. All pertinent information was communicated and disseminated to colleges and departments by committee members.
- A subcommittee including members from SODEC to begin assessing and evaluating how online faculty are evaluated by students for teaching effectiveness and excellence. At present, the SELFI is used to evaluate all faculty in multiple teaching roles (faciliatory, course lead, course developer, instructor, etc.).
- During the Spring semester, the committee discussed the current charge of the
 committee and how best to spend our time as a committee during the 2022-2023
 academic year. The committee identified three primary roles or areas of focus for the
 near future (the current academic year and 2022 -2023 academic year), all of which fall
 within the purview of the current committee charge:

Goals for the 2022-2023 Academic Year

- Advise UND Online and TTaDA in determining initiatives based on the SODEC Faculty,
 Staff, and Student survey results.
- Communicate online instruction faculty development opportunities to department faculty that are offered by UND, TTaDA, and other outside organizations.
- Develop strategies to promote diversity, equity, and inclusion content in online education courses.
