Campus Plans for Homecoming '72

Alumni Advisory Group to Meet On Campus

Friday, October 20, will be a full day for members of the UND Alumni Advisory Committee, who will spend many hours in meeting and discussions, designed to give advice on guidelines and plans for the University of North Dakota. All sessions will be in the University Center.

Registration and coffee occupy the hour from 8:45 to 9:45 a.m., with assembly in the Lecture Bowl to follow from 9:45 to 10:30 a.m.

The committee will then separate into special groups and hold sessions in seven areas, beginning at 10:45 a.m. Luncheon is slated from noon to 1:30 p.m., when group meetings will be completed and summations prepared.

A second general assembly at 2 p.m. will be held in the Lecture Bowl, with summations, reports and discussions.

At 4 r.m. a campus tour of new buildings is scheduled, followed by a social hour and (Continued on Page 3)

Gamble to be Presented With Roughrider Award

A special highlight of the 1972 Homecoming ceremonies will be the presentation of the Teddy Roosevelt Roughrider Award to Bertin C. Gamble, chairman of the board of Gamble-Skogmo, Inc. and a long-time UND benefactor. The presentation will be made by Gov. William L. Guy, who conceived the award in 1961, at a special Roughrider Luncheon on October 20 on the UND campus.

The award came into being during the Dakota Territory Centennial celebration and is designed to honor those North Dakotas, or former North Dakotans, who have achieved national or internationally recognized success in their chosen fields, and have been influenced by their life in North Dakota in achieving that success. The North Dakota State Legislature made the award official in 1963.

The award includes a wall plaque with the bust of Theodore Roosevelt and an inscribed steer hide that are given to the recipient. In addition, his portrait will be done in oil and hung in the State Capitol lobby.

Gamble becomes the 12th recipient of the award; previously honored have been Eric Sevareid, Dorothy Stickney,

Gamble was born in Hunter, N.D., where his father was a partner in a general store. When Gamble was seven years old, his family moved to Arthur, N.D., where he met his future partner, Phil Skogmo. After finishing high school, he went to Minneapolis where he worked for a dairy (Continued on Page 6)

Busy Oct. 20-21 Slated for UND Alumni

The stage is set on the UND campus for the 1972 Homecoming with everything "all put together" for one of the memorable events in alumni history on October 20-21.

Enrollment Levels Off At 8,282

Final enrollment for the fall semester at UND totals 8,282, a 1.35 percent decline from the enrollment of last fall. University officials indicate that the enrollment follows a national pattern and represents a leveling off of the state's college-age population. The UND enrollment decline is spread quite evenly through its classes and academic divisions. High interest in the health fields is reflected in a 13.8 percent gain for the College of Nursing, while the Graduate School enrollment rose 7.6 percent.

FUNDS ALLOCATED

Federal funds in the amount of \$14,000 have been allocated to help finance a loan for purchase of the McCannel Hall building on the campus for use as a student health center. The U.S. Department of Housing and Urban Development has allocated \$14,000 to guarantee interest payments in excess of three per cent on a \$500,000 loan. The interest subsidy will be applied to the purchase of McCannel Hall at a cost of \$750,000.



Sioux Awards

JUDGE PAUL BENSON

There are many UND graduates who have the title of doctor, or professor, or mister or reverend or miss or mrs. and now even ms., but few are eligible to carry the title of judge. One of these is Judge Paul Benson, Chief Judge of the United States District Court for the District of Fargo.

A native of Verona, N.D., he earned his bachelor's degree at UND, continuing his education at George Washington University where he received his LL.B. degree. He was named to Blue Key fraternity while attending UND.

Judge Benson served as a Lieutenant in the U.S. Navy in World War II for four years and was executive secretary and assistant to Senator Milton Young from 1946 to 1949.

He entered the practice of law in 1950 in Cavalier, moving to Grand Forks in October of that year to join the firm now known as Shaft, Shaft McConn and Fisher. From 1954 to 1955 he was attorney general for the state of North Dakota.

Judge Benson is a member of the American Bar Association, the American Judicature Society, the North Dakota State Bar, and served as President of the Grand Forks County Bar. A former Chairman of the Grand Forks Chapter of the Red Cross, he holds membership in the Elks, Masons, Shrine, American Legion and VFW.

His wife, the former Laurel Johnson of Grand Forks, attended UND for two years. They have five children—including two daughters, Polly Benson Diem, '71, and Santal Benson Manos, ex '69, who attended UND. The Bensons make their home in Fargo.

William L. Brewer, '71, is a social service worker II for the Towner County Welfare Board in Cando, N. D. He was married in August to Anne Mary Hermes.

(Continued from Page 1) supply firm and then enrolled in a business school.

Gamble teamed up with his school friend, Skogmo, to operate a Hudson-Essex automobile dealership, and later Ford dealerships as well, in Fergus Falls, Minn. In 1925 the partners opened the first Gamble's store in St. Cloud, Minn., featuring a selection of automobile parts and accessories.

By 1969, Gamble-Skogmo, Inc., had expanded this modest beginning into a retail chain with over 4,200 outlets in 39 states and Canada, making Gamble-Skogmo the 19th largest retailer in the nation. Besides still dealing in automobile accessories, Gamble-Skogmo interests now stretch from home appliances to wearing apparel, from banking to sporting goods.

During his early business years in Fergus Falls, Gamble married the former Gladys Lucille Pearson in 1927. They now make their home in Wayzata, a suburb of Minneapolis.

In recognition of Gamble's business accomplishments, the University of North Dakota conferred an honorary Doctor of Laws degree upon him in 1965. That year Gamble-Skogmo contributed \$15,000 to the UND faculty improvement program and \$25,000 for the B.C. Gamble Student scholarship program.

In 1967 the B. C. Gamble and P. W. Skogmo Foundations contributed \$200,000 to UND to furnish and equip a new classroom building at UND. This contribution provided the impetus for federal and state funds for the construction of Gamble Hall, one of UND's largest classroom facilities. The building, which serves as the home of the UND College of Business and Public Administration, was completed in the summer of 1968.

Bertin C. Gamble, wrote Newsweek magazine in October of 1962, exemplifies one of the most cherished of American folk heroes: "the industrious small-town boy who scrambles from humble origins to emerge as a dauntless captain of commerce."

Fritz Establishes Fund For Distinguished Faculty

Chester Fritz, a University of North Dakota alumnus and benefactor now living in Switzerland, has given the University \$100,000 to establish a permanent fund for distinguished professorships.

The gift from the international investment banker will provide for the annual presentation of grants of \$2,000 each to at least three fulltime UND faculty members. The awards will be known as the Chester Fritz Distinguished Professorships.

Fritz referred to his gift as an "investment in the future of my alma mater and of the people who make that future what it shall be." A Lidgerwood high school graduate who enrolled as a freshman at UND 64 years ago, Fritz said, "I am especially indebted to the fine teachers who, in the end, have determined, in large measure, how I was able to learn and to use the knowledge that the University of North Dakota could provide."

Fritz said the gift was also offered "because the greatness of any university depends, to a very great extent, upon the quality of its individual faculty members."

Fritz proposed that the professorships be "awarded to the University's most distinguished professors as special recognition of their excellence and contribution to the development of young men and women and to the advancement of knowledge and learning which are the primary purposes of a university."

The Chester Fritz Distinguished Professorships are the first endowed professorships in the 89-year history of the University. "We feel that the professorships will have a real impact on quality instruction and will also be an inspiration to faculty members," said Pres. Thomas Clifford in announcing the gift.

The names of faculty members chosen to receive the first professorships will be announced at UND's Founders Day in February.

The professorships program will be administered by a committee of five, including the UND president, the vice president for academic affairs, the president of the student body, the president of the University Senate and a full-time member of the teaching and research faculty appointed by the president of the University. The committee will devise its own procedures for selection of the Chester Fritz Distinguished Professors.

Born at Buxton, Fritz attended UND in 1908-10. He completed his work for a baccalaureate degree plus a year of law at the University of Wash., graduating in 1914.

In 1915 the Fisher Flouring Mills for whom he had been working in Seattle, Wash., sent him to the Orient on business. In a few years he became the representative in the Orient for the American Metal Company, and later helped organize the international investment banking firm of Swan, Culbertson & Fritz, with headquarters in Shanghai, and other offices in Hong Kong, the Philippines, and South America. With time out for eight tours around the world, he lived in the Orient for 34 years.

Fritz's gratitude to his home state and UND has remained constant. He has been making what he calls "partial repayments" to the taxpayers of the state and to the University for what they contributed to his education.

Prior to 1950 Fritz gave UND more than \$31,000 for various projects. In 1956 he established six University scholarships and since then the number of scholarships has grown to 17, three bearing the name of Kathrine B. Tiffany and six the name of Neil C. Macdonald, all in amounts ranging from \$750 to \$1,000 annually. In 1958 he gave UND \$1 million for the Chester Fritz Library and in 1965 he gave another million toward construction of the Chester Fritz Auditorium, which will be dedicated in October. He also gave \$30,000 toward construction of the Kathrine B. Tiffany Graduate Study Center at UND and in 1971 he gave the Lidgerwood Special School District \$40,000 to establish in perpetuity two two-year scholarships, awarded one each year for a graduating high school senior from Lidgerwood High School.
